# Health in Avoca: Overview

Dear Community Members & Stakeholders of Avoca,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partner-ship with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Avoca ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Avoca's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Avoca. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

# **How to Use this Report**

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Avoca that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Avoca, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Avoca compares to the rest of the state and similarly-sized communities.

With a population of 1,375, Avoca's similarly sized communities are defined as small communities. In lowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

#### Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, lowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

## **Health Status**


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. #### **Poor General Health**

Avoca has a crude rate of 14.8% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 576th out of 958 lowa communities (90th out of 138 small communities). The age-adjusted rate for Avoca is 13.1%, which ranks 533rd out of 905 lowa communities (87th out of 138 small communities).



#### **Poor Physical Health**

Avoca has a crude rate of 11.3% for physical health not good for >=14 days among adults aged >=18 years, which ranks 636th out of 958 lowa communities (97th out of 138 small communities). The age-adjusted rate for Avoca is 10.0%, which ranks 559th out of 905 lowa communities (95th out of 138 small communities).



#### **Poor Mental Health**

Avoca has a crude rate of 14.6% for mental health not good for >=14 days among adults aged >=18 years, which ranks 587th out of 958 lowa communities (98th out of 138 small communities). The age-adjusted rate for Avoca is 16.0%, which ranks 631st out of 905 lowa communities (97th out of 138 small communities).

# **Health Risk Behaviors**


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. ## **Binge Drinking**

Avoca has a crude rate of 19.3% for binge drinking among adults aged >=18 years, which ranks 441st out of 958 lowa communities (72nd out of 138 small communities). The age-adjusted rate for Avoca is 22.1%, which ranks 478th out of 905 lowa communities (69th out of 138 small communities).



#### **Current Smoking**

Avoca has a crude rate of 17.2% for current smoking among adults aged >=18 years, which ranks 555th out of 958 lowa communities (105th out of 138 small communities). The age-adjusted rate for Avoca is 17.8%, which ranks 495th out of 905 lowa communities (84th out of 138 small communities).



#### **Physical Inactivity**

Avoca has a crude rate of 25.7% for no leisure-time physical activity among adults aged >=18 years, which ranks 421st out of 958 lowa communities (68th out of 138 small communities). The age-adjusted rate for Avoca is 23.9%, which ranks 381st out of 905 lowa communities (69th out of 138 small communities).



## Sleep <7 hours

Avoca has a crude rate of 31.4% for sleeping less than 7 hours among adults aged >=18 years, which ranks 708th out of 958 lowa communities (114th out of 138 small communities). The age-adjusted rate for Avoca is 32.3%, which ranks 717th out of 905 lowa communities (116th out of 138 small communities).

# **Health Outcomes**



Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. #### **Arthritis**

Avoca has a crude rate of 29.5% for arthritis among adults aged >=18 years, which ranks 654th out of 958 lowa communities (87th out of 138 small communities). The age-adjusted rate for Avoca is 24.1%, which ranks 707th out of 905 lowa communities (109th out of 138 small communities).



#### **High Blood Pressure**

Avoca has a crude rate of 34.3% for high blood pressure among adults aged >=18 years, which ranks 690th out of 958 lowa communities (98th out of 138 small communities). The age-adjusted rate for Avoca is 28.6%, which ranks 728th out of 905 lowa communities (116th out of 138 small communities).



#### Cancer (except skin)

Avoca has a crude rate of 8.4% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 578th out of 958 lowa communities (68th out of 138 small communities). The age-adjusted rate for Avoca is 6.5%, which ranks 418th out of 905 lowa communities (41st out of 138 small communities).



#### **Current Asthma**

Avoca has a crude rate of 9.5% for current asthma among adults aged >=18 years, which ranks 625th out of 958 lowa communities (100th out of 138 small communities). The age-adjusted rate for Avoca is 9.7%, which ranks 628th out of 905 lowa communities (99th out of 138 small communities).



#### **Coronary Heart Disease**

Avoca has a crude rate of 6.8% for coronary heart disease among adults aged >=18 years, which ranks 569th out of 958 lowa communities (73rd out of 138 small communities). The age-adjusted rate for Avoca is 5.1%, which ranks 511th out of 905 lowa communities (95th out of 138 small communities).



Avoca has a crude rate of 7.9% for chronic obstructive pulmonary disease among adults aged >=18 years, which ranks 613th out of 958 lowa communities (95th out of 138 small communities). The age-adjusted rate for Avoca is 6.5%, which ranks 571st out of 905 lowa communities (95th out of 138 small communities).



Avoca has a crude rate of 17.7% for depression among adults aged >=18 years, which ranks 356th out of 958 lowa communities (59th out of 138 small communities). The age-adjusted rate for Avoca is 18.8%, which ranks 330th out of 905 lowa communities (47th out of 138 small communities).



#### **Diabetes**

Avoca has a crude rate of 10.9% for diagnosed diabetes among adults aged >=18 years, which ranks 670th out of 958 lowa communities (99th out of 138 small communities). The age-adjusted rate for Avoca is 8.6%, which ranks 652nd out of 905 lowa communities (112th out of 138 small communities).



#### **High Cholesterol**

Avoca has a crude rate of 36.3% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 482nd out of 958 lowa communities (63rd out of 138 small communities). The age-adjusted rate for Avoca is 29.1%, which ranks 195th out of 905 lowa communities (35th out of 138 small communities).



Avoca has a crude rate of 3.3% for chronic kidney disease among adults aged >=18 years, which ranks 540th out of 958 lowa communities (69th out of 138 small communities). The age-adjusted rate for Avoca is 2.6%, which ranks 349th out of 905 lowa communities (65th out of 138 small communities).



Avoca has a crude rate of 38.4% for obesity among adults aged >=18 years, which ranks 601st out of 958 lowa communities (100th out of 138 small communities). The age-adjusted rate for Avoca is 37.9%, which ranks 490th out of 905 lowa communities (75th out of 138 small communities).



Avoca has a crude rate of 3.4% for stroke among adults aged >=18 years, which ranks 538th out of 958 lowa communities (67th out of 138 small communities). The age-adjusted rate for Avoca is 2.6%, which ranks 375th out of 905 lowa communities (70th out of 138 small communities).



Avoca has a crude rate of 13.0% for all teeth lost among adults aged >=65 years, which ranks 487th out of 958 lowa communities (73rd out of 138 small communities). The age-adjusted rate for Avoca is 12.8%, which ranks 448th out of 905 lowa communities (80th out of 138 small communities).

## **Prevention**



#### **Lack of Health Insurance**

Avoca has a crude rate of 7.2% for current lack of health insurance among adults aged 18–64 years, which ranks 415th out of 958 lowa communities (68th out of 138 small communities). The age-adjusted rate for Avoca is 7.7%, which ranks 427th out of 905 lowa communities (73rd out of 138 small communities).



## **Taking BP Medication**

Avoca has a crude rate of 79.8% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 469th out of 958 lowa communities (76th out of 138 small communities). The age-adjusted rate for Avoca is 58.6%, which ranks 579th out of 905 lowa communities (89th out of 138 small communities).



Avoca has a crude rate of 83.7% for cervical cancer screening among adult women aged 21–65 years, which ranks 378th out of 958 lowa communities (63rd out of 138 small communities). The age-adjusted rate for Avoca is 83.2%, which ranks 442nd out of 905 lowa communities (83rd out of 138 small communities).



Avoca has a crude rate of 75.4% for visits to doctor for routine checkup within the past year among adults aged >=18 years, which ranks 428th out of 958 lowa communities (74th out of 138 small communities). The age-adjusted rate for Avoca is 72.3%, which ranks 530th out of 905 lowa communities (89th out of 138 small communities).



#### **Cholesterol Screening**

Avoca has a crude rate of 82.5% for cholesterol screening among adults aged >=18 years, which ranks 501st out of 958 lowa communities (80th out of 138 small communities). The age-adjusted rate for Avoca is 78.4%, which ranks 649th out of 905 lowa communities (107th out of 138 small communities).



#### **Colorectal Cancer Screening**

Avoca has a crude rate of 71.9% for colorectal cancer screening among adults aged 50–75 years, which ranks 430th out of 958 lowa communities (69th out of 138 small communities). The age-adjusted rate for Avoca is 71.3%, which ranks 399th out of 905 lowa communities (66th out of 138 small communities).



#### Core preventive services for older men

Avoca has a crude rate of 45.1% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 321st out of 958 lowa communities (51st out of 138 small communities). The age-adjusted rate for Avoca is 45.2%, which ranks 296th out of 905 lowa communities (56th out of 138 small communities).



#### Core preventive services for older women

Avoca has a crude rate of 38.8% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 492nd out of 958 lowa communities (63rd out of 138 small communities). The age-adjusted rate for Avoca is 38.5%, which ranks 623rd out of 905 lowa communities (106th out of 138 small communities).



Avoca has a crude rate of 63.8% for visits to dentist or dental clinic among adults aged >=18 years, which ranks 771st out of 958 lowa communities (121st out of 138 small communities). The age-adjusted rate for Avoca is 63.3%, which ranks 721st out of 905 lowa communities (117th out of 138 small communities).



# **Mammography**

Avoca has a crude rate of 73.3% for mammography use among women aged 50–74 years, which ranks 890th out of 958 lowa communities (127th out of 138 small communities). The age-adjusted rate for Avoca is 70.9%, which ranks 825th out of 905 lowa communities (130th out of 138 small communities).

# **Disability**



Avoca has a crude rate of 7.6% for hearing disability among adults aged >=18 years, which ranks 531st out of 958 lowa communities (66th out of 138 small communities). The age-adjusted rate for Avoca is 6.1%, which ranks 544th out of 905 lowa communities (97th out of 138 small communities).







This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
