#### Health in Britt: Overview

Dear Community Members & Stakeholders of Britt,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partner-ship with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Britt ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Britt's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Britt. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

#### **Strengths**

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community's strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

#### **How to Use this Report**

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Britt that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Britt, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Britt compares to the rest of the state and similarly-sized communities.

With a population of 1,921, Britt's similarly sized communities are defined as small communities. In Iowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

#### Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, lowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

#### **Health Status**


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. #### **Poor General Health**

Britt has a crude rate of 17.9% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 906th out of 958 lowa communities (134th out of 138 small communities). The age-adjusted rate for Britt is 15.5%, which ranks 828th out of 905 lowa communities (130th out of 138 small communities).



#### **Poor Physical Health**

Britt has a crude rate of 12.8% for physical health not good for >=14 days among adults aged >=18 years, which ranks 908th out of 958 lowa communities (135th out of 138 small communities). The age-adjusted rate for Britt is 11.1%, which ranks 816th out of 905 lowa communities (131st out of 138 small communities).



#### **Poor Mental Health**

Britt has a crude rate of 14.8% for mental health not good for >=14 days among adults aged >=18 years, which ranks 646th out of 958 lowa communities (107th out of 138 small communities). The age-adjusted rate for Britt is 16.9%, which ranks 834th out of 905 lowa communities (131st out of 138 small communities).

#### **Health Risk Behaviors**


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. #### **Binge Drinking**

Britt has a crude rate of 16.7% for binge drinking among adults aged >=18 years, which ranks 66th out of 958 lowa communities (10th out of 138 small communities). The age-adjusted rate for Britt is 20.5%, which ranks 78th out of 905 lowa communities (8th out of 138 small communities).



#### **Current Smoking**

Britt has a crude rate of 18.6% for current smoking among adults aged >=18 years, which ranks 783rd out of 958 lowa communities (129th out of 138 small communities). The age-adjusted rate for Britt is 20.6%, which ranks 844th out of 905 lowa communities (134th out of 138 small communities).



#### **Physical Inactivity**

Britt has a crude rate of 30.8% for no leisure-time physical activity among adults aged >=18 years, which ranks 900th out of 958 lowa communities (131st out of 138 small communities). The age-adjusted rate for Britt is 27.6%, which ranks 806th out of 905 lowa communities (130th out of 138 small communities).



#### Sleep <7 hours

Britt has a crude rate of 30.8% for sleeping less than 7 hours among adults aged >=18 years, which ranks 590th out of 958 lowa communities (96th out of 138 small communities). The age-adjusted rate for Britt is 32.4%, which ranks 743rd out of 905 lowa communities (118th out of 138 small communities).

#### **Health Outcomes**


This section includes measures about specific health outcomes such as chronic illness, mental health conditions, and risk factors for future disease. Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. #### **Arthritis**

Britt has a crude rate of 32.4% for arthritis among adults aged >=18 years, which ranks 890th out of 958 lowa communities (127th out of 138 small communities). The age-adjusted rate for Britt is 24.7%, which ranks 819th out of 905 lowa communities (130th out of 138 small communities).



#### **High Blood Pressure**

Britt has a crude rate of 36.0% for high blood pressure among adults aged >=18 years, which ranks 820th out of 958 lowa communities (117th out of 138 small communities). The age-adjusted rate for Britt is 28.1%, which ranks 644th out of 905 lowa communities (105th out of 138 small communities).



#### Cancer (except skin)

Britt has a crude rate of 9.5% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 824th out of 958 lowa communities (104th out of 138 small communities). The age-adjusted rate for Britt is 6.4%, which ranks 74th out of 905 lowa communities (4th out of 138 small communities).



#### **Current Asthma**

Britt has a crude rate of 9.6% for current asthma among adults aged >=18 years, which ranks 716th out of 958 lowa communities (118th out of 138 small communities). The age-adjusted rate for Britt is 10.0%, which ranks 805th out of 905 lowa communities (129th out of 138 small communities).



#### **Coronary Heart Disease**

Britt has a crude rate of 8.5% for coronary heart disease among adults aged >=18 years, which ranks 901st out of 958 lowa communities (131st out of 138 small communities). The age-adjusted rate for Britt is 5.6%, which ranks 797th out of 905 lowa communities (130th out of 138 small communities).



Britt has a crude rate of 9.5% for chronic obstructive pulmonary disease among adults aged >=18 years, which ranks 905th out of 958 lowa communities (134th out of 138 small communities). The age-adjusted rate for Britt is 7.4%, which ranks 822nd out of 905 lowa communities (130th out of 138 small communities).



Britt has a crude rate of 18.1% for depression among adults aged >=18 years, which ranks 499th out of 958 lowa communities (83rd out of 138 small communities). The age-adjusted rate for Britt is 20.0%, which ranks 733rd out of 905 lowa communities (110th out of 138 small communities).



Britt has a crude rate of 12.3% for diagnosed diabetes among adults aged >=18 years, which ranks 894th out of 958 lowa communities (134th out of 138 small communities). The age-adjusted rate for Britt is 9.3%, which ranks 802nd out of 905 lowa communities (130th out of 138 small communities).



#### **High Cholesterol**

Britt has a crude rate of 39.6% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 858th out of 958 lowa communities (129th out of 138 small communities). The age-adjusted rate for Britt is 30.9%, which ranks 790th out of 905 lowa communities (127th out of 138 small communities).



Britt has a crude rate of 4.0% for chronic kidney disease among adults aged >=18 years, which ranks 890th out of 958 lowa communities (128th out of 138 small communities). The age-adjusted rate for Britt is 2.8%, which ranks 762nd out of 905 lowa communities (125th out of 138 small communities).



Britt has a crude rate of 37.3% for obesity among adults aged >=18 years, which ranks 415th out of 958 lowa communities (74th out of 138 small communities). The age-adjusted rate for Britt is 38.2%, which ranks 559th out of 905 lowa communities (91st out of 138 small communities).





#### **Prevention**



#### **Lack of Health Insurance**

Britt has a crude rate of 9.8% for current lack of health insurance among adults aged 18–64 years, which ranks 910th out of 958 lowa communities (135th out of 138 small communities). The age-adjusted rate for Britt is 10.2%, which ranks 855th out of 905 lowa communities (135th out of 138 small communities).



#### **Taking BP Medication**

Britt has a crude rate of 83.0% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 92nd out of 958 lowa communities (14th out of 138 small communities). The age-adjusted rate for Britt is 60.3%, which ranks 63rd out of 905 lowa communities (9th out of 138 small communities).



The age-adjusted rate for Britt is 81.8%, which ranks 744th out of 905 lowa communities (129th out of 138 small communities).



Britt has a crude rate of 76.1% for visits to doctor for routine checkup within the past year among adults aged >=18 years, which ranks 291st out of 958 lowa communities (57th out of 138 small communities). The age-adjusted rate for Britt is 71.6%, which ranks 746th out of 905 lowa communities (124th out of 138 small communities).



Britt has a crude rate of 82.7% for cholesterol screening among adults aged >=18 years, which ranks 451st out of 958 lowa communities (74th out of 138 small communities). The age-adjusted rate for Britt is 77.6%, which ranks 793rd out of 905 lowa communities (127th out of 138 small communities).



#### **Colorectal Cancer Screening**

Britt has a crude rate of 70.4% for colorectal cancer screening among adults aged 50–75 years, which ranks 664th out of 958 lowa communities (116th out of 138 small communities). The age-adjusted rate for Britt is 69.1%, which ranks 766th out of 905 lowa communities (127th out of 138 small communities).



#### Core preventive services for older men

Britt has a crude rate of 39.7% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 838th out of 958 lowa communities (125th out of 138 small communities). The age-adjusted rate for Britt is 39.9%, which ranks 762nd out of 905 lowa communities (128th out of 138 small communities).



#### Core preventive services for older women

Britt has a crude rate of 36.3% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 731st out of 958 lowa communities (100th out of 138 small communities). The age-adjusted rate for Britt is 39.4%, which ranks 521st out of 905 lowa communities (91st out of 138 small communities).



Britt has a crude rate of 62.0% for visits to dentist or dental clinic among adults aged >=18 years, which ranks 881st out of 958 lowa communities (133rd out of 138 small communities). The age-adjusted rate for Britt is 61.4%, which ranks 823rd out of 905 lowa communities (130th out of 138 small communities).



Britt has a crude rate of 74.7% for mammography use among women aged 50–74 years, which ranks 737th out of 958 lowa communities (104th out of 138 small communities). The age-adjusted rate for Britt is 72.2%, which ranks 714th out of 905 lowa communities (113th out of 138 small communities).

## **Disability**



Britt has a crude rate of 9.6% for hearing disability among adults aged >=18 years, which ranks 900th out of 958 lowa communities (129th out of 138 small communities). The age-adjusted rate for Britt is 6.5%, which ranks 766th out of 905 lowa communities (129th out of 138 small communities).





#### Cognitive disability









This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
