Health in Charles City: Overview

Dear Community Members & Stakeholders of Charles City,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partnership with Iowa State University’s Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Charles City ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Charles City’s strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all Iowa communities and communities of similar size to Charles City. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community’s strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

How to Use this Report

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Charles City that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Charles City, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Charles City compares to the rest of the state and similarly-sized communities.

With a population of 7,364, Charles City’s similarly sized communities are defined as midsized communities. In Iowa, midsized communities have an average population of 4,787, and there are 102 communities that are considered midsized communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community’s crude and age-adjusted rate estimates alongside their averages across all Iowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all Iowa communities and the dotted lines showing the average rate for similarly-sized communities.



Health Status

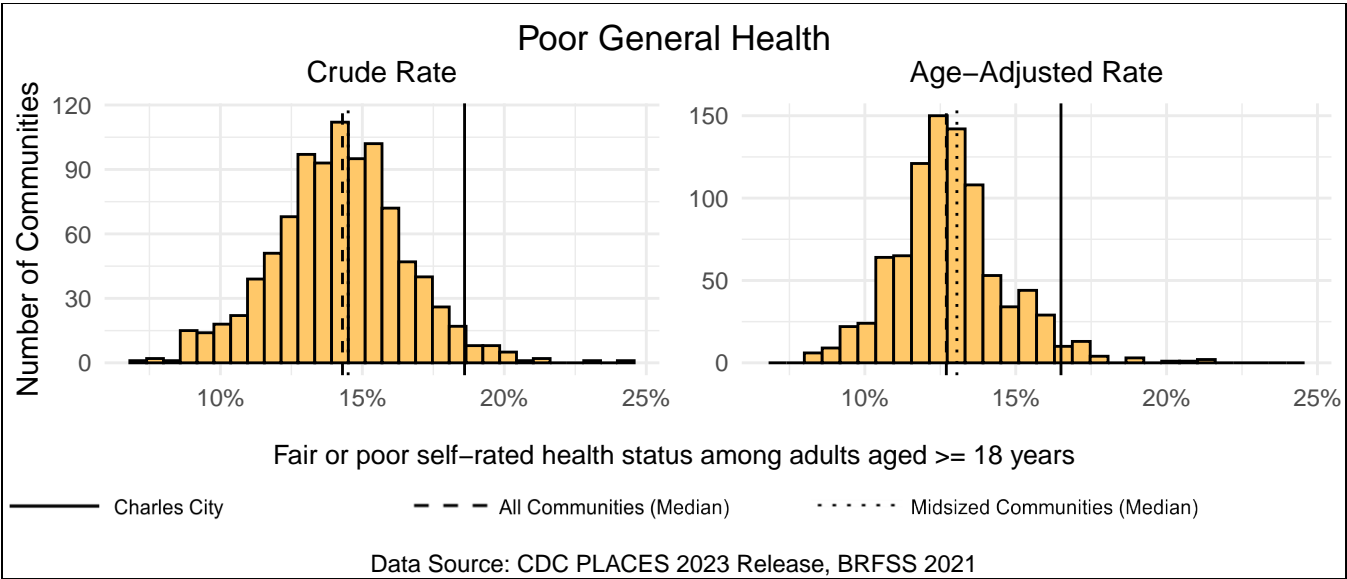
This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country’s population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of “excellent,” “very good,” “good,” “fair,” or “poor,” from which the respondents who answer “fair” or “poor” are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Charles City has a crude rate of 18.6% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 931st out of 958 Iowa communities (96th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 16.5%, which ranks 877th out of 905 Iowa communities (93rd out of 102 mid-sized communities).

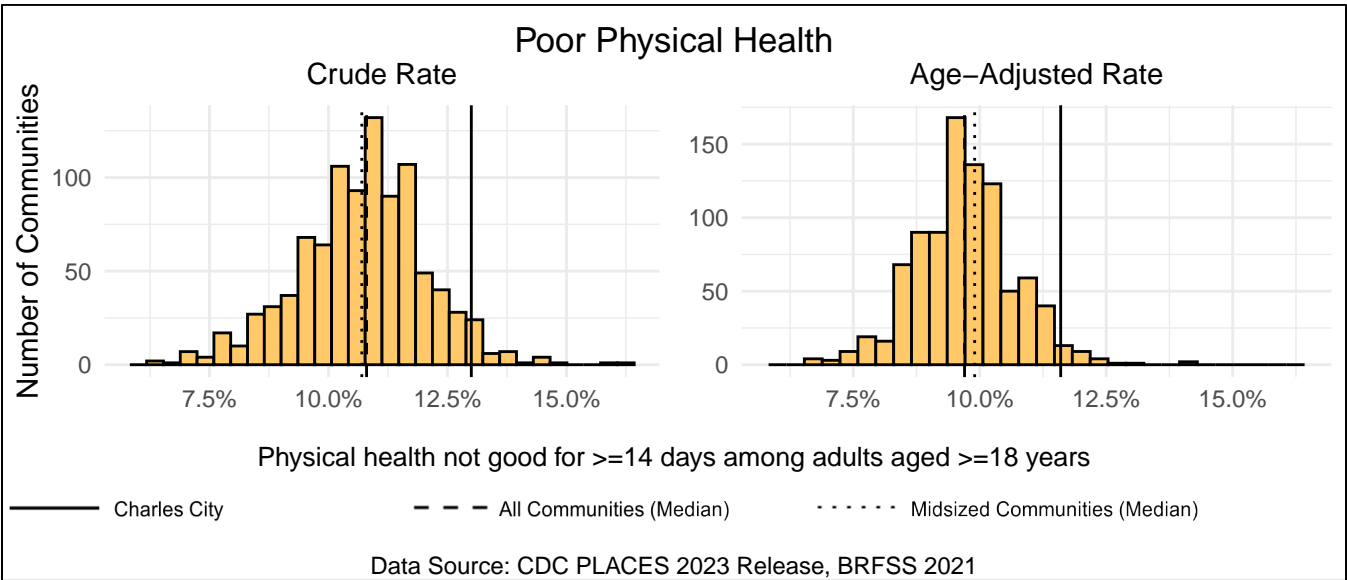

Poor Physical Health

Charles City has a crude rate of 13.0% for physical health not good for >=14 days among adults aged >=18 years, which ranks 921st out of 958 Iowa communities (99th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 11.6%, which ranks 880th out of 905 Iowa communities (93rd out of 102 mid-sized communities).

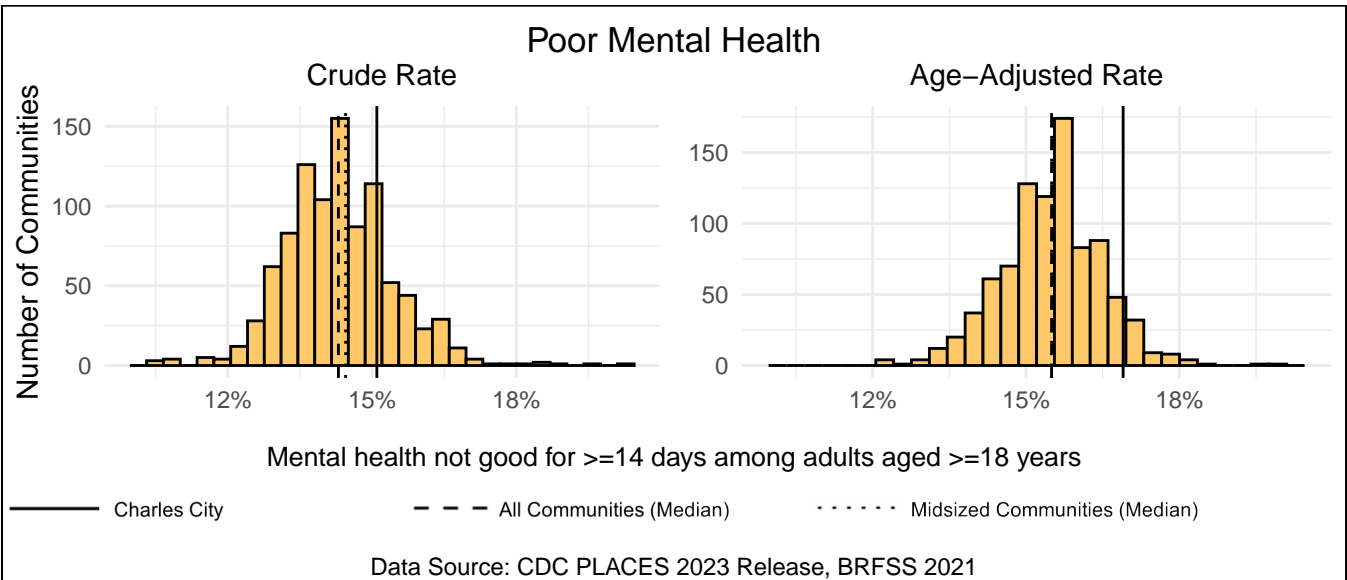

Poor Mental Health

Charles City has a crude rate of 15.1% for mental health not good for >=14 days among adults aged >=18 years, which ranks 736th out of 958 Iowa communities (70th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 16.9%, which ranks 834th out of 905 Iowa communities (88th out of 102 mid-sized communities).

Health Risk Behaviors

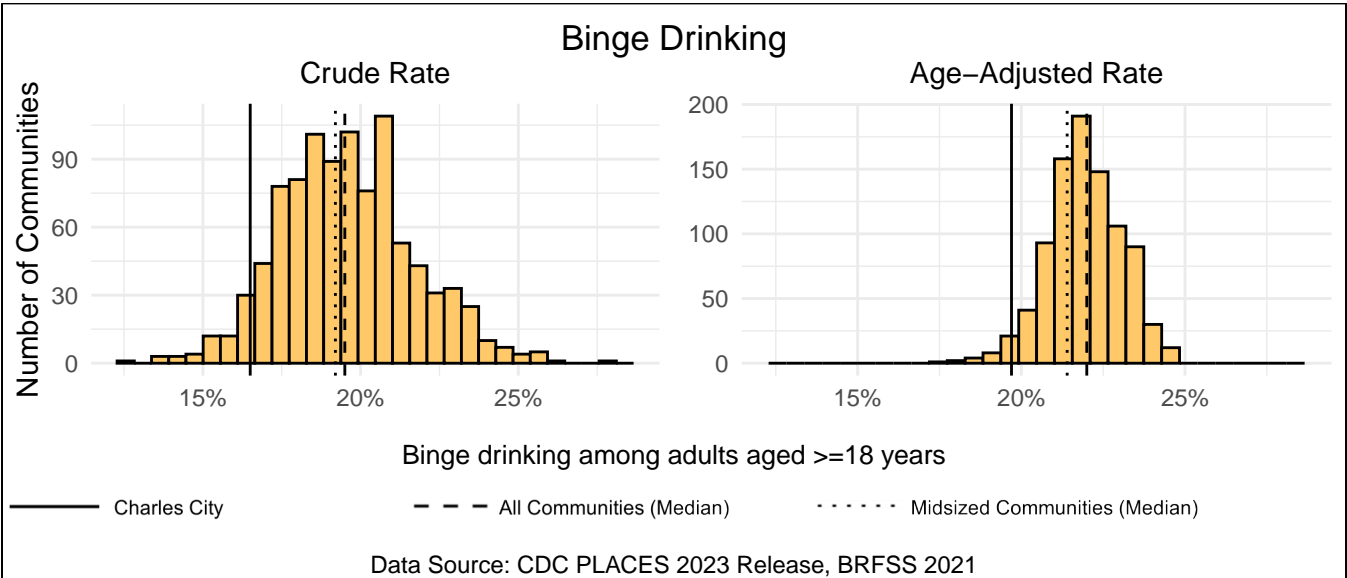
Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Charles City has a crude rate of 16.5% for binge drinking among adults aged ≥ 18 years, which ranks 53rd out of 958 Iowa communities (4th out of 102 midsize communities). The age-adjusted rate for Charles City is 19.7%, which ranks 24th out of 905 Iowa communities (7th out of 102 midsize communities).

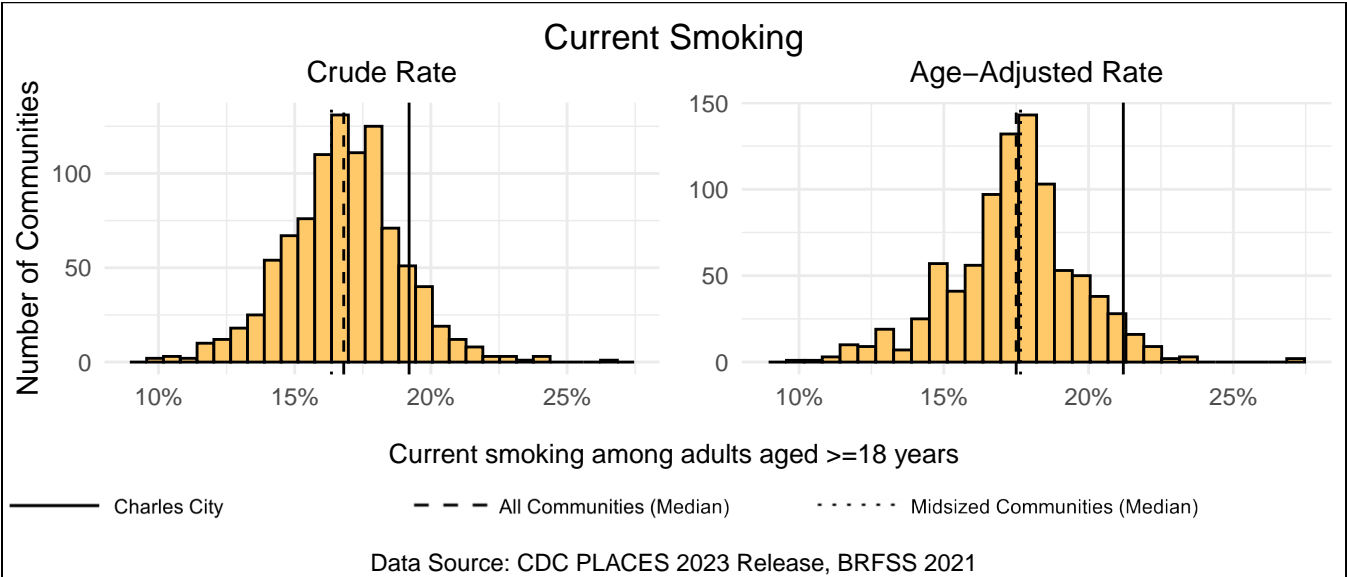

Current Smoking

Charles City has a crude rate of 19.2% for current smoking among adults aged >=18 years, which ranks 842nd out of 958 Iowa communities (86th out of 102 midsize communities). The age-adjusted rate for Charles City is 21.2%, which ranks 868th out of 905 Iowa communities (94th out of 102 midsize communities).

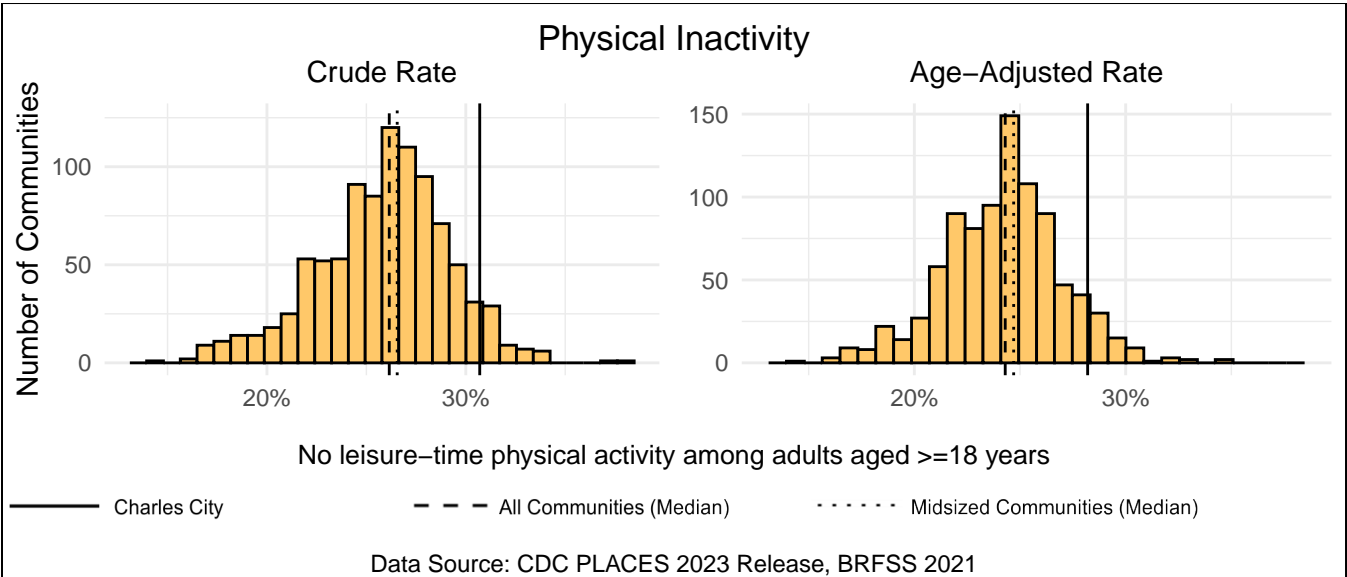

Physical Inactivity

Charles City has a crude rate of 30.7% for no leisure-time physical activity among adults aged >=18 years, which ranks 897th out of 958 Iowa communities (86th out of 102 midsize communities). The age-adjusted rate for Charles City is 28.2%, which ranks 837th out of 905 Iowa communities (82nd out of 102 midsize communities).

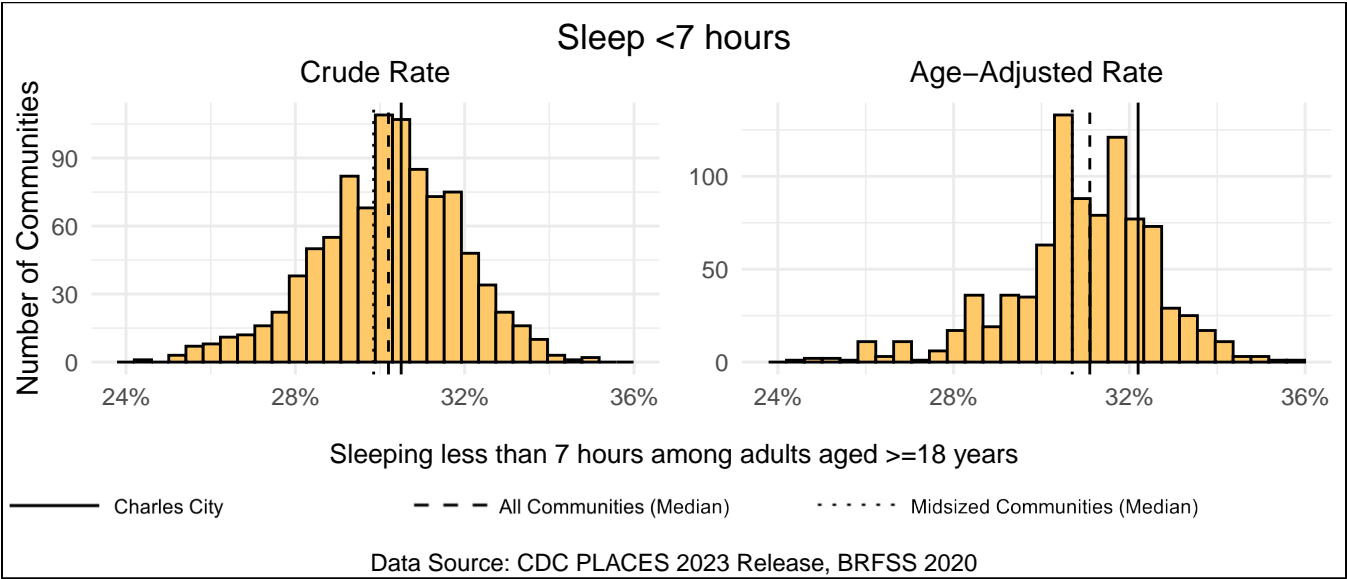

Sleep <7 hours

Charles City has a crude rate of 30.5% for sleeping less than 7 hours among adults aged >=18 years, which ranks 521st out of 958 Iowa communities (60th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 32.2%, which ranks 706th out of 905 Iowa communities (79th out of 102 mid-sized communities).

Health Outcomes

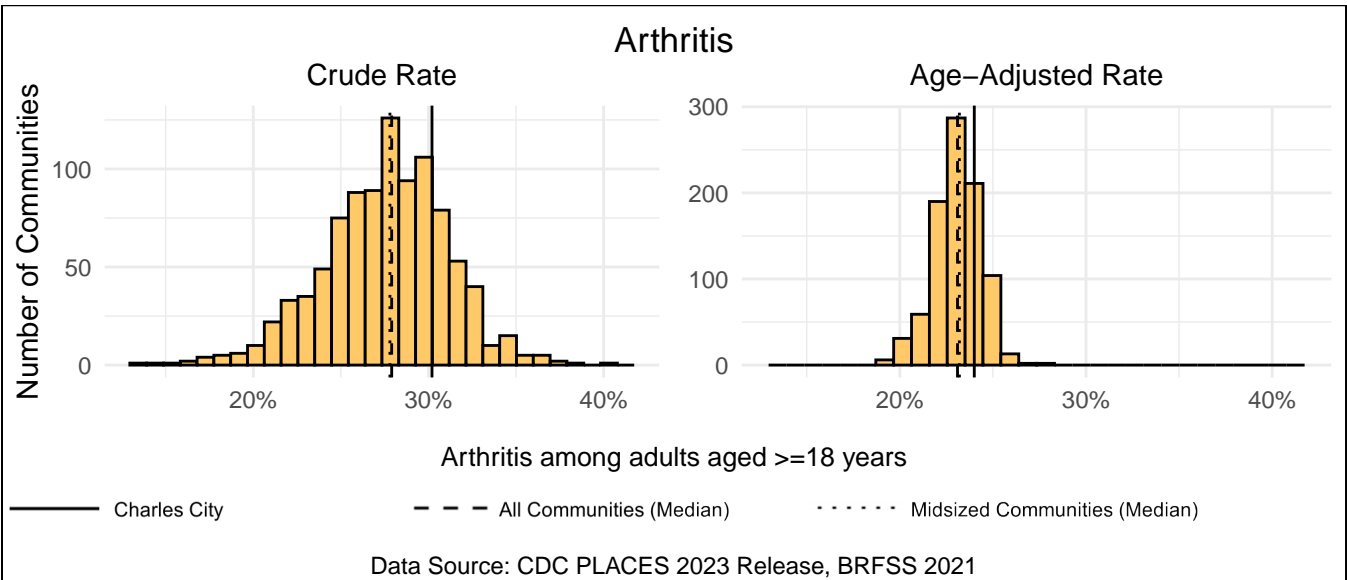

Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. Charles City has a crude rate of 30.2% for arthritis among adults aged ≥ 18 years, which ranks 732nd out of 958 Iowa communities (87th out of 102 midsized communities). The age-adjusted rate for Charles City is 24.0%, which ranks 683rd out of 905 Iowa communities (73rd out of 102 midsized communities).

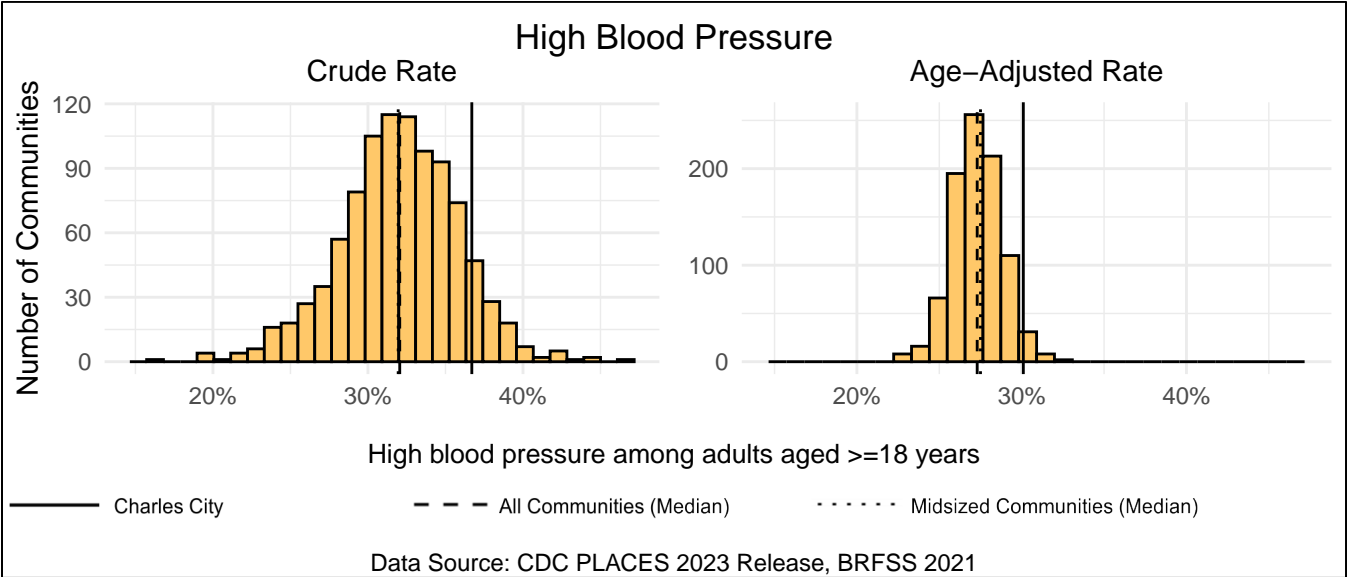

High Blood Pressure

Charles City has a crude rate of 36.7% for high blood pressure among adults aged ≥ 18 years, which ranks 864th out of 958 Iowa communities (98th out of 102 midsized communities). The age-adjusted rate for Charles City is 30.1%, which ranks 878th out of 905 Iowa communities (94th out of 102 midsized communities).

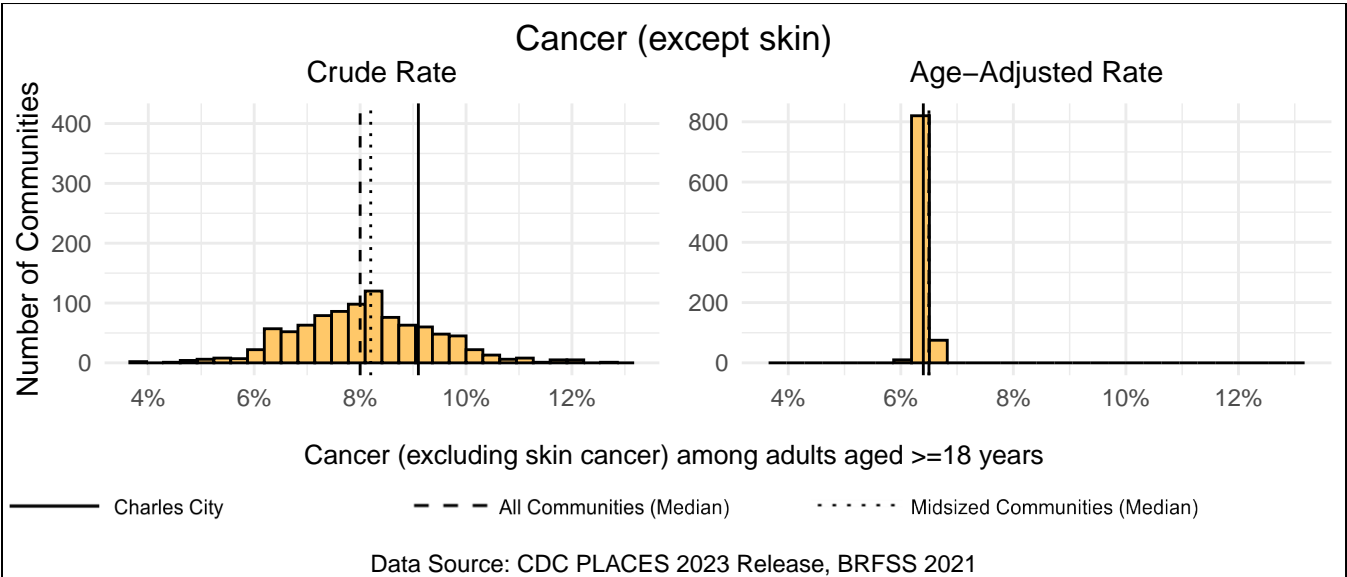

Charles City has a crude rate of 9.1% for cancer (excluding skin cancer) among adults aged ≥ 18 years, which ranks 745th out of 958 Iowa communities (86th out of 102 midsized communities). The age-adjusted rate for Charles City is 6.4%, which ranks 74th out of 905 Iowa communities (11th out of 102 midsized communities).

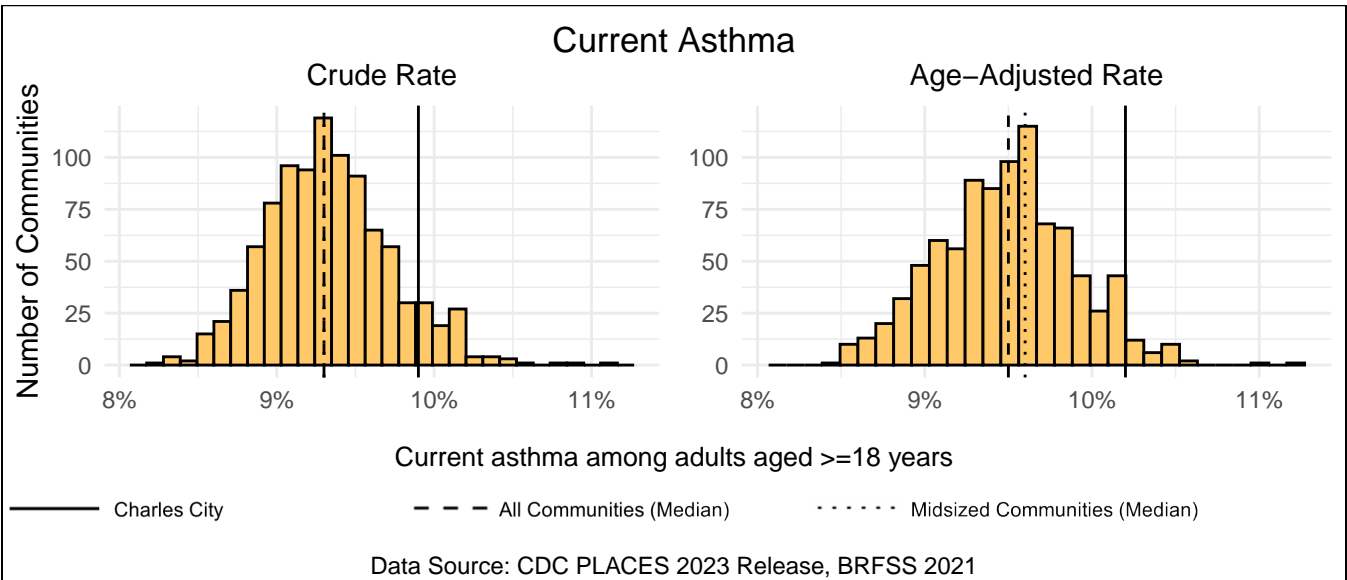

The age-adjusted rate for Charles City is 10.2%, which ranks 856th out of 905 Iowa communities (91st out of 102 midsize communities).

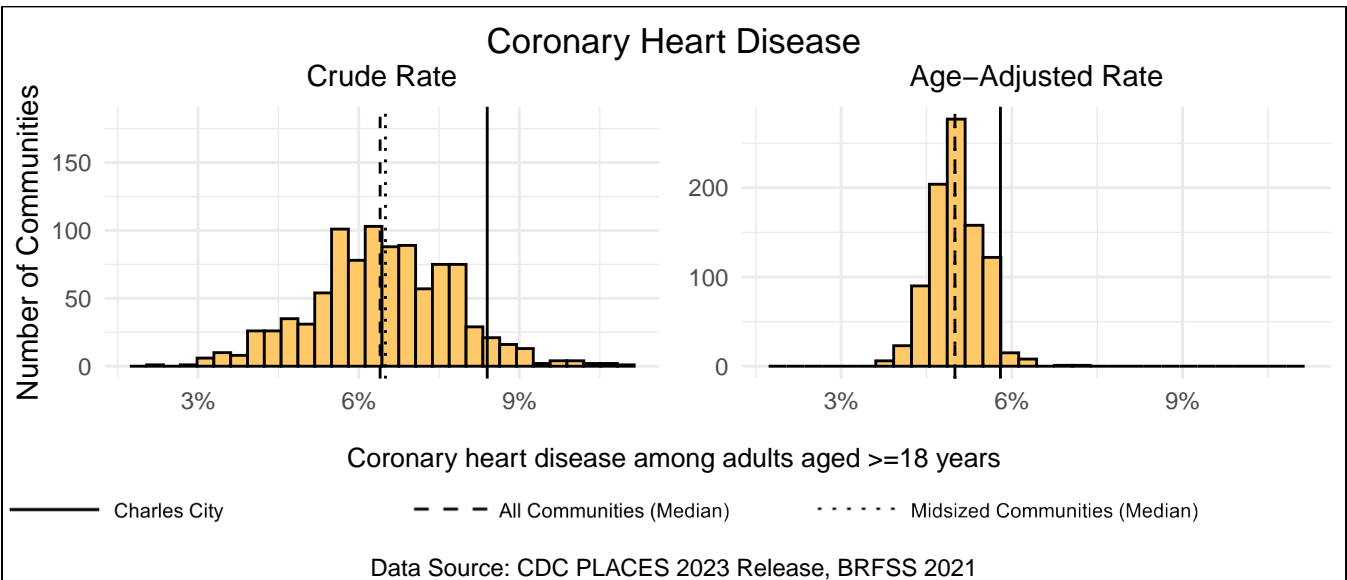

The age-adjusted rate for Charles City is 5.8%, which ranks 865th out of 905 Iowa communities (93rd out of 102 midsize communities).

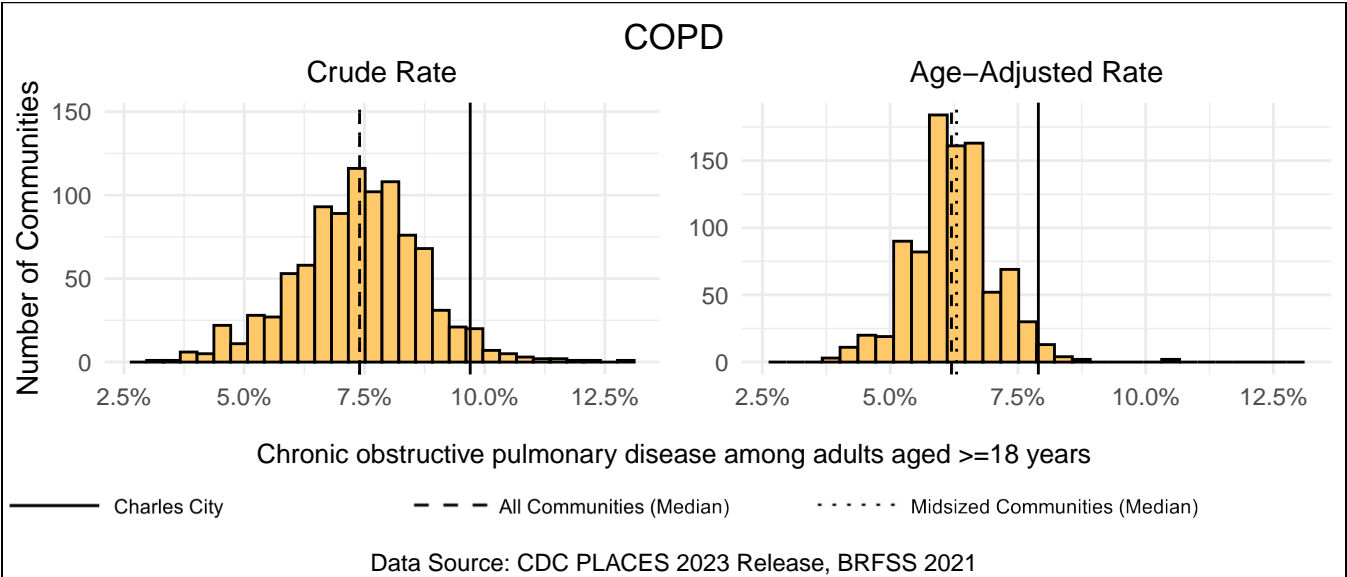

Charles City has a crude rate of 9.7% for chronic obstructive pulmonary disease among adults aged ≥ 18 years, which ranks 917th out of 958 Iowa communities (100th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 7.9%, which ranks 885th out of 905 Iowa communities (95th out of 102 mid-sized communities).

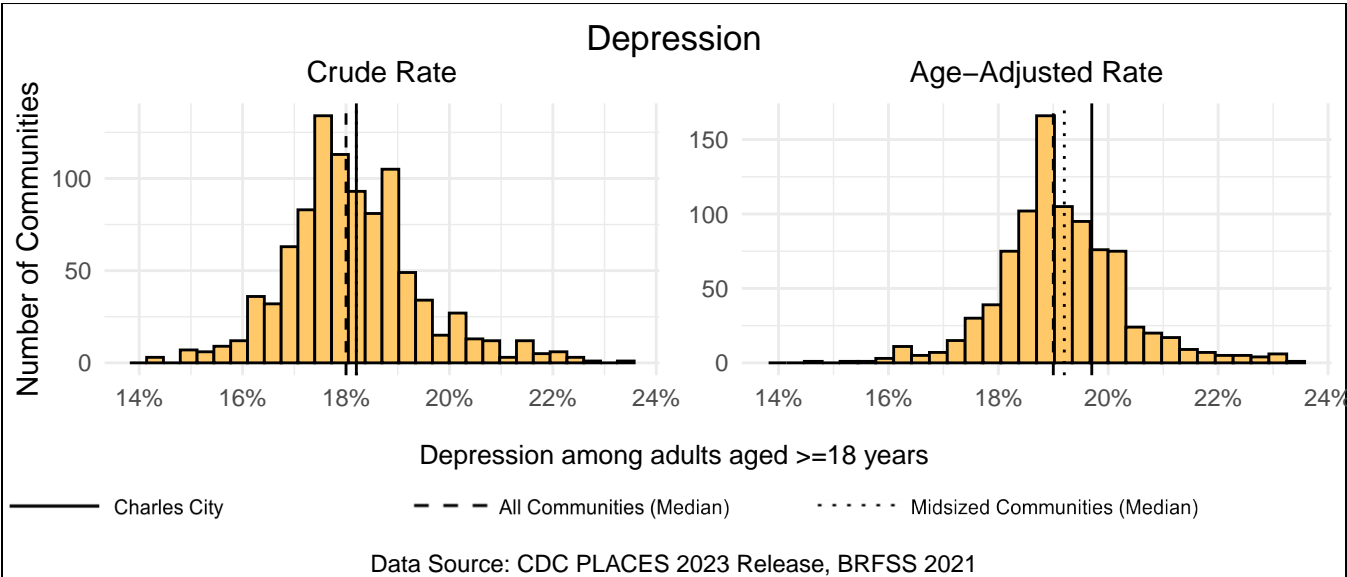

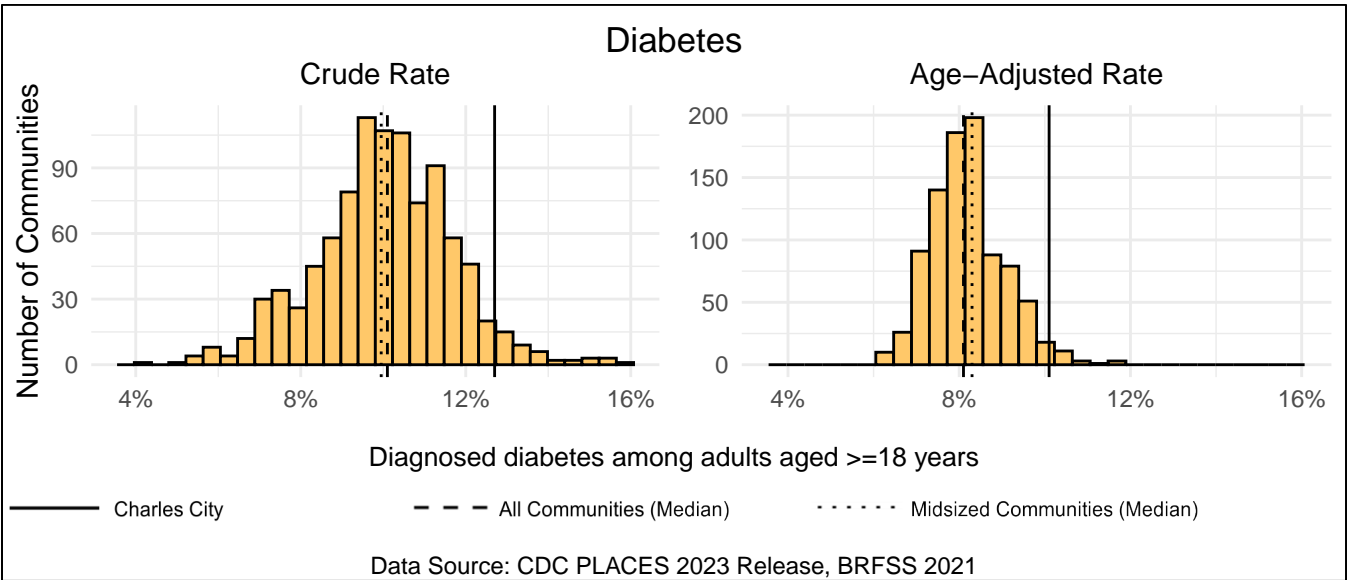

Charles City has a crude rate of 12.7% for diagnosed diabetes among adults aged ≥ 18 years, which ranks 912th out of 958 Iowa communities (101st out of 102 midsized communities). The age-adjusted rate for Charles City is 10.1%, which ranks 879th out of 905 Iowa communities (94th out of 102 midsized communities).

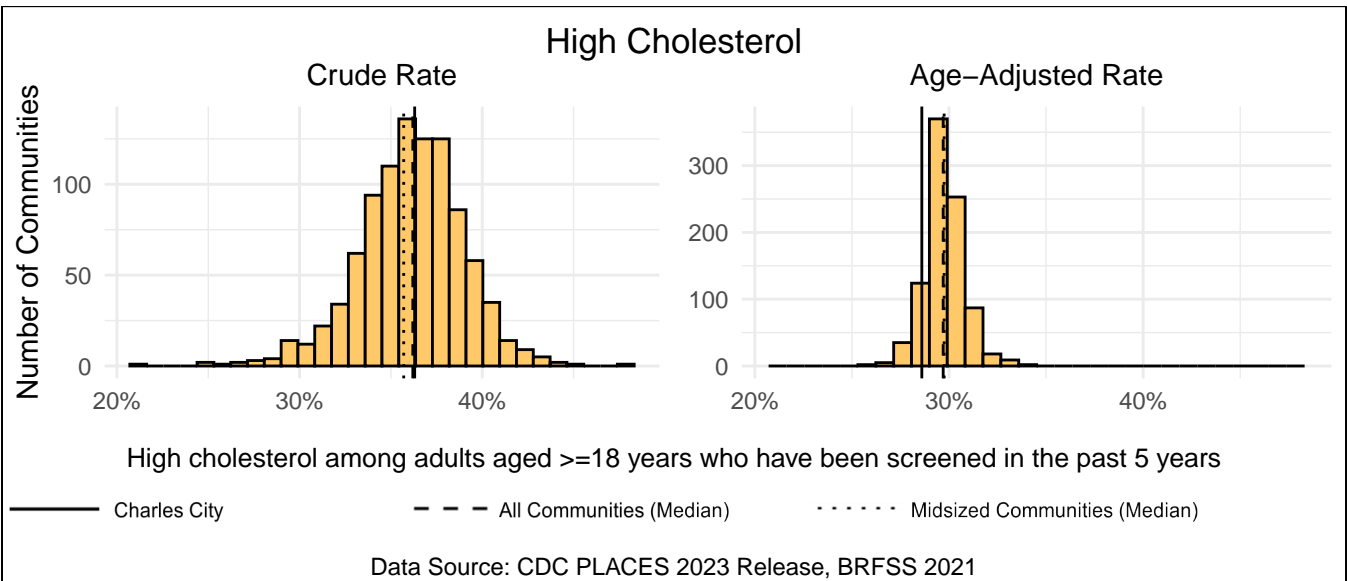

The age-adjusted rate for Charles City is 28.6%, which ranks 83rd out of 905 Iowa communities (12th out of 102 midsized communities).

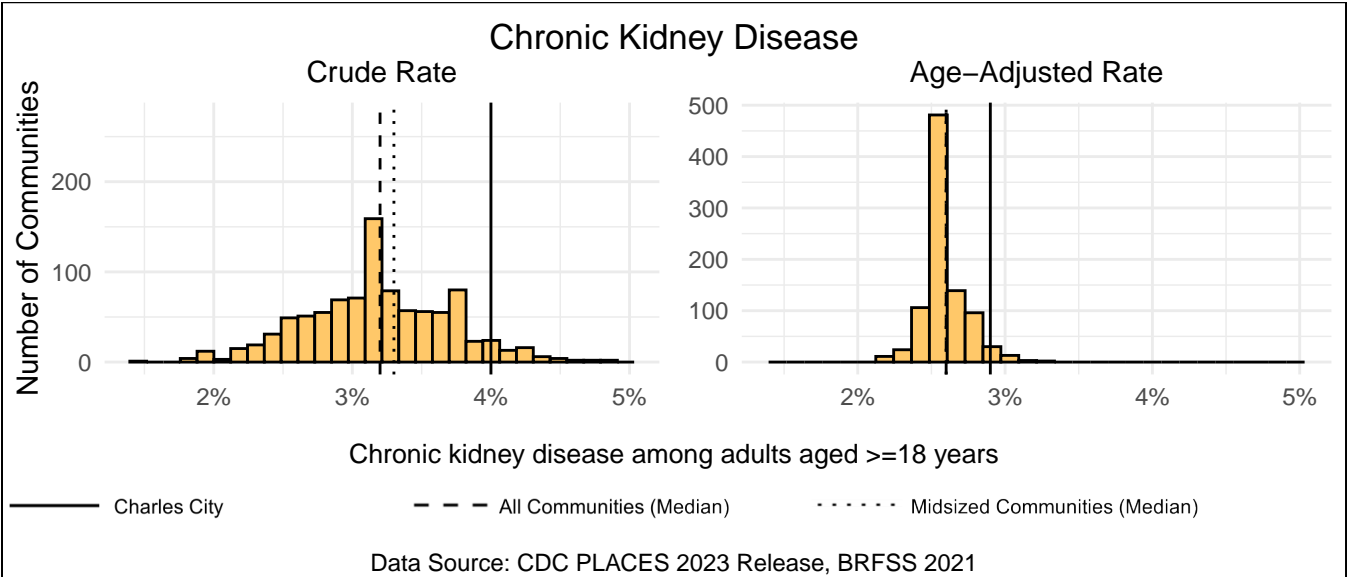

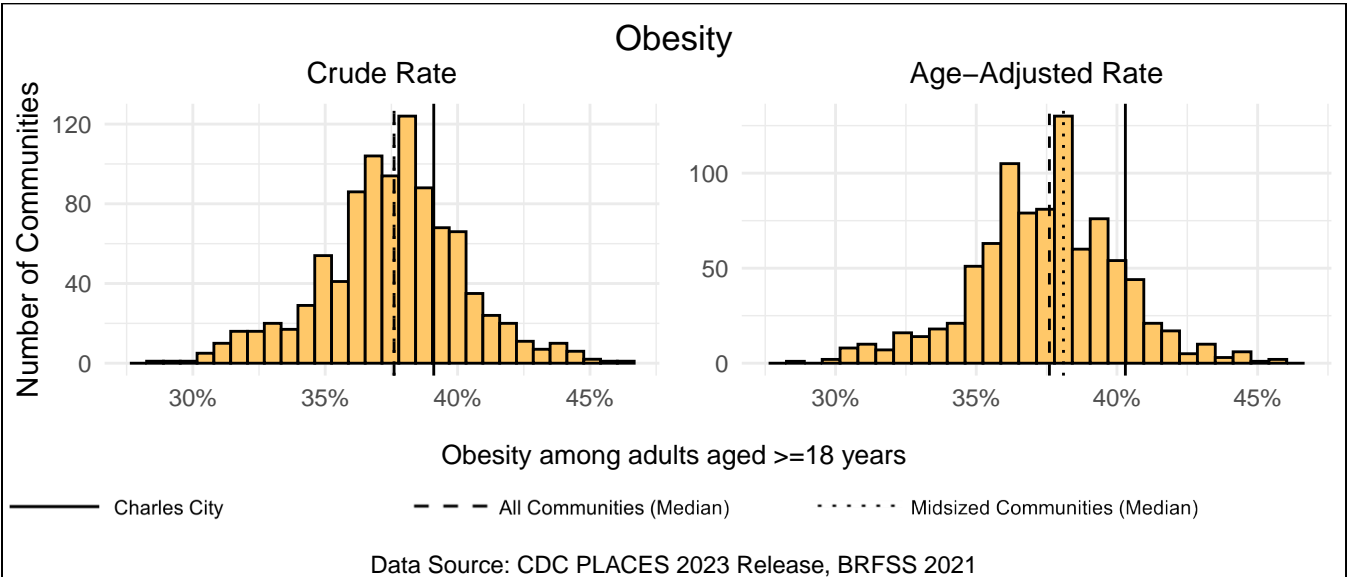

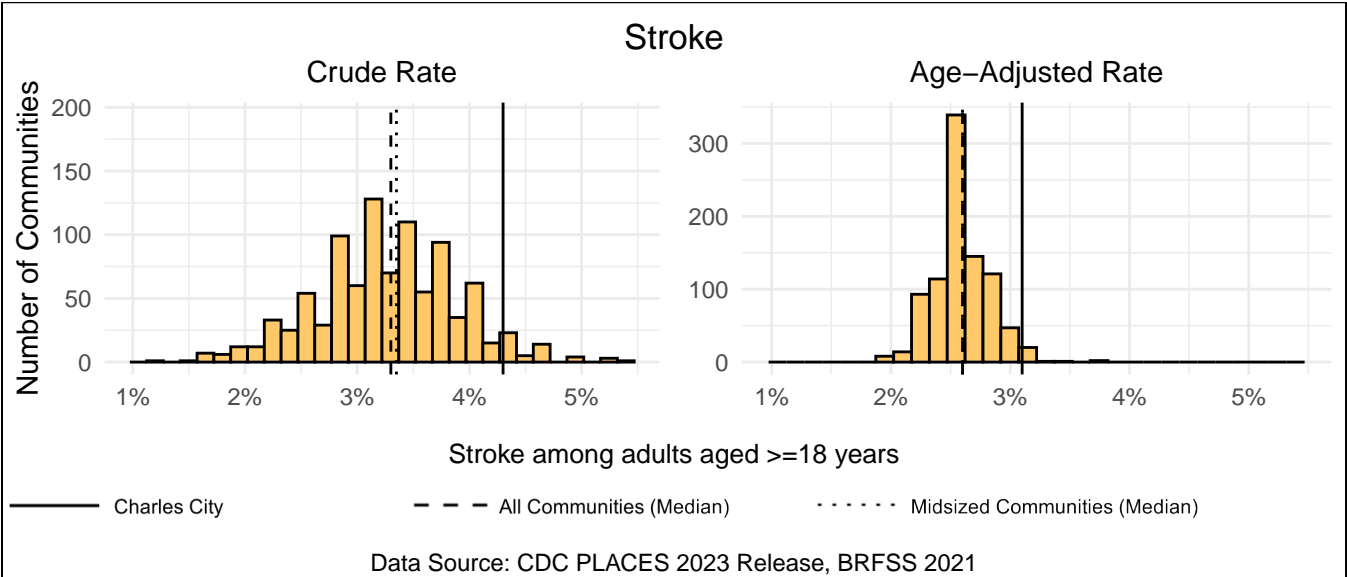

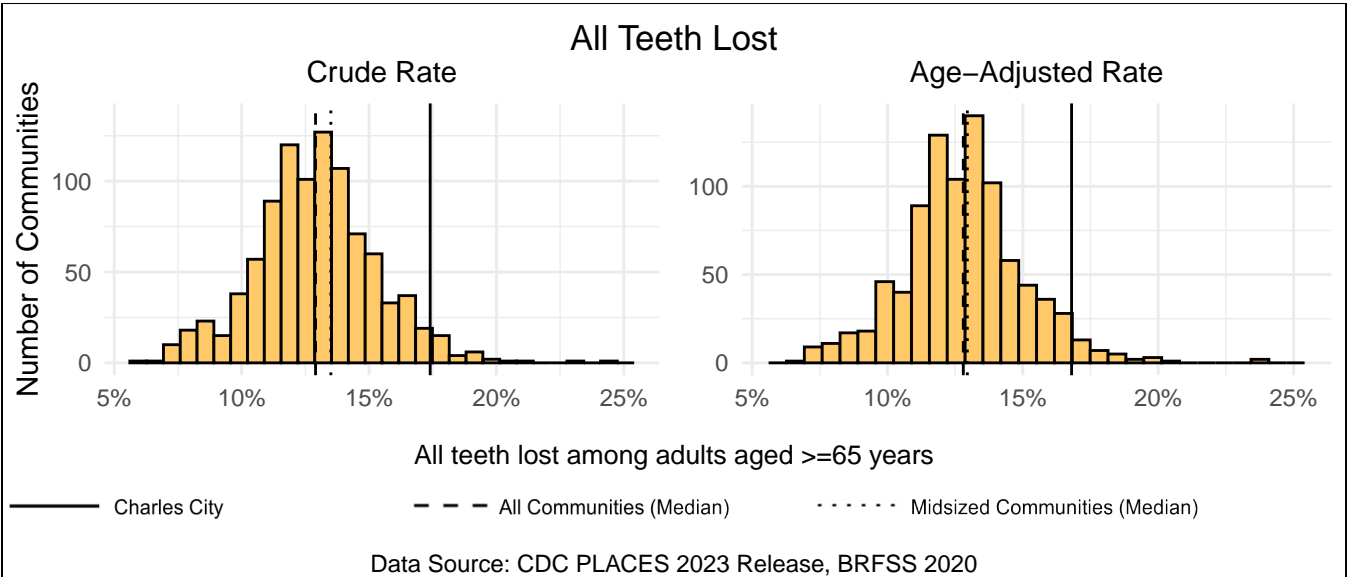

Charles City has a crude rate of 9.6% for current lack of health insurance among adults aged 18–64 years, which ranks 898th out of 958 Iowa communities (87th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 10.1%, which ranks 848th out of 905 Iowa communities (88th out of 102 mid-sized communities).

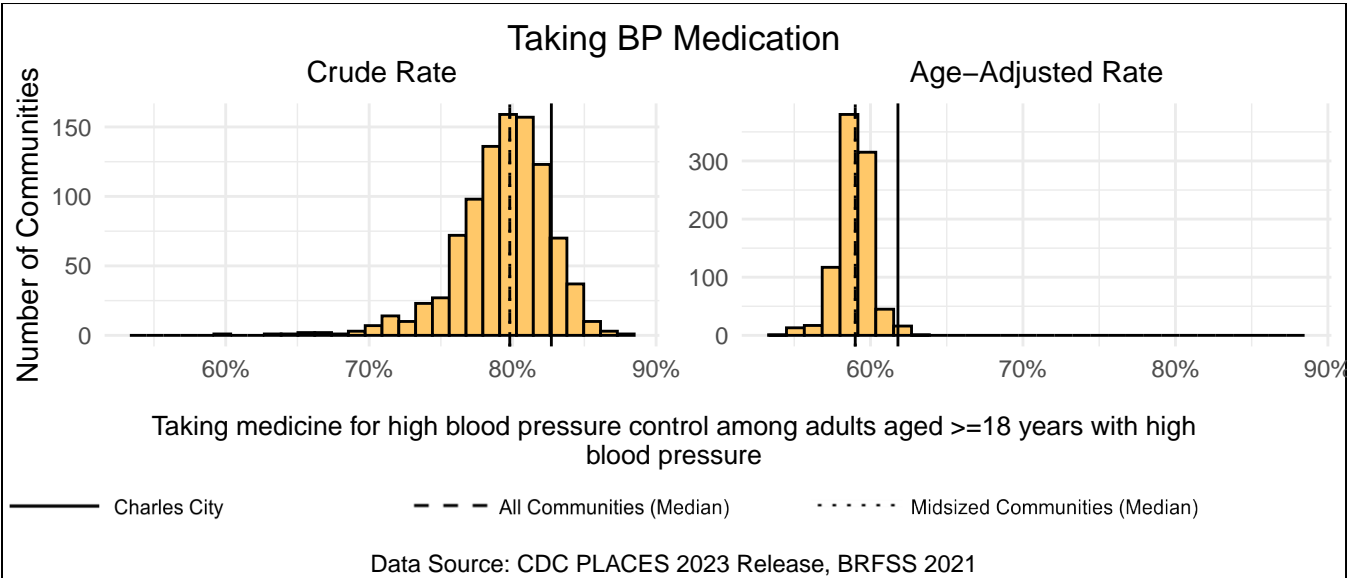

Taking BP Medication

Charles City has a crude rate of 82.7% for taking medicine for high blood pressure control among adults aged ≥ 18 years with high blood pressure, which ranks 112th out of 958 Iowa communities (3rd out of 102 mid-sized communities). The age-adjusted rate for Charles City is 61.8%, which ranks 15th out of 905 Iowa communities (1st out of 102 mid-sized communities).

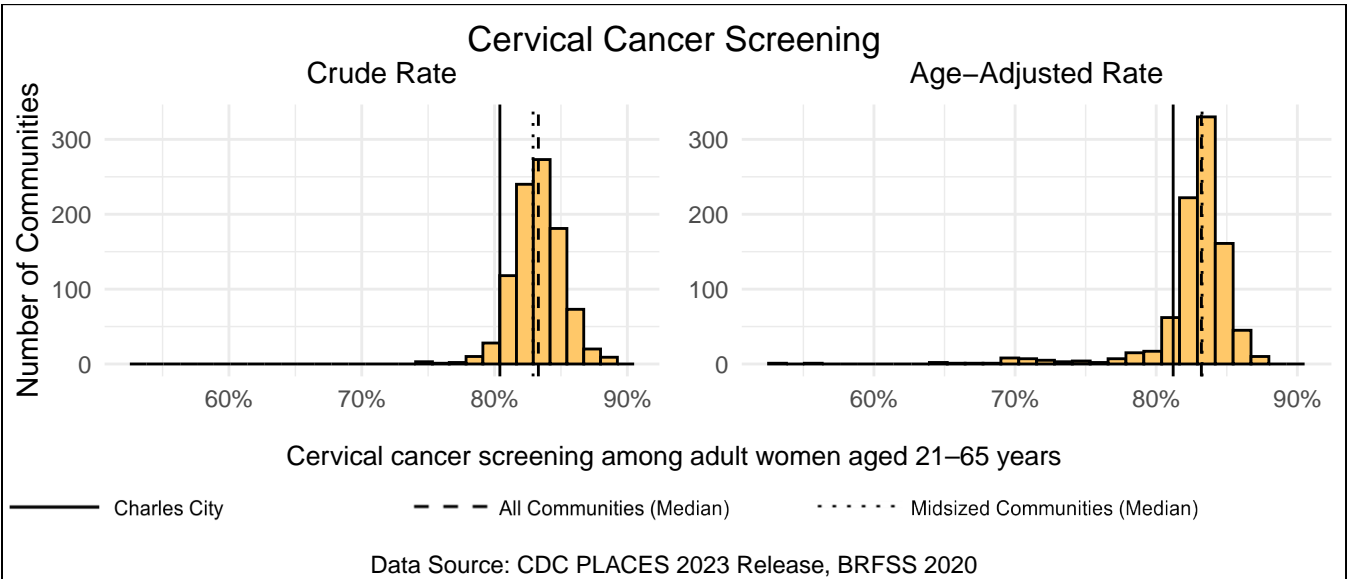

The age-adjusted rate for Charles City is 81.2%, which ranks 805th out of 905 Iowa communities (91st out of 102 mid-sized communities).

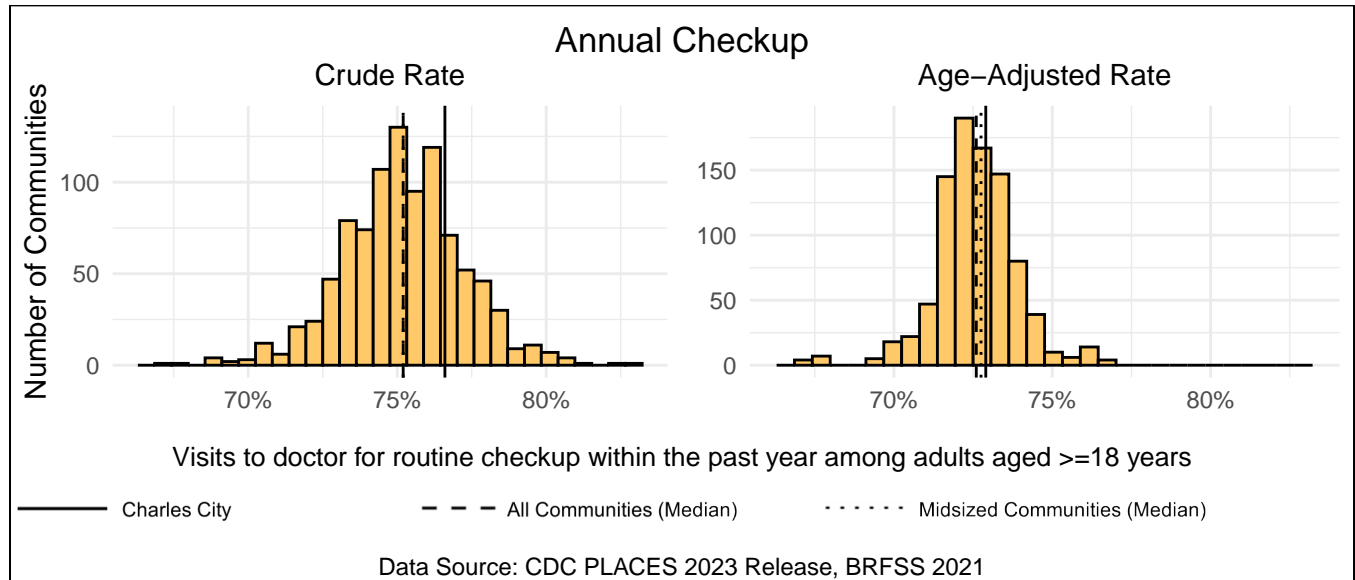

The age-adjusted rate for Charles City is 72.9%, which ranks 333rd out of 905 Iowa communities (46th out of 102 mid-sized communities).

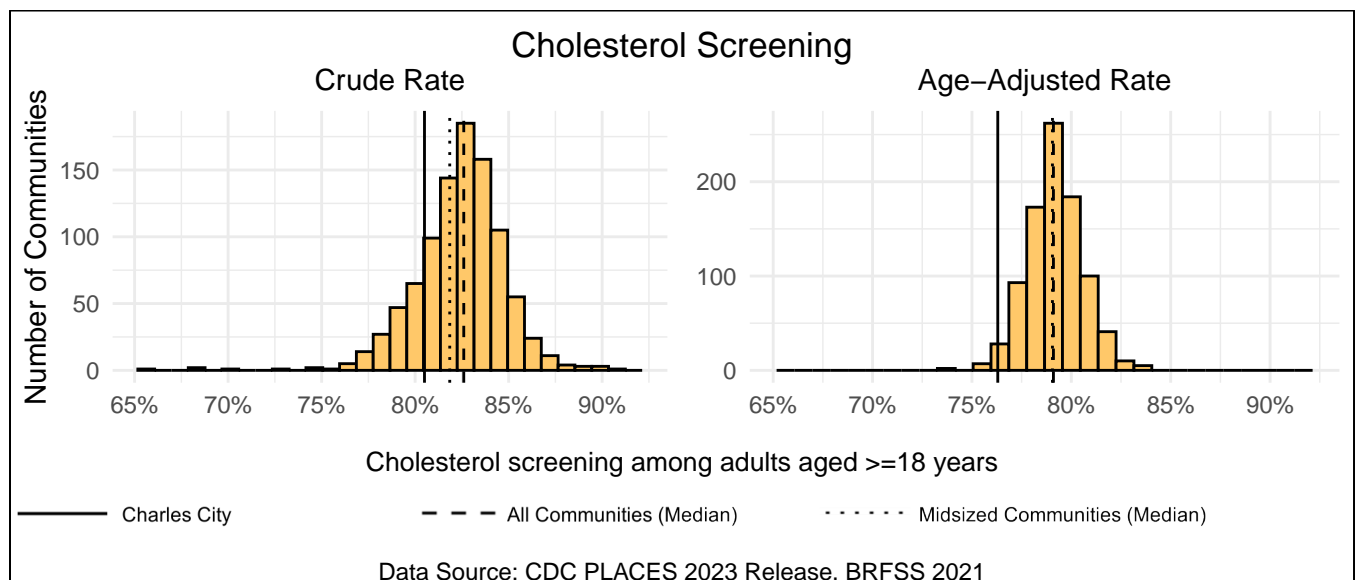

The age-adjusted rate for Charles City is 76.3%, which ranks 888th out of 905 Iowa communities (97th out of 102 mid-sized communities).

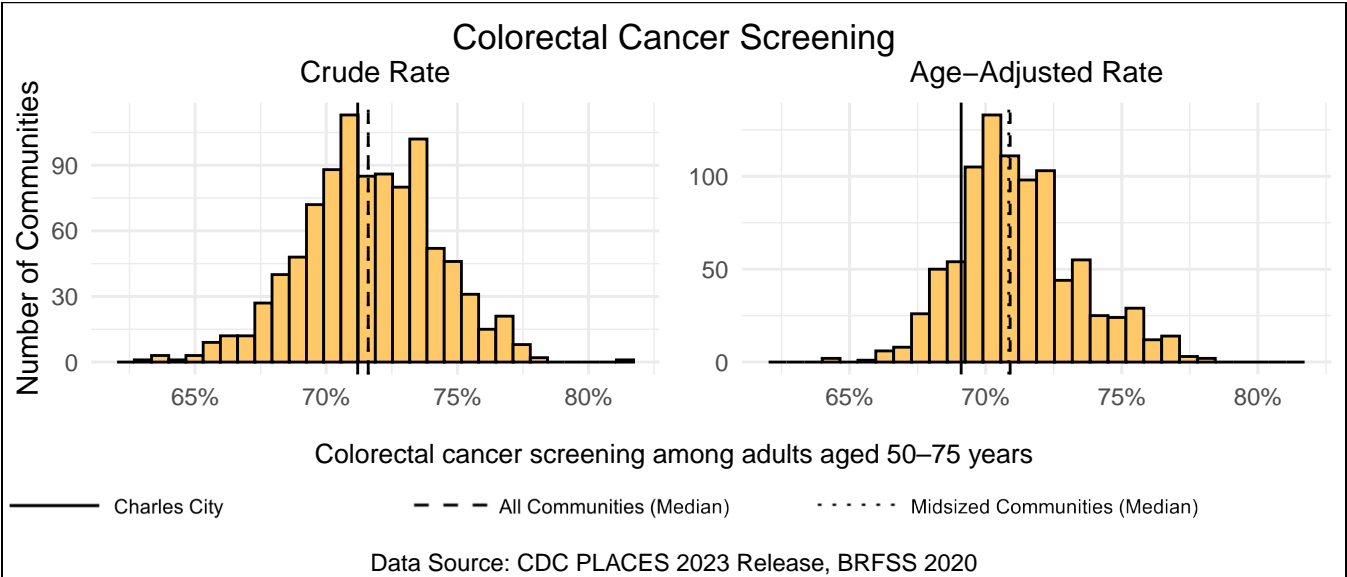

Colorectal Cancer Screening

Charles City has a crude rate of 71.2% for colorectal cancer screening among adults aged 50–75 years, which ranks 530th out of 958 Iowa communities (56th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 69.1%, which ranks 766th out of 905 Iowa communities (77th out of 102 mid-sized communities).

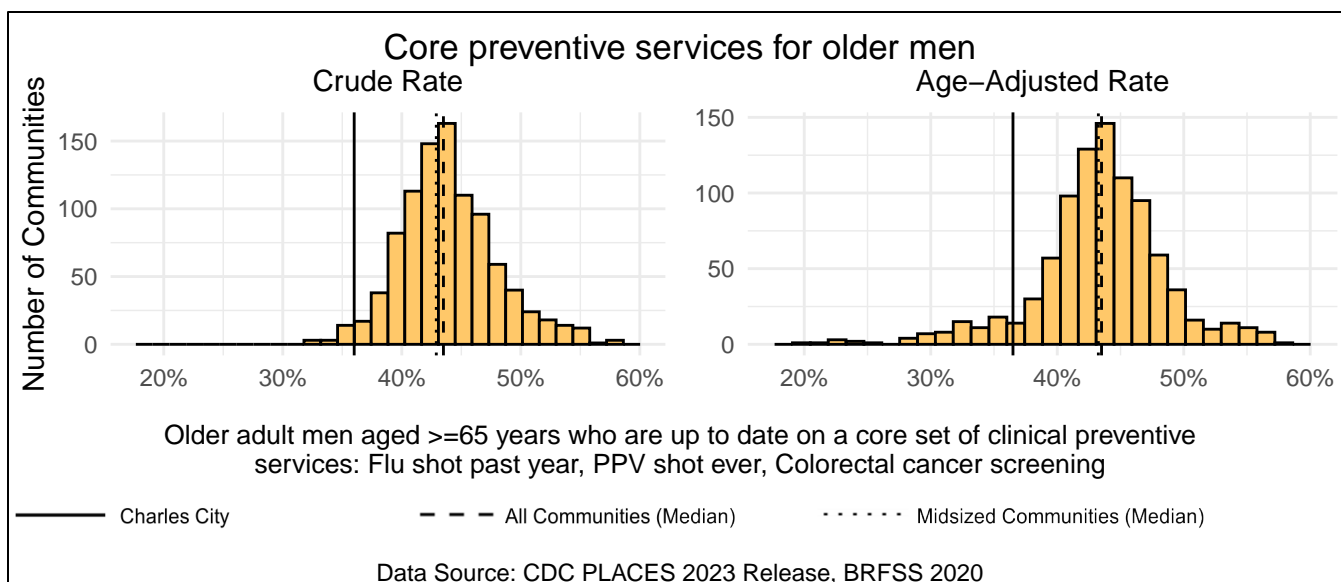

Charles City has a crude rate of 36.0% for older adult men aged ≥ 65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 939th out of 958 Iowa communities (99th out of 102 mid-sized communities). The age-adjusted rate for Charles City is 36.5%, which ranks 830th out of 905 Iowa communities (99th out of 102 mid-sized communities).

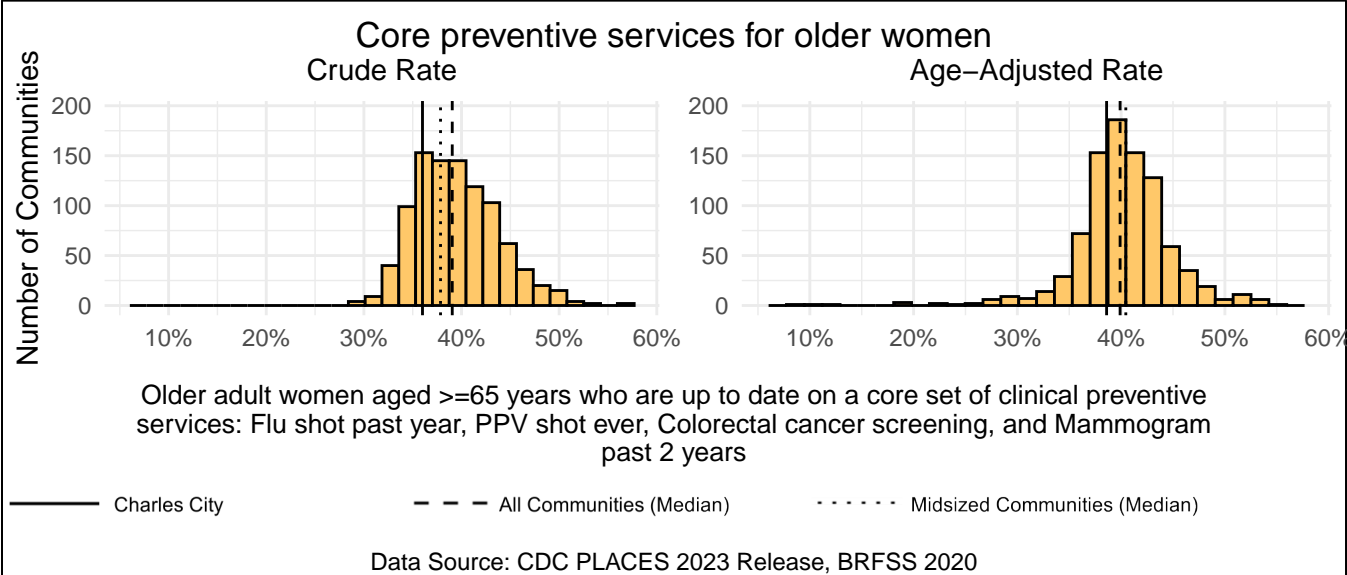

Core preventive services for older women

Charles City has a crude rate of 36.0% for older adult women aged ≥ 65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 757th out of 958 Iowa communities (70th out of 102 midsize communities). The age-adjusted rate for Charles City is 38.6%, which ranks 613th out of 905 Iowa communities (69th out of 102 midsize communities).

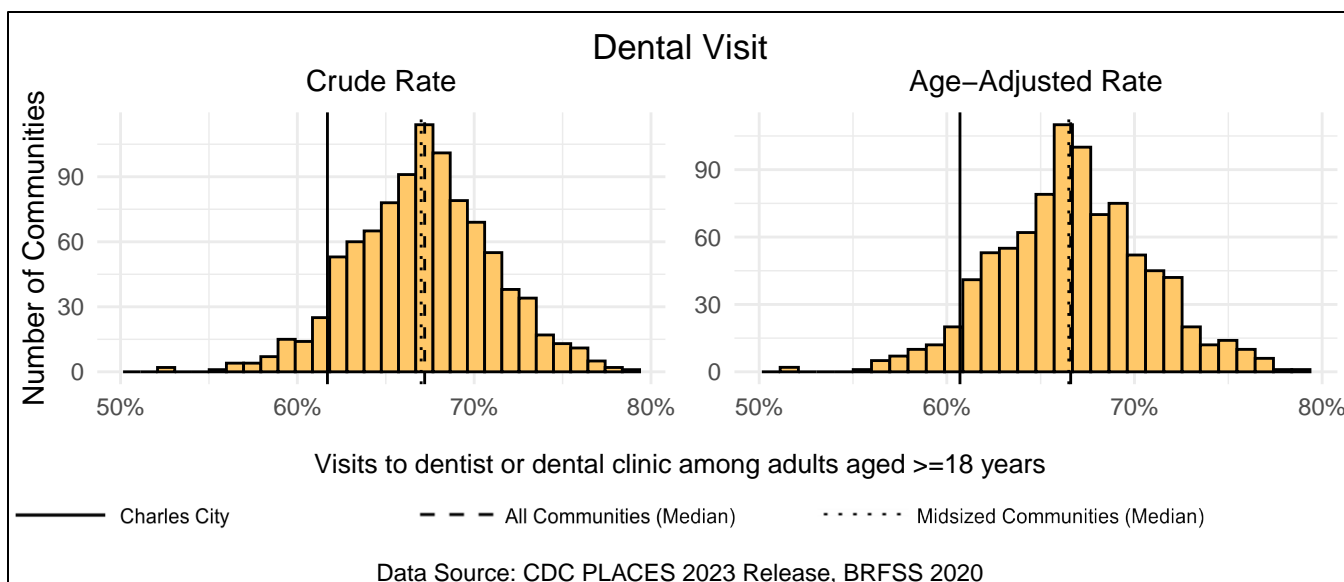

The age-adjusted rate for Charles City is 60.7%, which ranks 851st out of 905 Iowa communities (83rd out of 102 midsize communities).

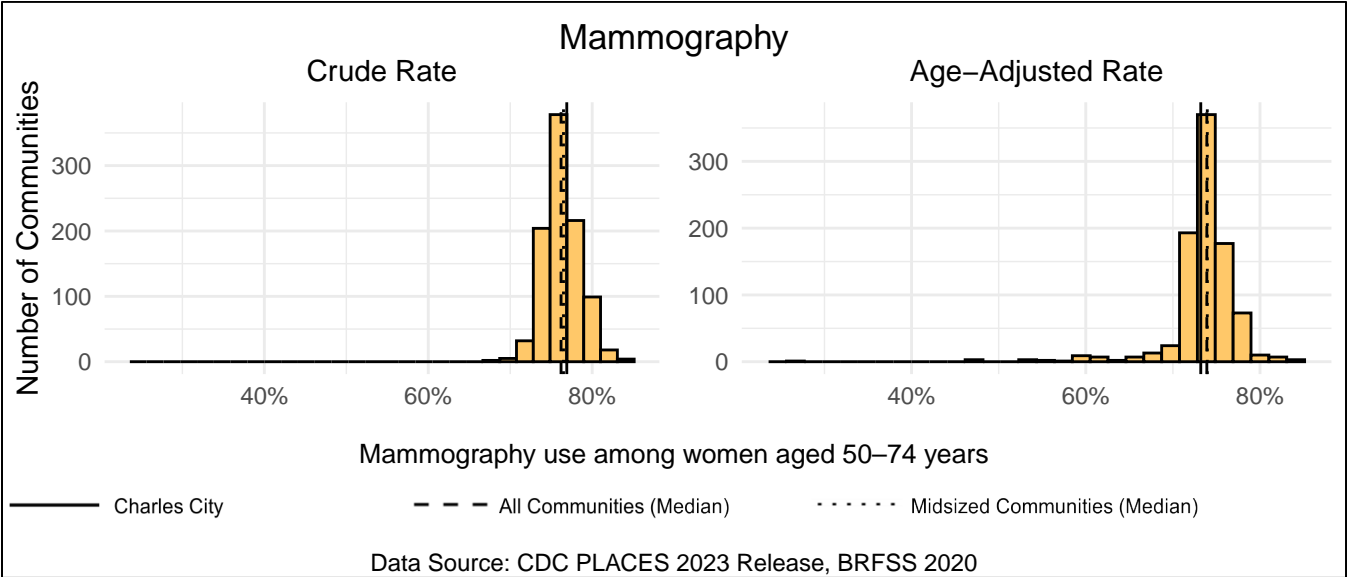

The age-adjusted rate for Charles City is 73.2%, which ranks 579th out of 905 Iowa communities (67th out of 102 midsized communities).

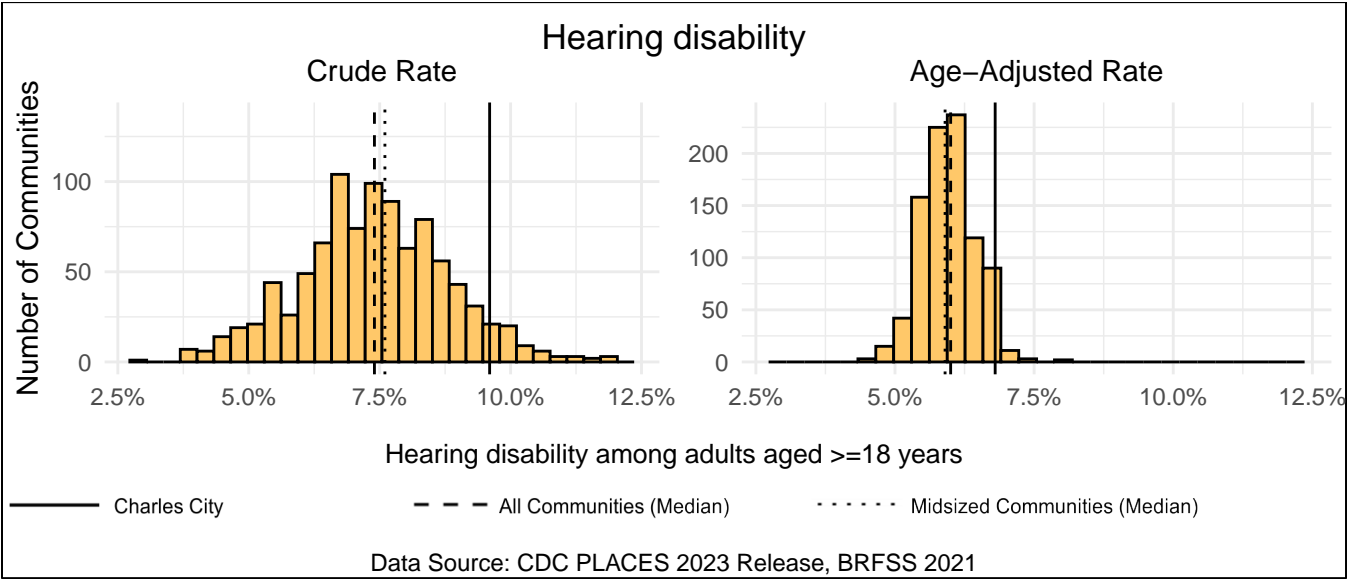

Charles City has a crude rate of 9.6% for hearing disability among adults aged ≥ 18 years, which ranks 900th out of 958 Iowa communities (101st out of 102 midsize communities). The age-adjusted rate for Charles City is 6.8%, which ranks 868th out of 905 Iowa communities (95th out of 102 midsize communities).

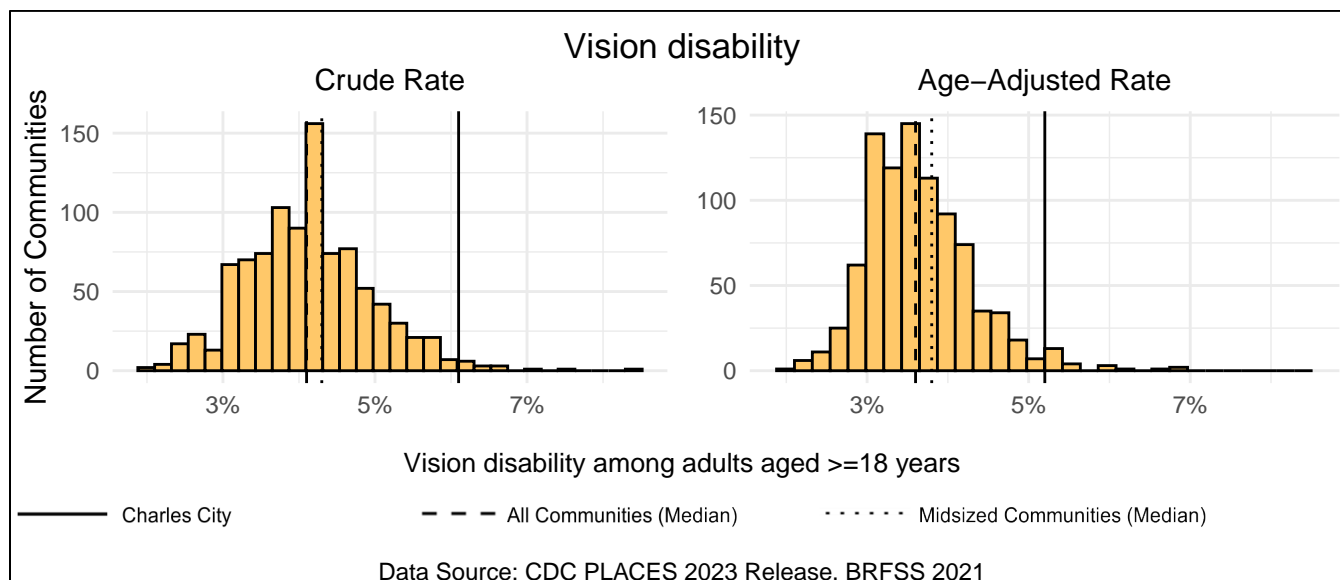

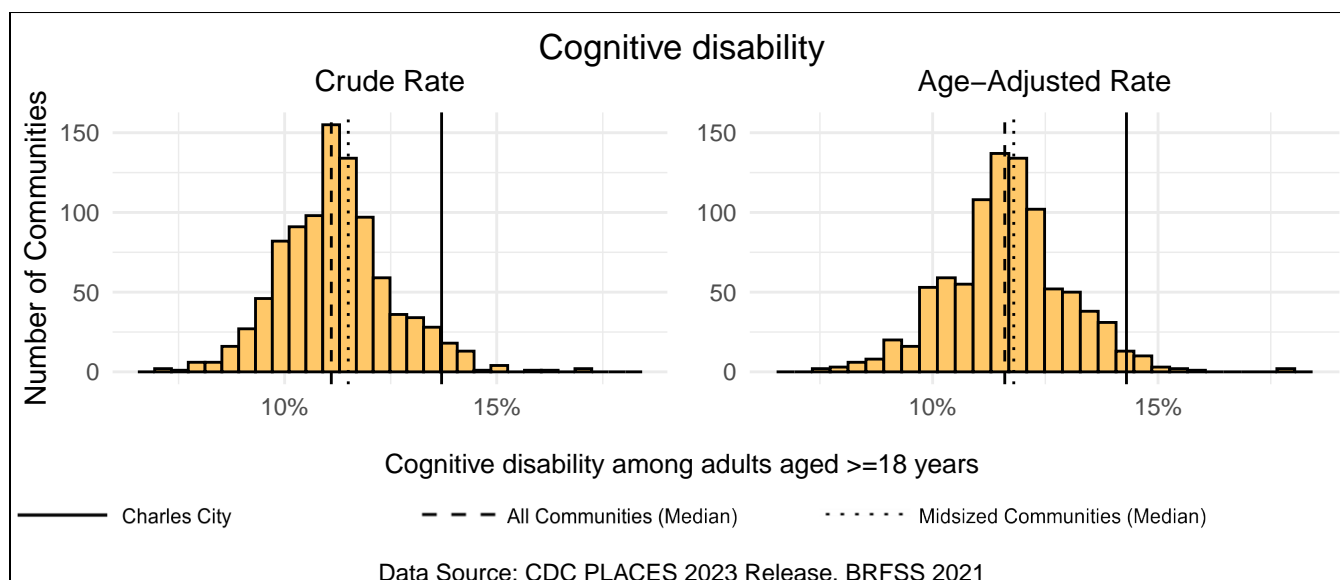

Charles City has a crude rate of 13.7% for cognitive disability among adults aged ≥ 18 years, which ranks 919th out of 958 Iowa communities (92nd out of 102 midsize communities). 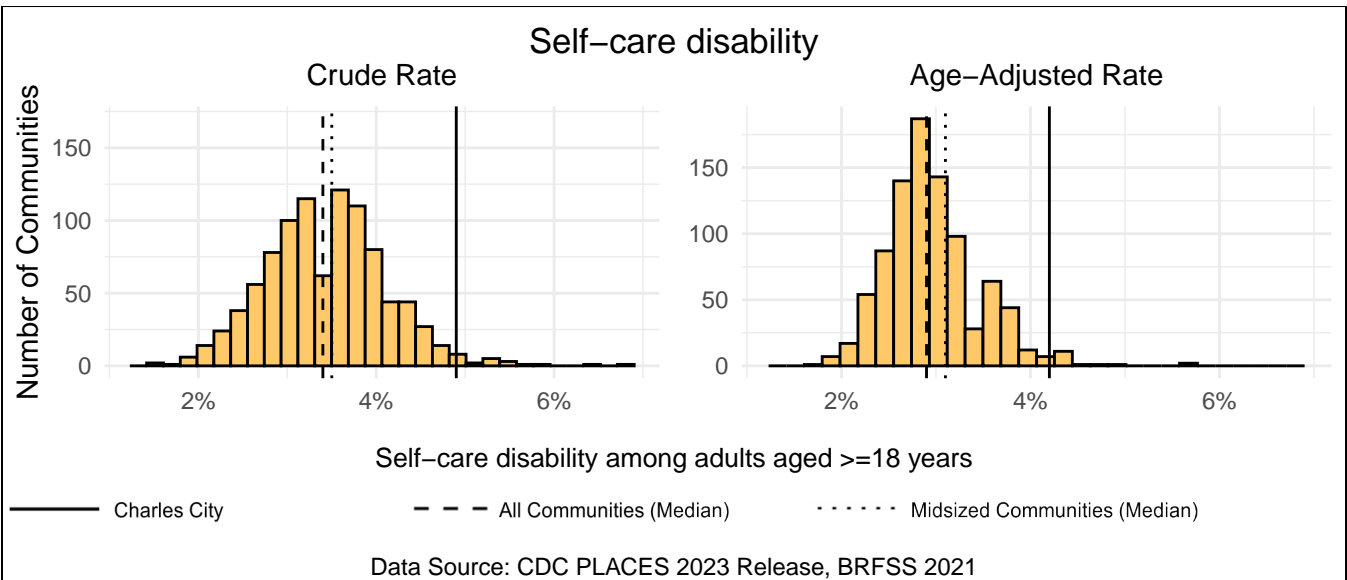

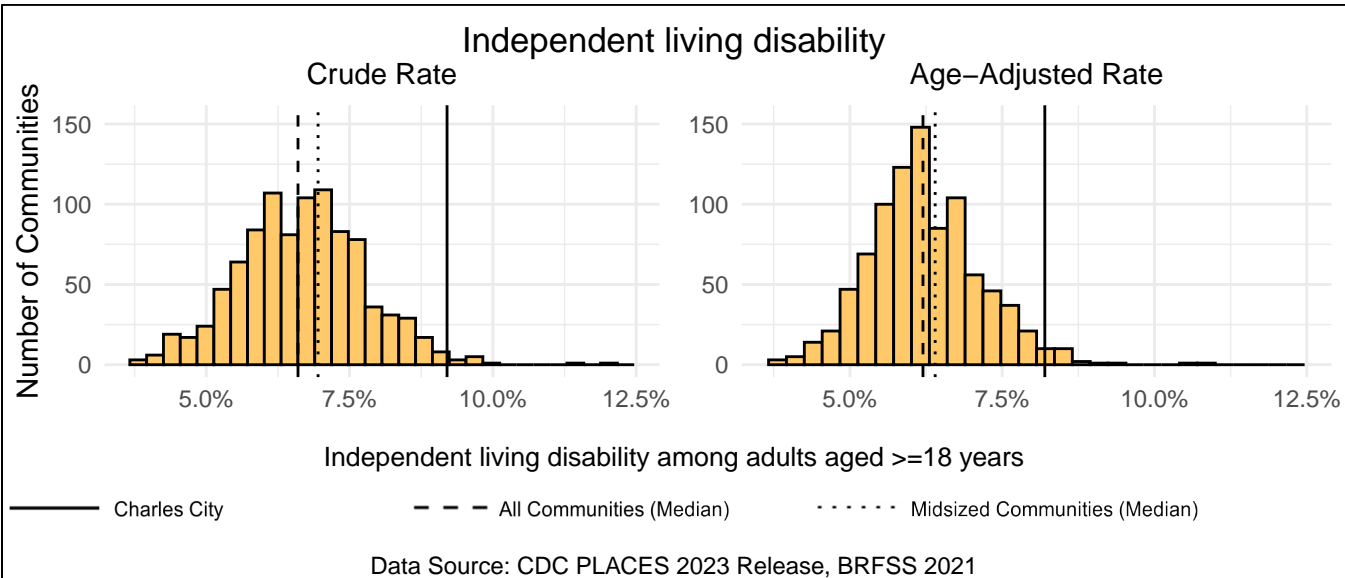

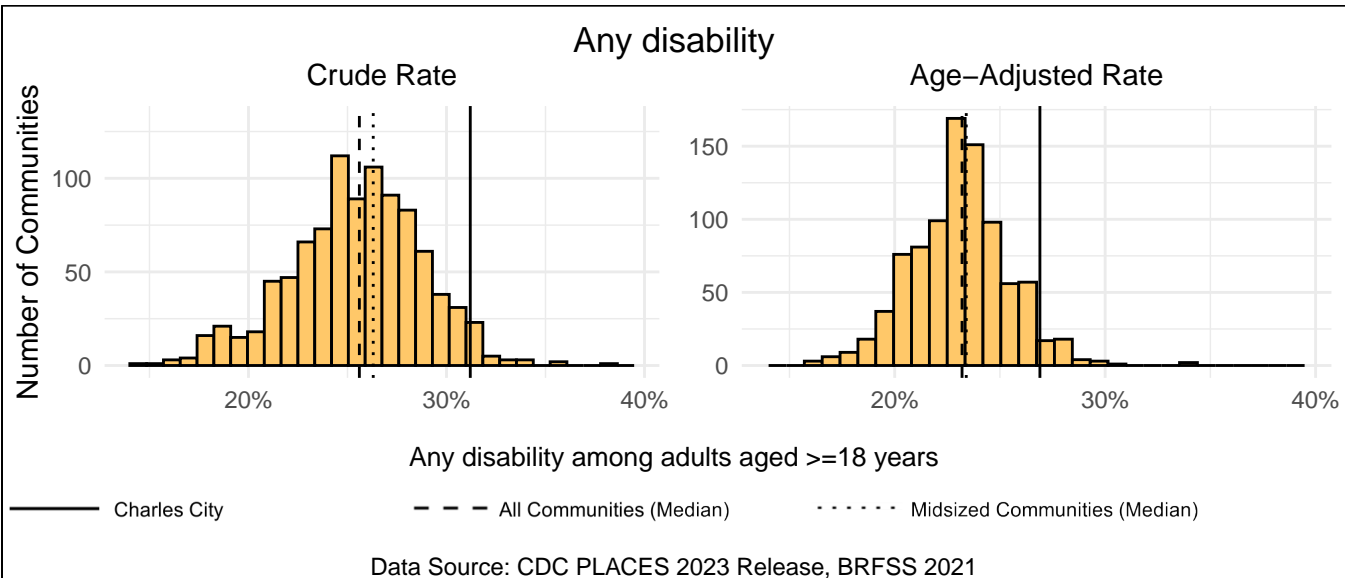

This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
