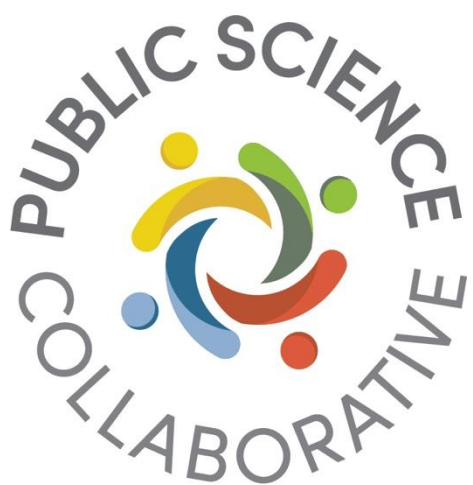

Health in Clarence: Overview

Dear Community Members & Stakeholders of Clarence,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partnership with Iowa State University’s Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Clarence ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Clarence’s strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all Iowa communities and communities of similar size to Clarence. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community’s strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

How to Use this Report

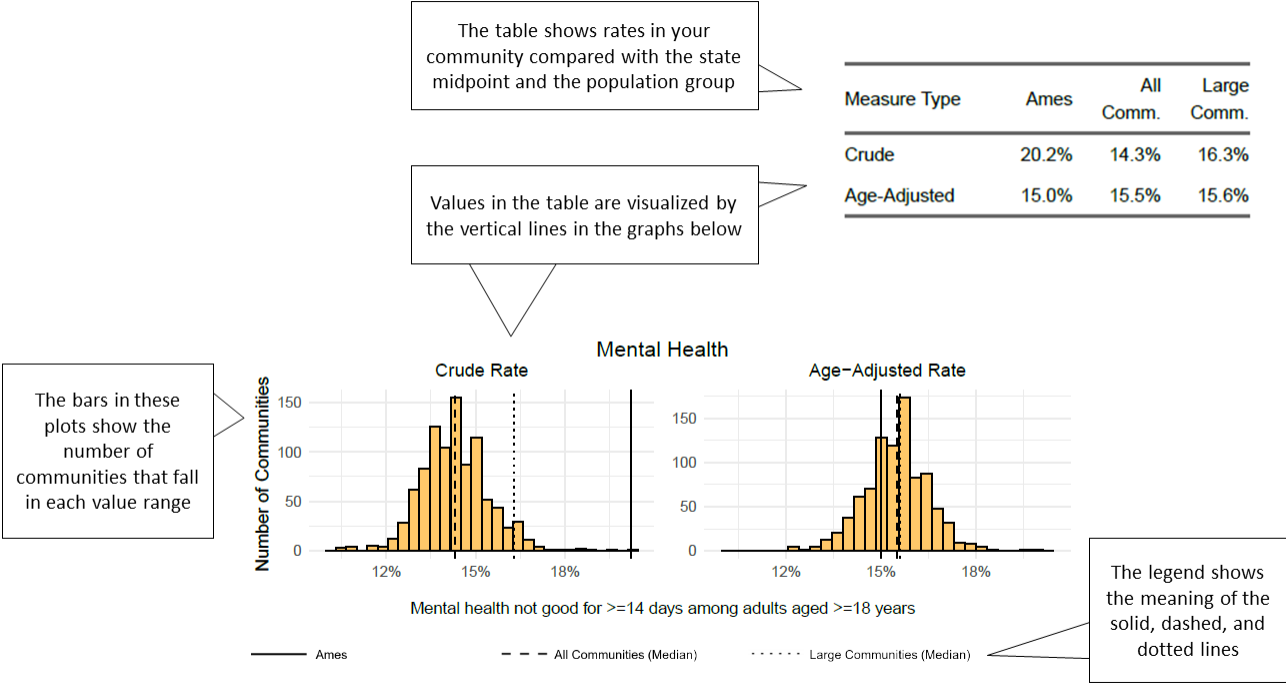
The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Clarence that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Clarence, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Clarence compares to the rest of the state and similarly-sized communities.

With a population of 1,136, Clarence’s similarly sized communities are defined as small communities. In Iowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community’s crude and age-adjusted rate estimates alongside their averages across all Iowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all Iowa communities and the dotted lines showing the average rate for similarly-sized communities.



Health Status

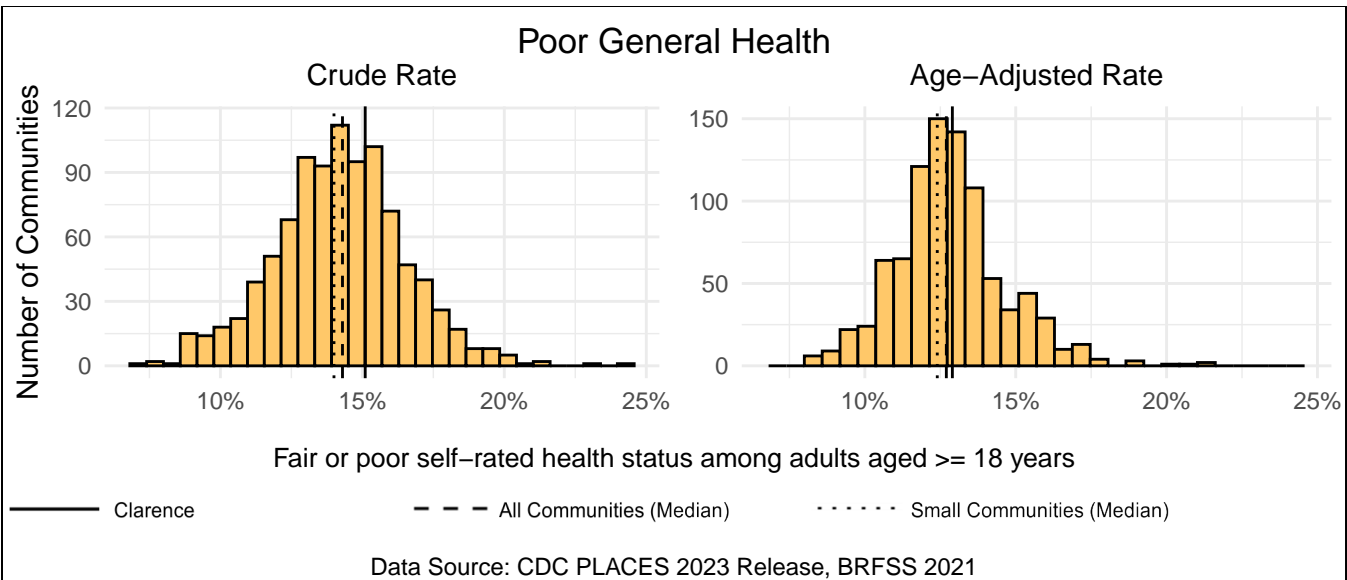
This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country’s population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of “excellent,” “very good,” “good,” “fair,” or “poor,” from which the respondents who answer “fair” or “poor” are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Clarence has a crude rate of 15.1% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 629th out of 958 Iowa communities (99th out of 138 small communities). The age-adjusted rate for Clarence is 12.9%, which ranks 482nd out of 905 Iowa communities (80th out of 138 small communities).

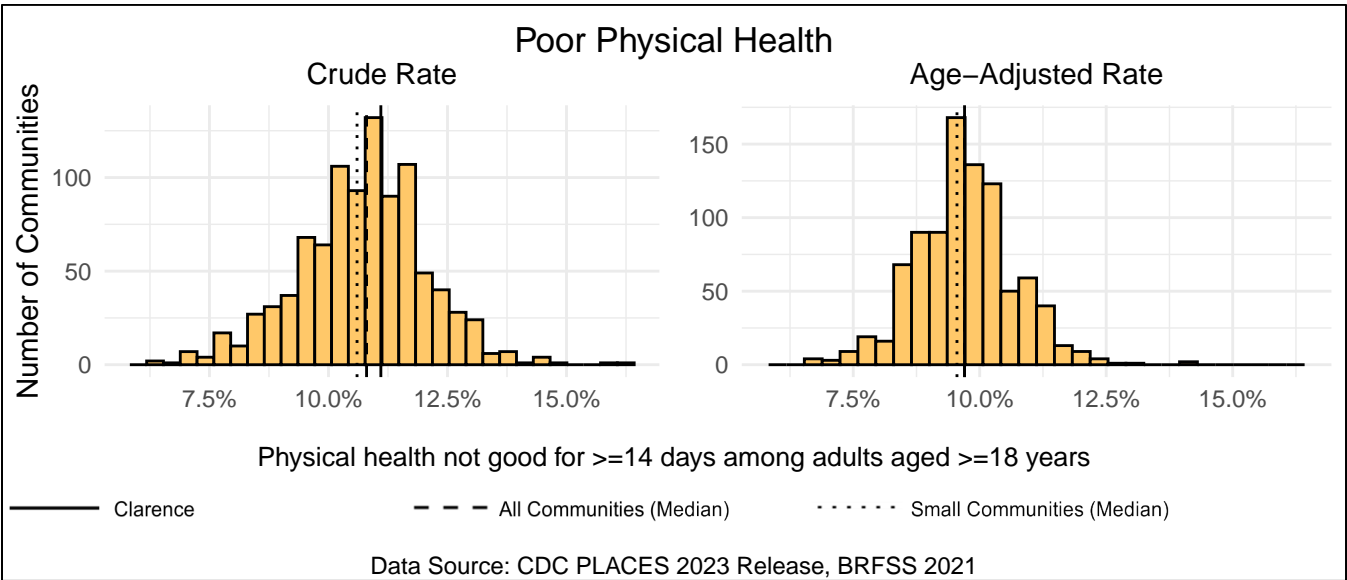

Poor Physical Health

Clarence has a crude rate of 11.1% for physical health not good for >=14 days among adults aged >=18 years, which ranks 568th out of 958 Iowa communities (90th out of 138 small communities). The age-adjusted rate for Clarence is 9.7%, which ranks 429th out of 905 Iowa communities (77th out of 138 small communities).

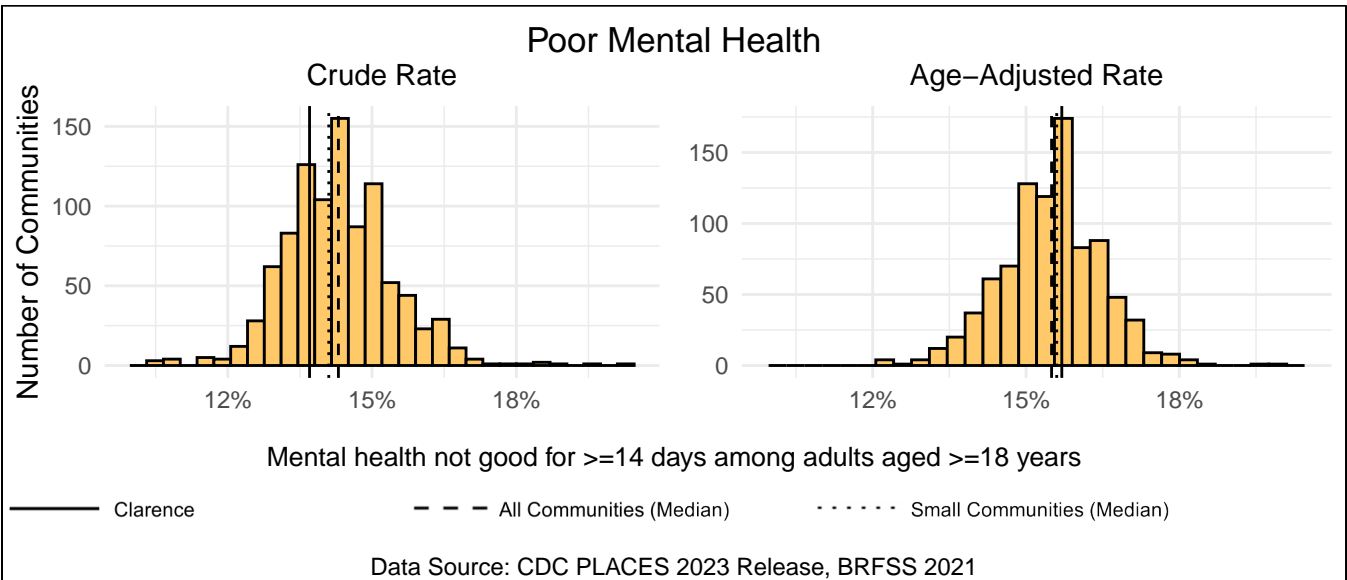

Poor Mental Health

Clarence has a crude rate of 13.7% for mental health not good for >=14 days among adults aged >=18 years, which ranks 260th out of 958 Iowa communities (44th out of 138 small communities). The age-adjusted rate for Clarence is 15.7%, which ranks 516th out of 905 Iowa communities (77th out of 138 small communities).

Health Risk Behaviors

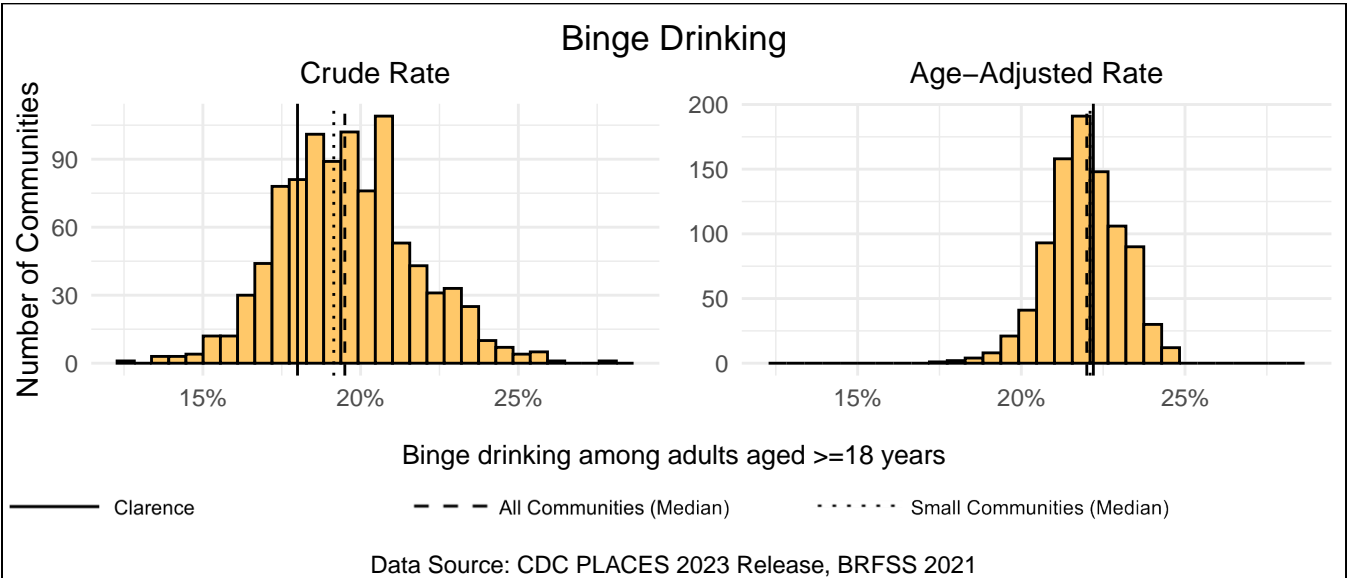
Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Clarence has a crude rate of 18.0% for binge drinking among adults aged ≥ 18 years, which ranks 223rd out of 958 Iowa communities (42nd out of 138 small communities). The age-adjusted rate for Clarence is 22.2%, which ranks 520th out of 905 Iowa communities (73rd out of 138 small communities).

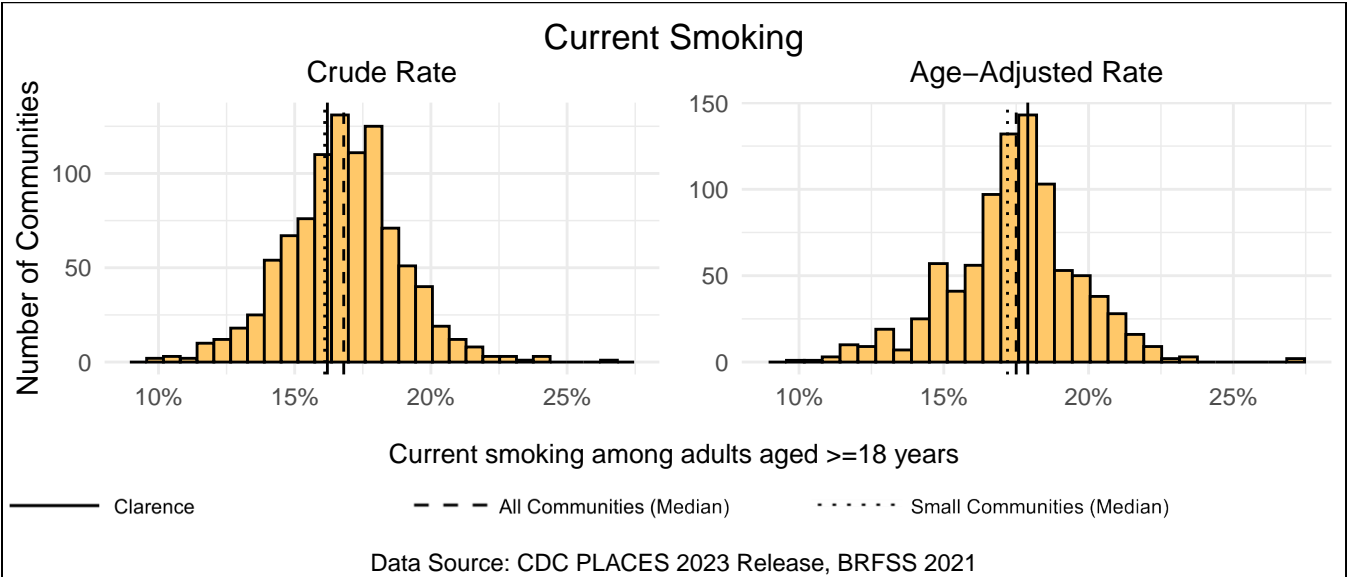

Current Smoking

Clarence has a crude rate of 16.2% for current smoking among adults aged >=18 years, which ranks 337th out of 958 Iowa communities (73rd out of 138 small communities). The age-adjusted rate for Clarence is 17.9%, which ranks 513th out of 905 Iowa communities (85th out of 138 small communities).

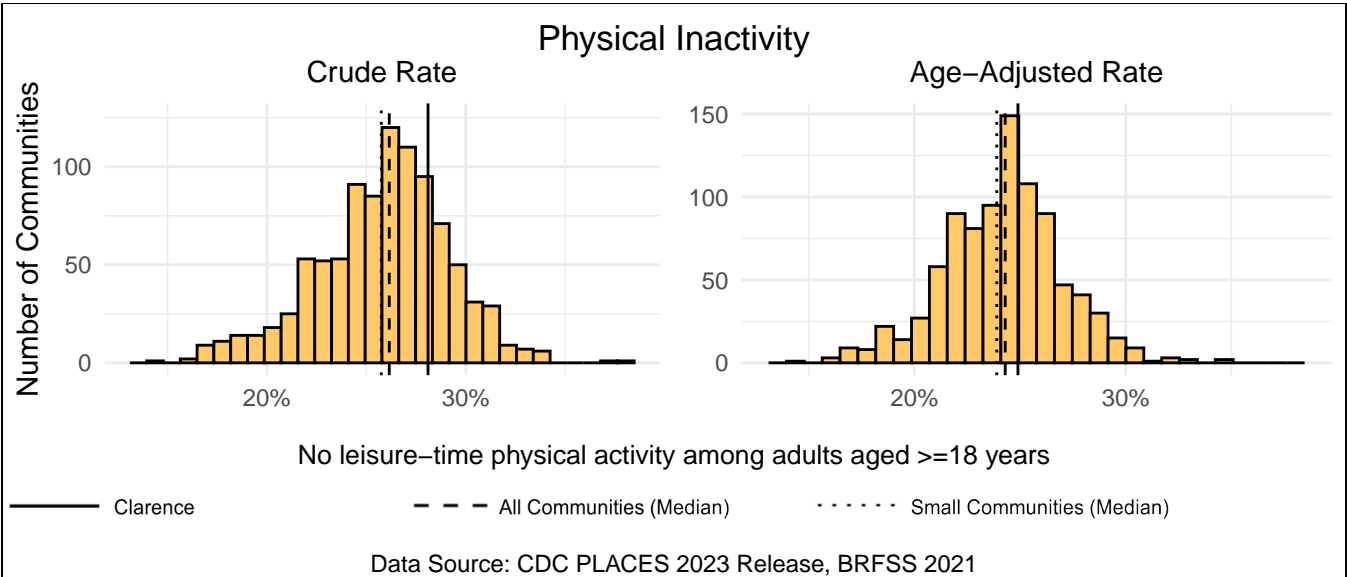

Physical Inactivity

Clarence has a crude rate of 28.1% for no leisure-time physical activity among adults aged >=18 years, which ranks 726th out of 958 Iowa communities (105th out of 138 small communities). The age-adjusted rate for Clarence is 24.9%, which ranks 541st out of 905 Iowa communities (89th out of 138 small communities).

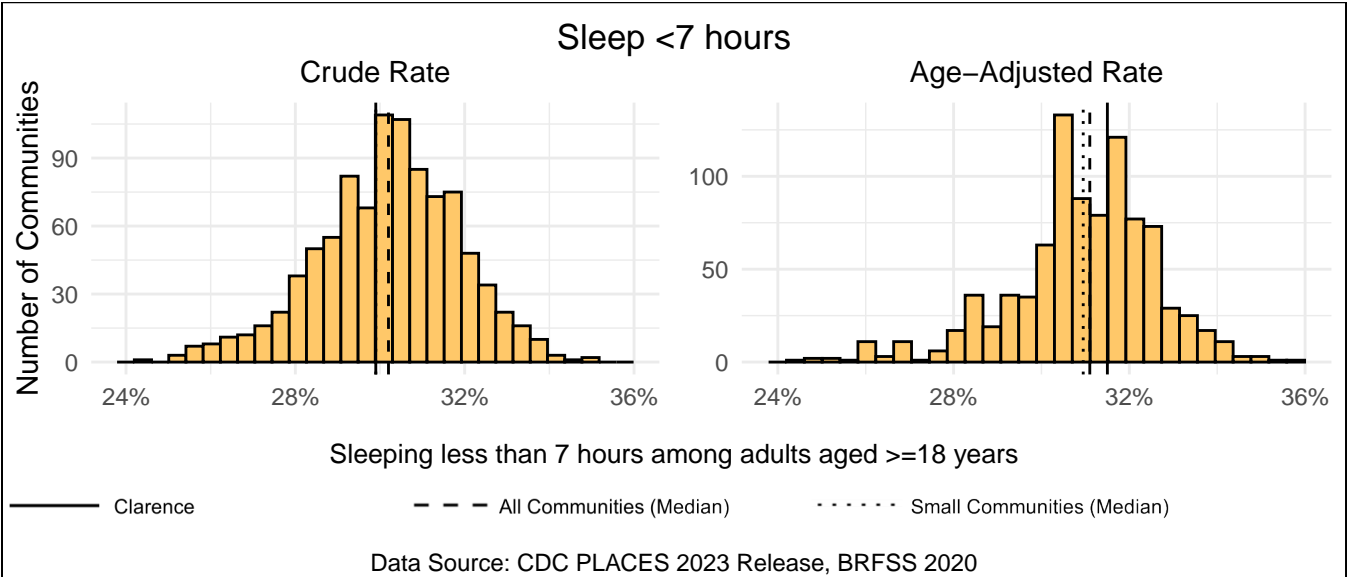

Sleep <7 hours

Clarence has a crude rate of 29.9% for sleeping less than 7 hours among adults aged ≥ 18 years, which ranks 374th out of 958 Iowa communities (66th out of 138 small communities). The age-adjusted rate for Clarence is 31.5%, which ranks 522nd out of 905 Iowa communities (88th out of 138 small communities).

Health Outcomes

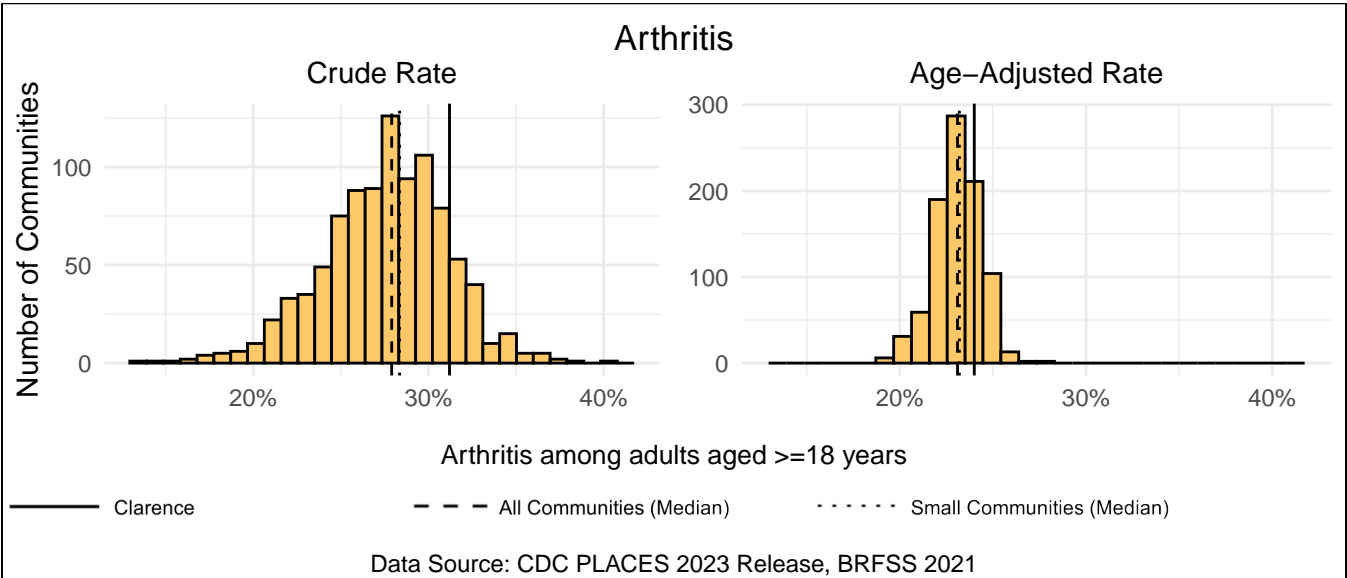

Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. Arthritis

Clarence has a crude rate of 31.2% for arthritis among adults aged ≥ 18 years, which ranks 827th out of 958 Iowa communities (116th out of 138 small communities). The age-adjusted rate for Clarence is 24.0%, which ranks 683rd out of 905 Iowa communities (107th out of 138 small communities).

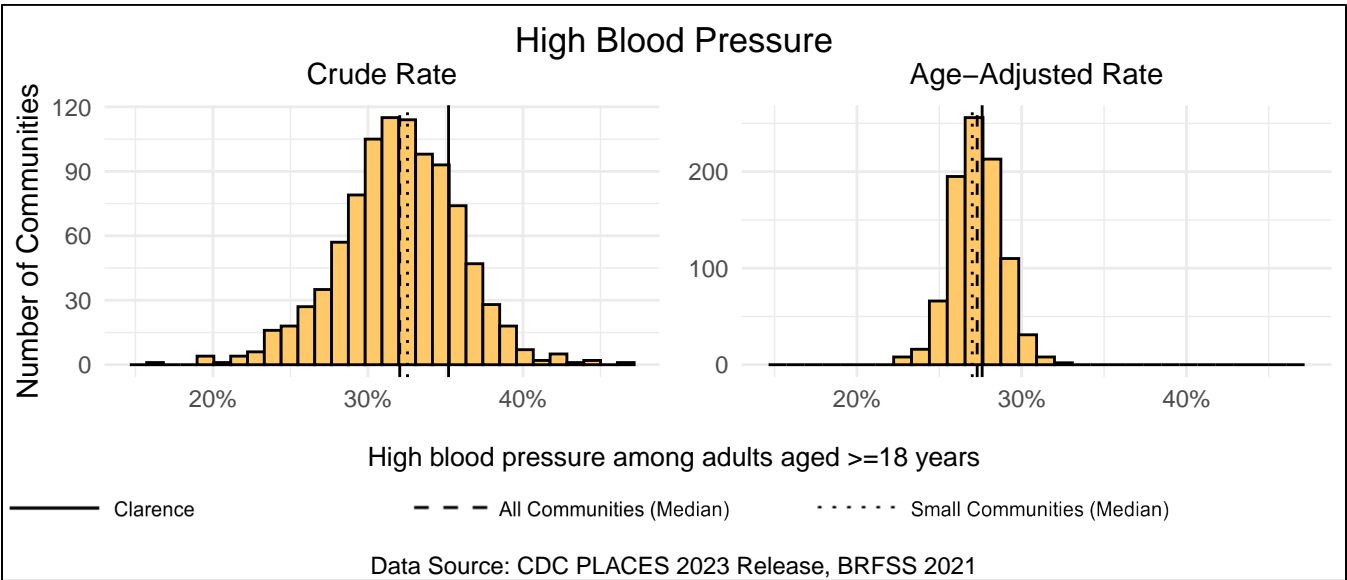

High Blood Pressure

Clarence has a crude rate of 35.2% for high blood pressure among adults aged ≥ 18 years, which ranks 770th out of 958 Iowa communities (108th out of 138 small communities). The age-adjusted rate for Clarence is 27.6%, which ranks 517th out of 905 Iowa communities (87th out of 138 small communities).

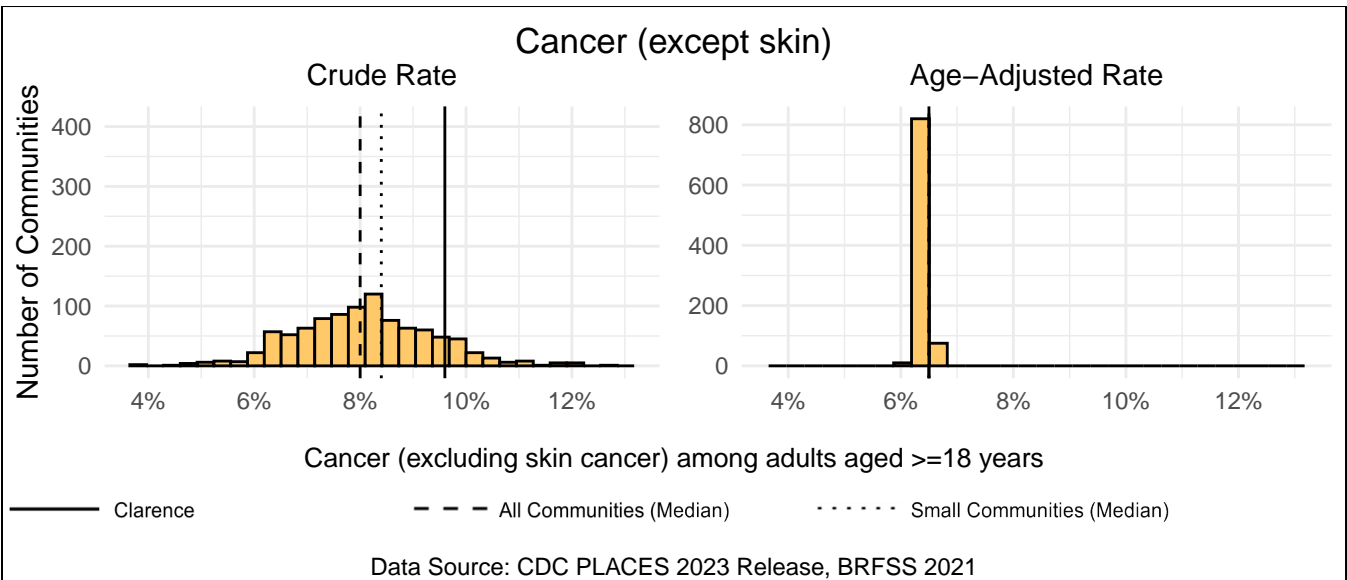

Cancer (except skin)

Clarence has a crude rate of 9.6% for cancer (excluding skin cancer) among adults aged ≥ 18 years, which ranks 841st out of 958 Iowa communities (110th out of 138 small communities). The age-adjusted rate for Clarence is 6.5%, which ranks 418th out of 905 Iowa communities (41st out of 138 small communities).

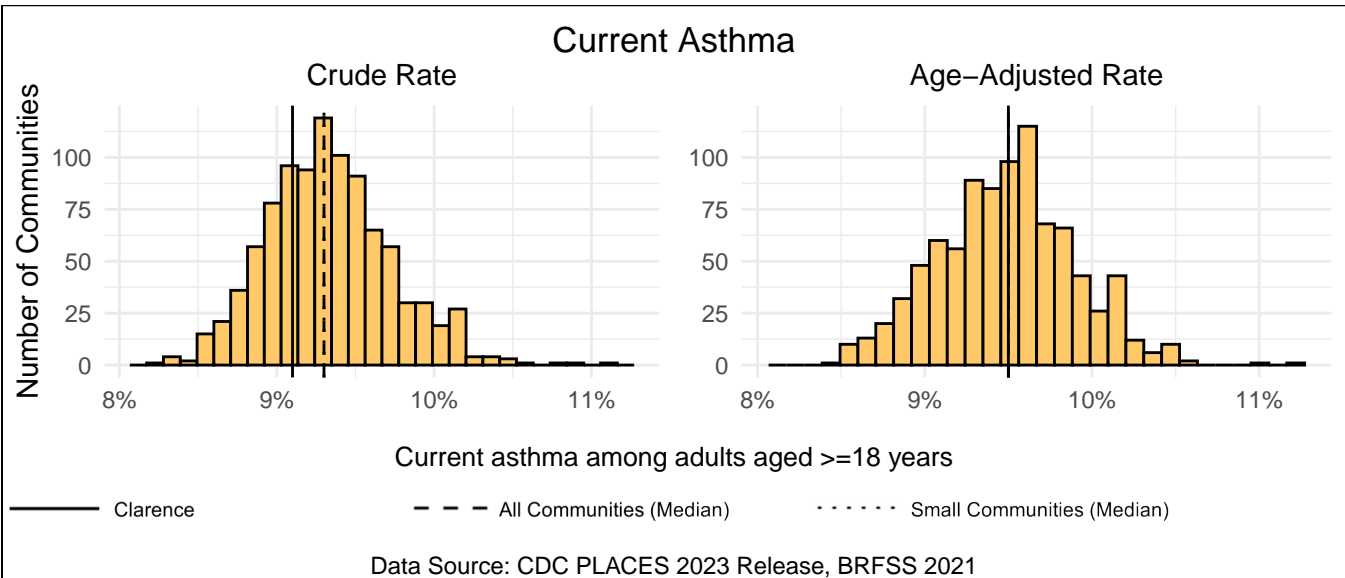

Current Asthma

Clarence has a crude rate of 9.1% for current asthma among adults aged ≥ 18 years, which ranks 215th out of 958 Iowa communities (32nd out of 138 small communities). The age-adjusted rate for Clarence is 9.5%, which ranks 415th out of 905 Iowa communities (54th out of 138 small communities).

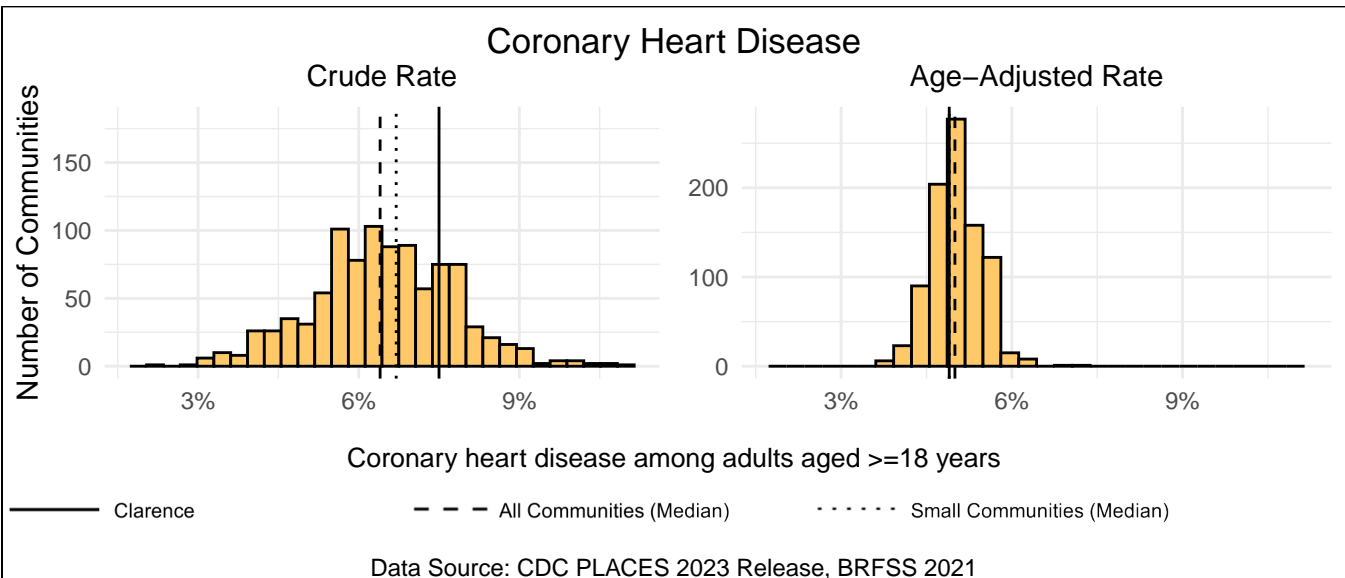

Coronary Heart Disease

Clarence has a crude rate of 7.5% for coronary heart disease among adults aged ≥ 18 years, which ranks 747th out of 958 Iowa communities (102nd out of 138 small communities). The age-adjusted rate for Clarence is 4.9%, which ranks 324th out of 905 Iowa communities (68th out of 138 small communities).

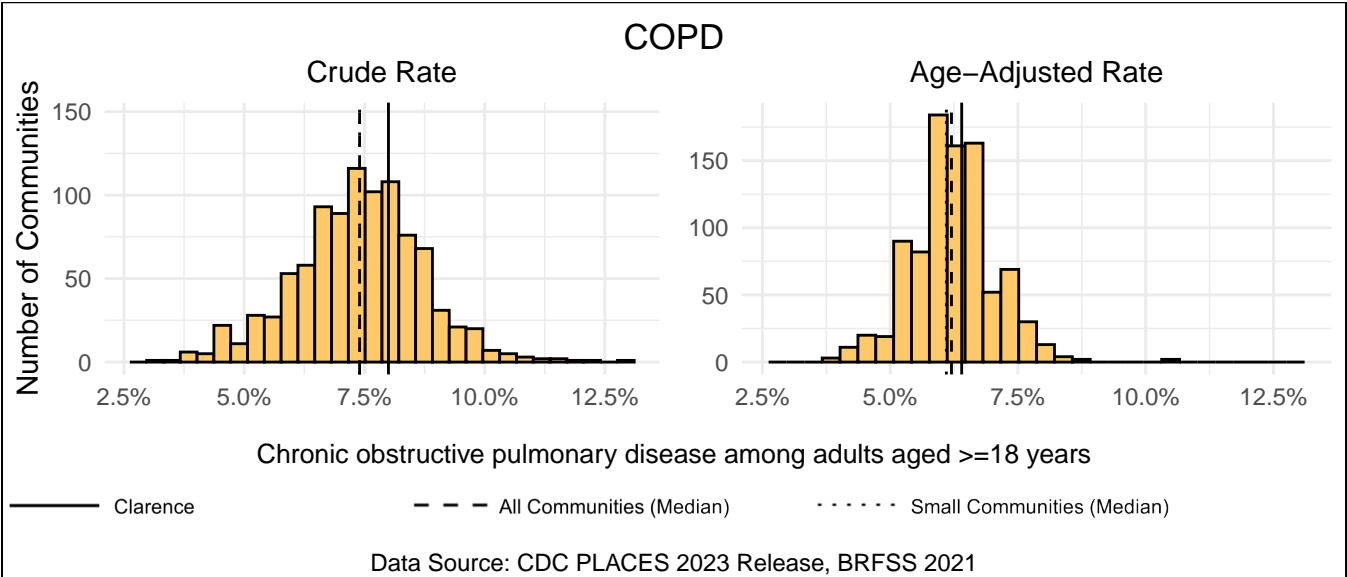

Clarence has a crude rate of 8.0% for chronic obstructive pulmonary disease among adults aged ≥ 18 years, which ranks 651st out of 958 Iowa communities (98th out of 138 small communities). The age-adjusted rate for Clarence is 6.4%, which ranks 513th out of 905 Iowa communities (82nd out of 138 small communities).

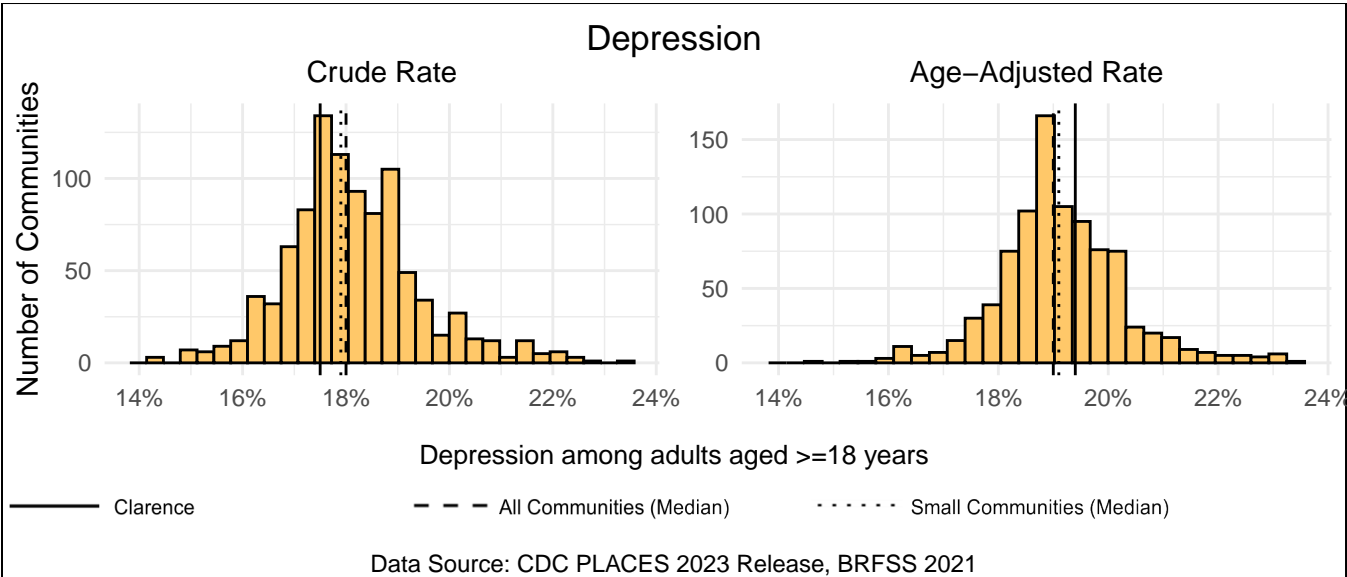

Clarence has a crude rate of 17.5% for depression among adults aged ≥ 18 years, which ranks 284th out of 958 Iowa communities (46th out of 138 small communities). The age-adjusted rate for Clarence is 19.4%, which ranks 562nd out of 905 Iowa communities (87th out of 138 small communities).

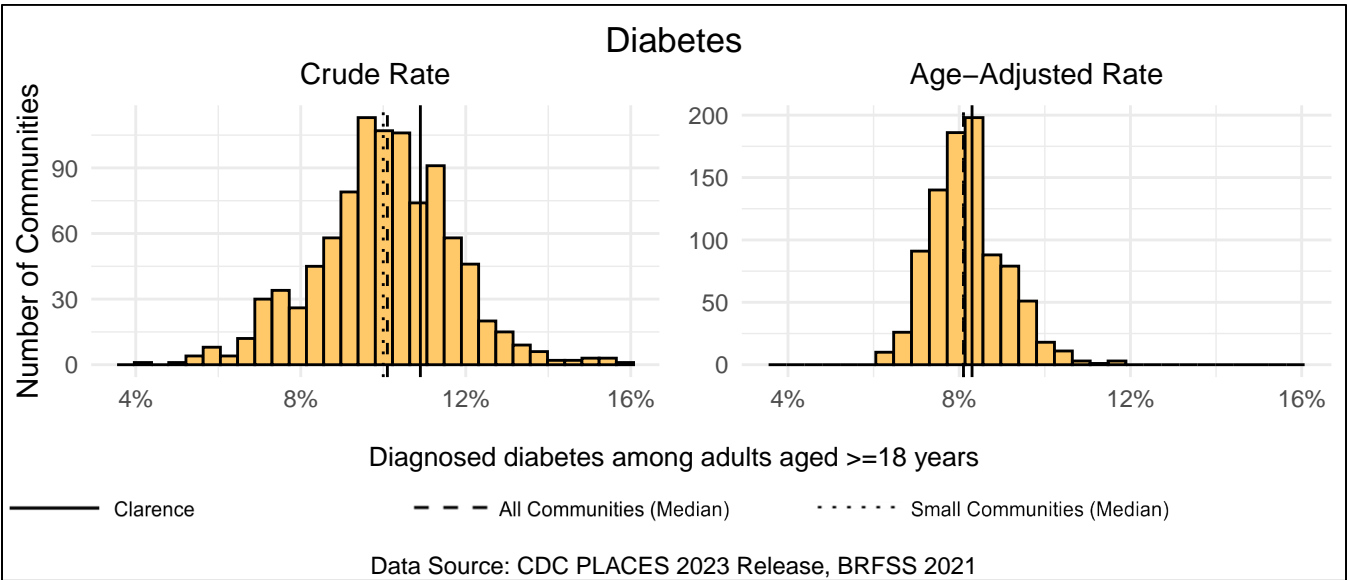

Clarence has a crude rate of 10.9% for diagnosed diabetes among adults aged >=18 years, which ranks 670th out of 958 Iowa communities (99th out of 138 small communities). The age-adjusted rate for Clarence is 8.3%, which ranks 508th out of 905 Iowa communities (89th out of 138 small communities).

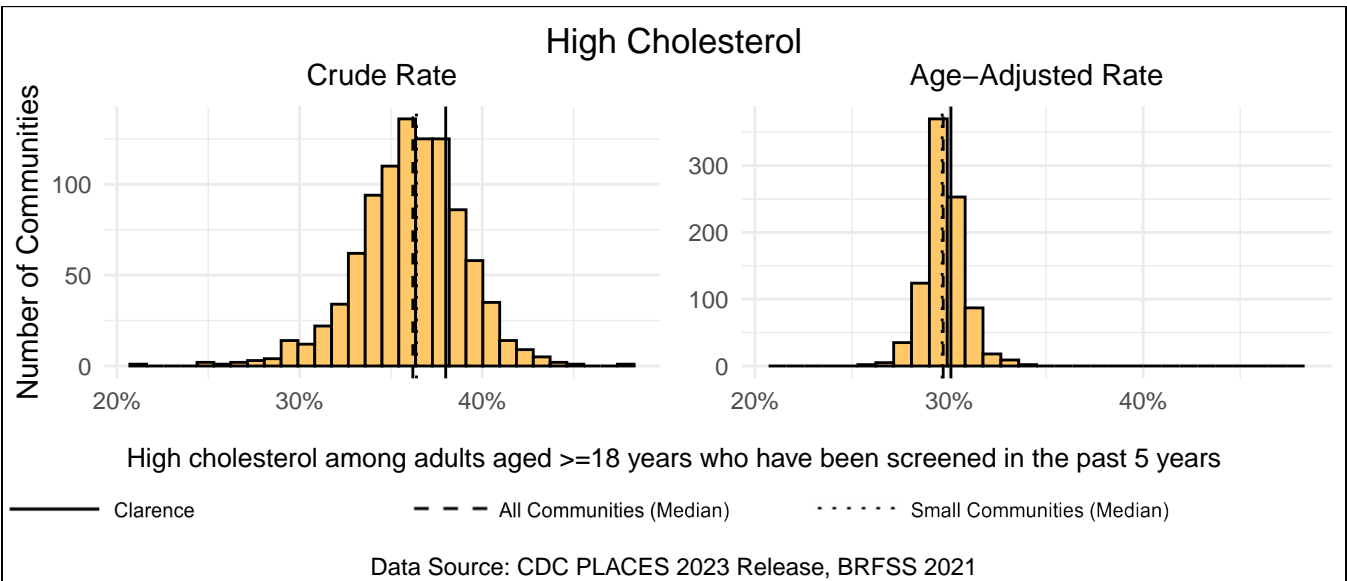

High Cholesterol

Clarence has a crude rate of 38.0% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 720th out of 958 Iowa communities (107th out of 138 small communities). The age-adjusted rate for Clarence is 30.1%, which ranks 565th out of 905 Iowa communities (89th out of 138 small communities).

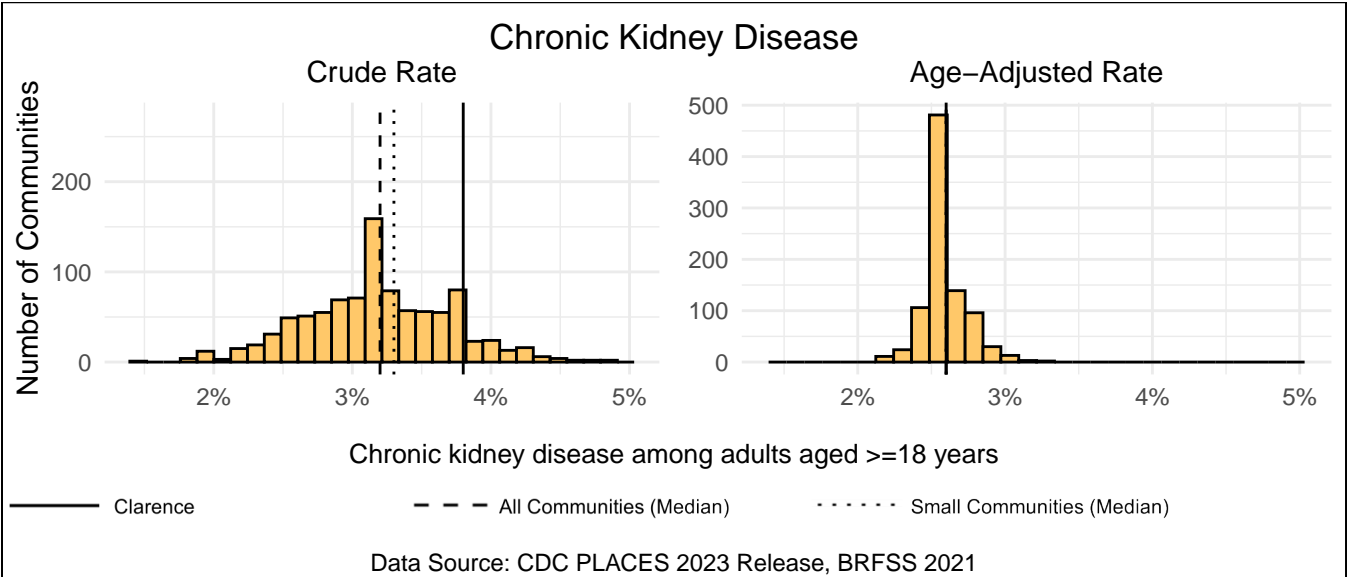

Clarence has a crude rate of 3.8% for chronic kidney disease among adults aged ≥ 18 years, which ranks 832nd out of 958 Iowa communities (114th out of 138 small communities). The age-adjusted rate for Clarence is 2.6%, which ranks 349th out of 905 Iowa communities (65th out of 138 small communities).

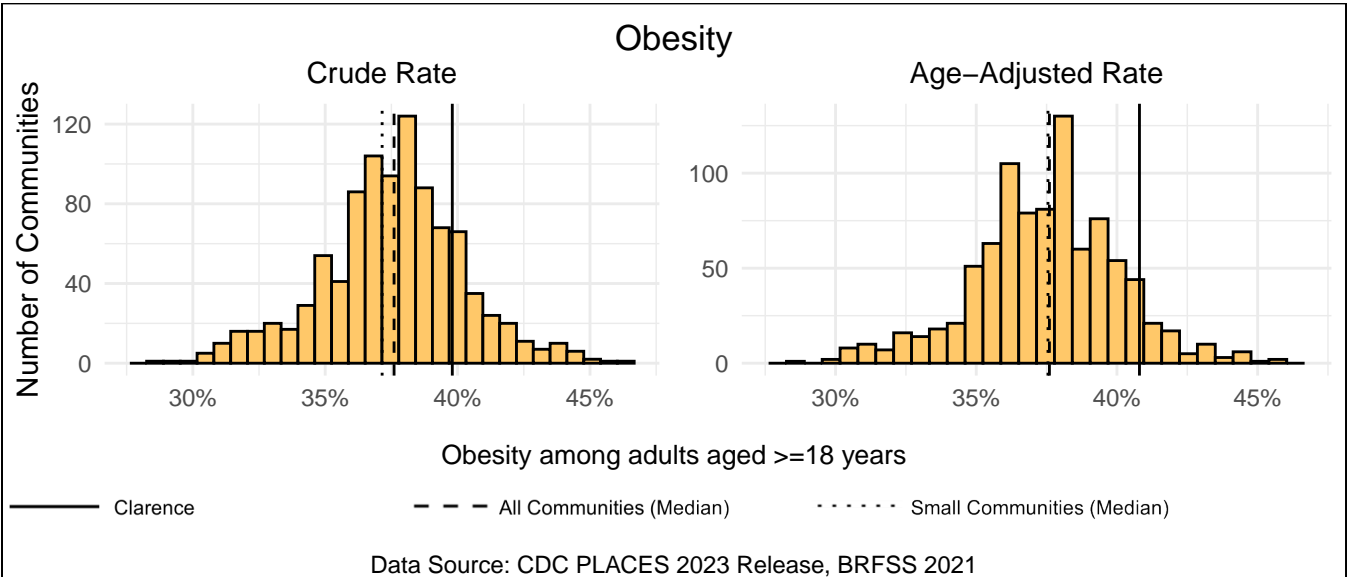

Clarence has a crude rate of 39.8% for obesity among adults aged ≥ 18 years, which ranks 789th out of 958 Iowa communities (129th out of 138 small communities). The age-adjusted rate for Clarence is 40.8%, which ranks 822nd out of 905 Iowa communities (129th out of 138 small communities).

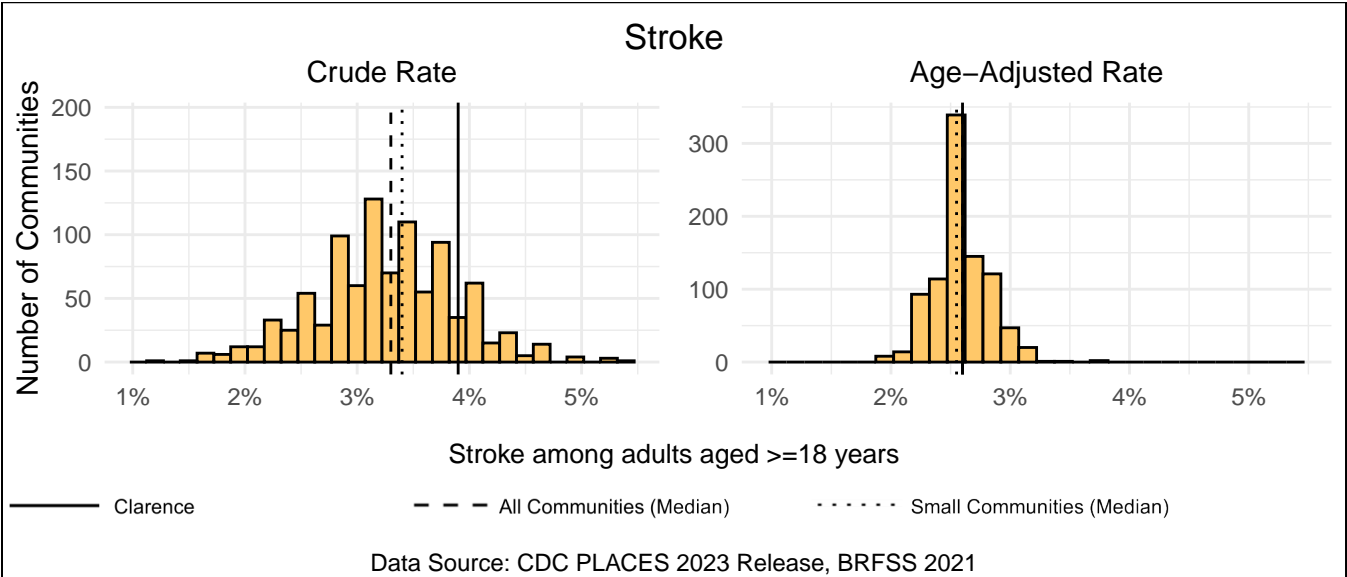

Clarence has a crude rate of 3.9% for stroke among adults aged ≥ 18 years, which ranks 797th out of 958 Iowa communities (105th out of 138 small communities). The age-adjusted rate for Clarence is 2.6%, which ranks 375th out of 905 Iowa communities (70th out of 138 small communities).

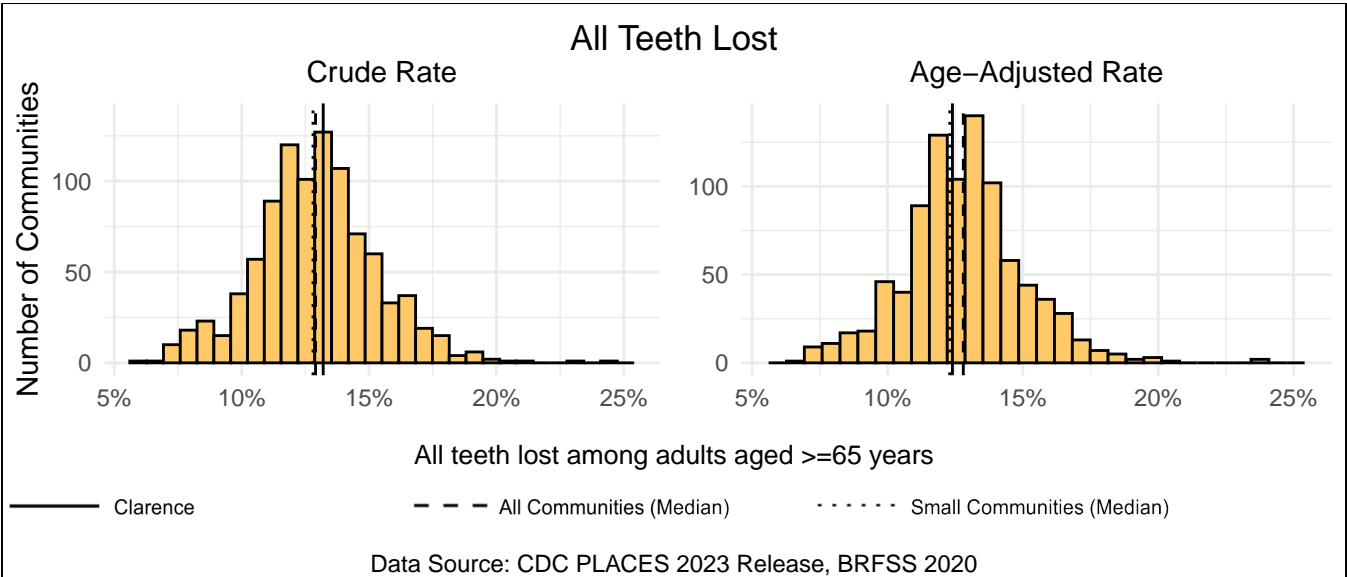

Clarence has a crude rate of 13.2% for all teeth lost among adults aged ≥ 65 years, which ranks 522nd out of 958 Iowa communities (81st out of 138 small communities). The age-adjusted rate for Clarence is 12.4%, which ranks 374th out of 905 Iowa communities (71st out of 138 small communities).

Prevention

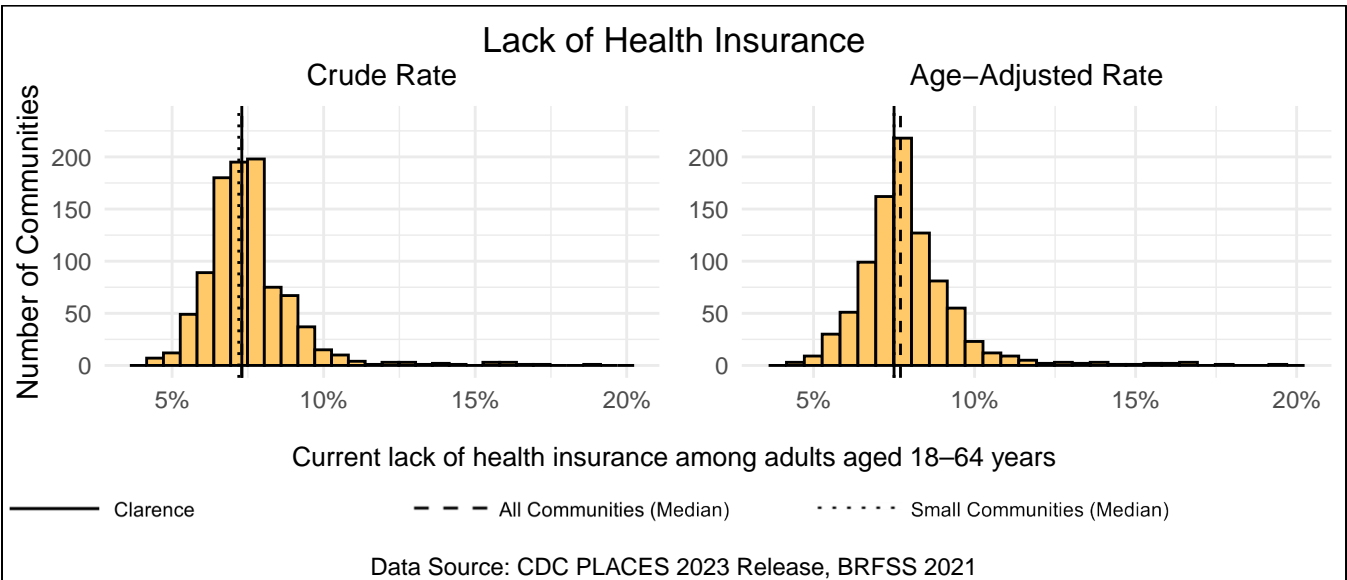

Clarence has a crude rate of 7.3% for current lack of health insurance among adults aged 18–64 years, which ranks 456th out of 958 Iowa communities (73rd out of 138 small communities). The age-adjusted rate for Clarence is 7.5%, which ranks 355th out of 905 Iowa communities (67th out of 138 small communities).

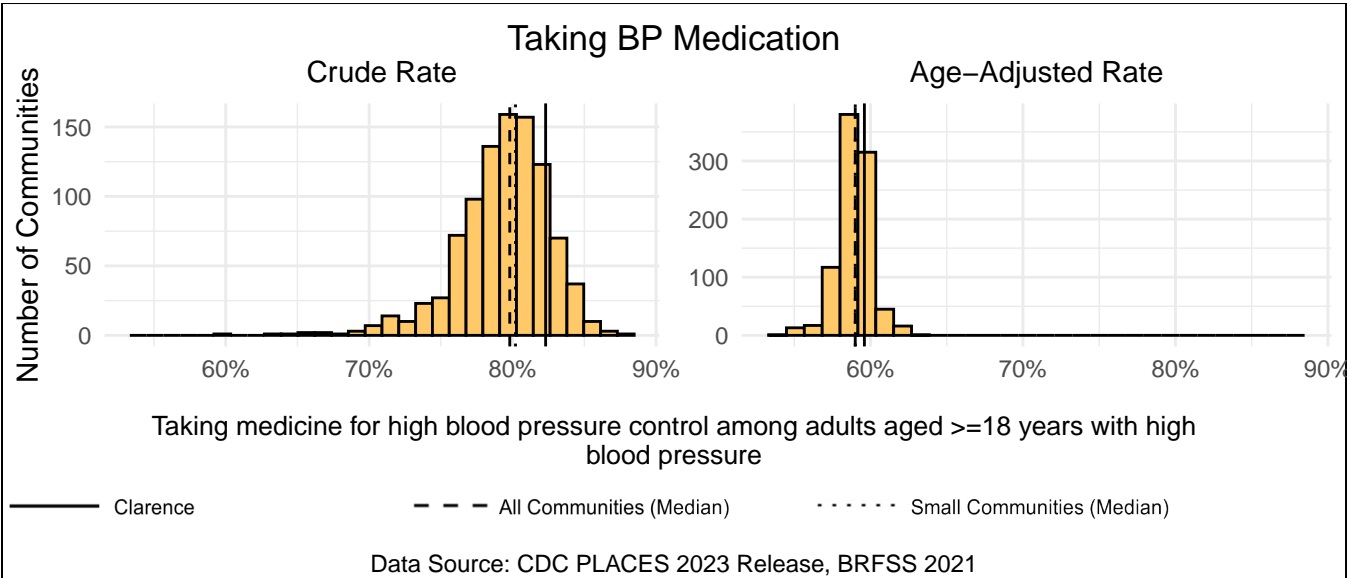

Taking BP Medication

Clarence has a crude rate of 82.3% for taking medicine for high blood pressure control among adults aged ≥ 18 years with high blood pressure, which ranks 140th out of 958 Iowa communities (26th out of 138 small communities). The age-adjusted rate for Clarence is 59.6%, which ranks 179th out of 905 Iowa communities (22nd out of 138 small communities).

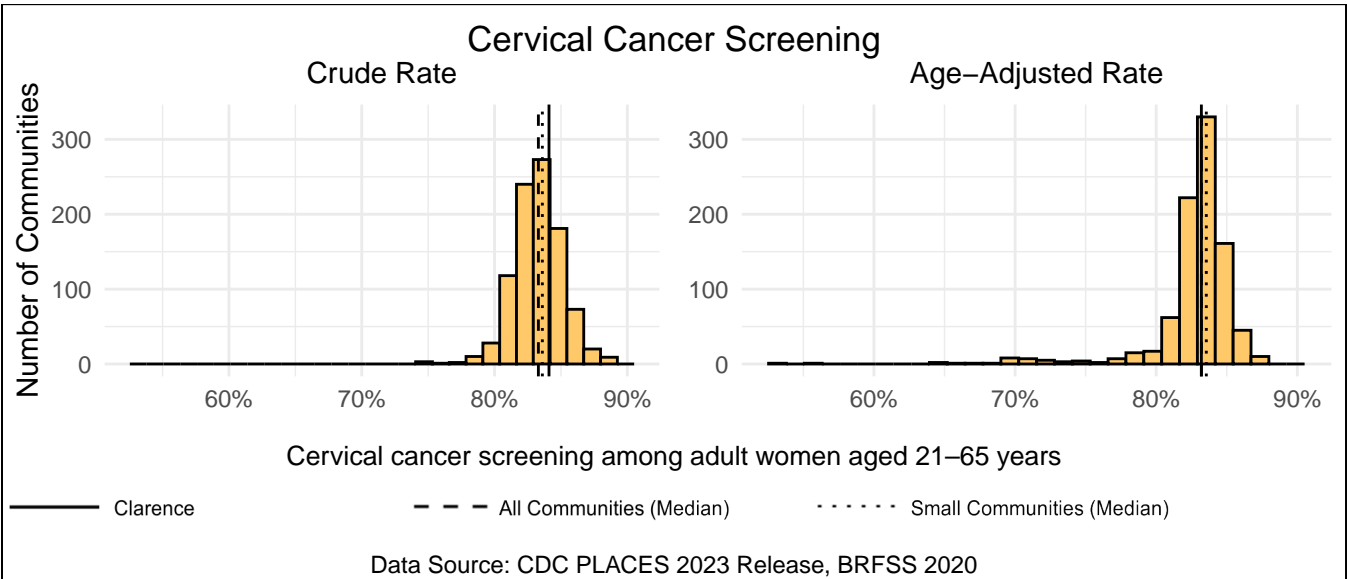

Clarence has a crude rate of 84.1% for cervical cancer screening among adult women aged 21–65 years, which ranks 284th out of 958 Iowa communities (49th out of 138 small communities). The age-adjusted rate for Clarence is 83.2%, which ranks 442nd out of 905 Iowa communities (83rd out of 138 small communities).

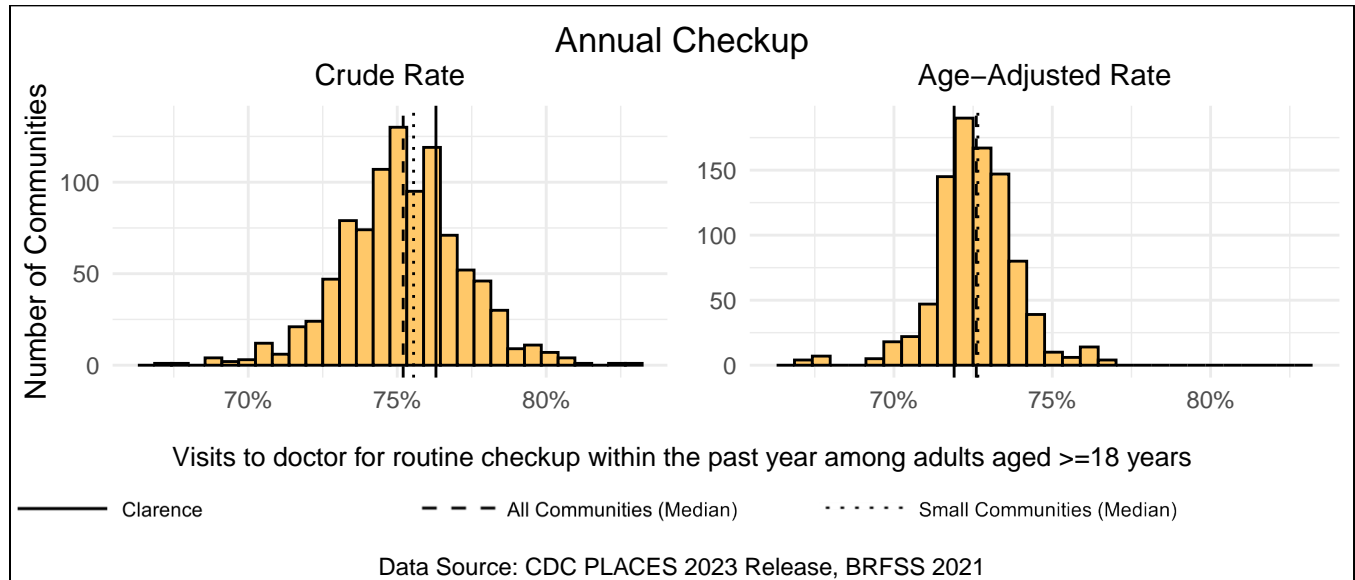

Clarence has a crude rate of 76.3% for visits to doctor for routine checkup within the past year among adults aged ≥ 18 years, which ranks 256th out of 958 Iowa communities (50th out of 138 small communities). The age-adjusted rate for Clarence is 71.9%, which ranks 658th out of 905 Iowa communities (110th out of 138 small communities).

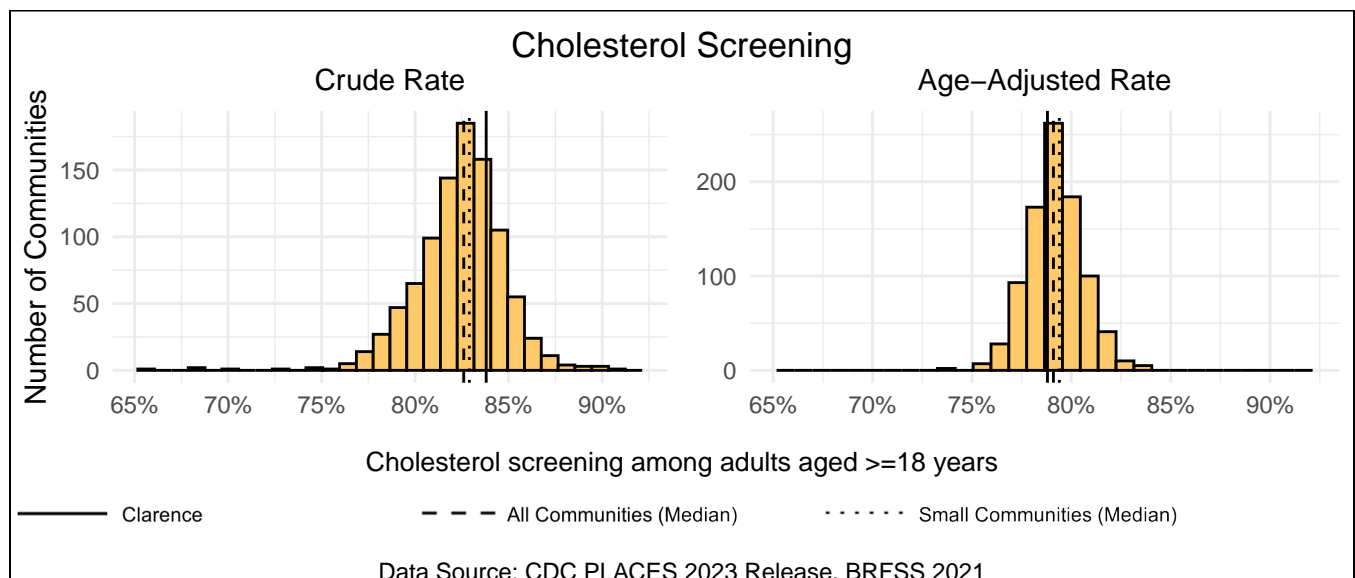

Clarence has a crude rate of 83.8% for cholesterol screening among adults aged ≥ 18 years, which ranks 240th out of 958 Iowa communities (40th out of 138 small communities). The age-adjusted rate for Clarence is 78.8%, which ranks 536th out of 905 Iowa communities (88th out of 138 small communities).

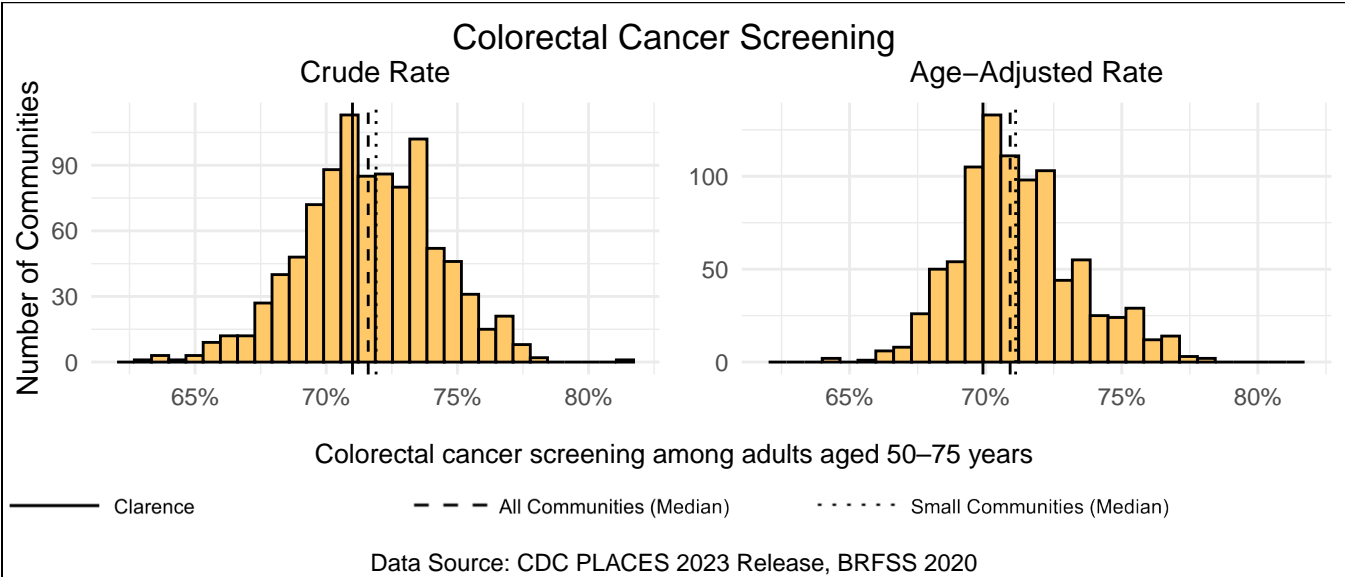

Colorectal Cancer Screening

Clarence has a crude rate of 71.0% for colorectal cancer screening among adults aged 50–75 years, which ranks 571st out of 958 Iowa communities (98th out of 138 small communities). The age-adjusted rate for Clarence is 69.9%, which ranks 654th out of 905 Iowa communities (114th out of 138 small communities).

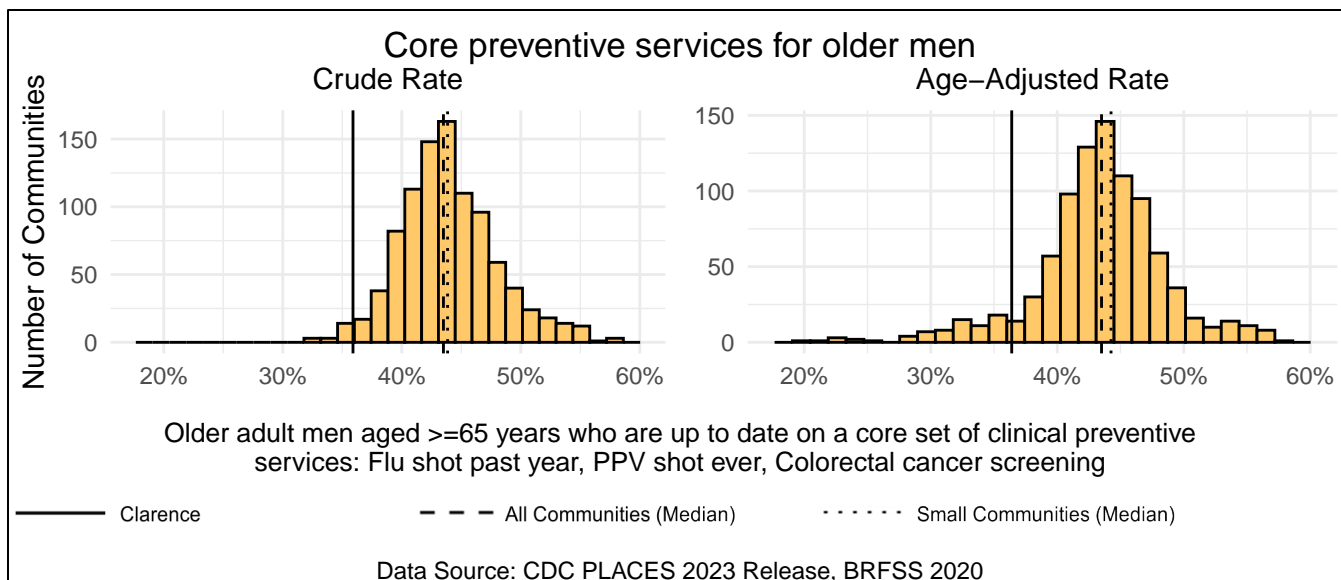

Core preventive services for older men

Clarence has a crude rate of 35.9% for older adult men aged ≥65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 943rd out of 958 Iowa communities (138th out of 138 small communities). The age-adjusted rate for Clarence is 36.4%, which ranks 832nd out of 905 Iowa communities (138th out of 138 small communities).

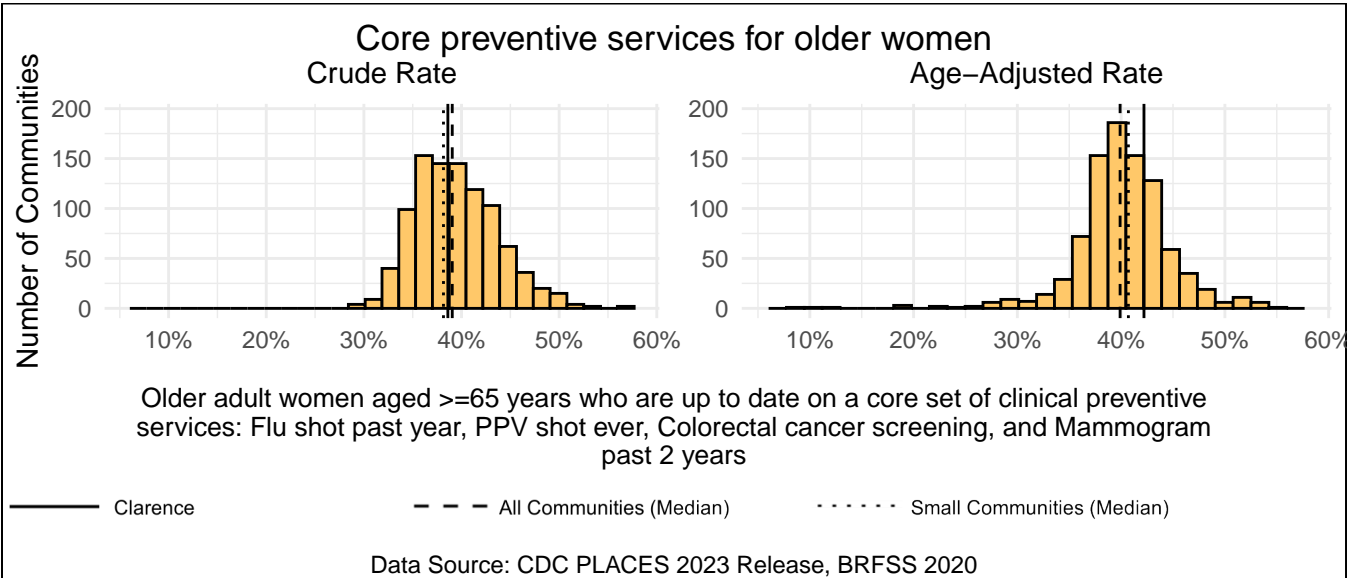

Core preventive services for older women

Clarence has a crude rate of 38.6% for older adult women aged ≥ 65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 519th out of 958 Iowa communities (66th out of 138 small communities). The age-adjusted rate for Clarence is 42.2%, which ranks 258th out of 905 Iowa communities (52nd out of 138 small communities).

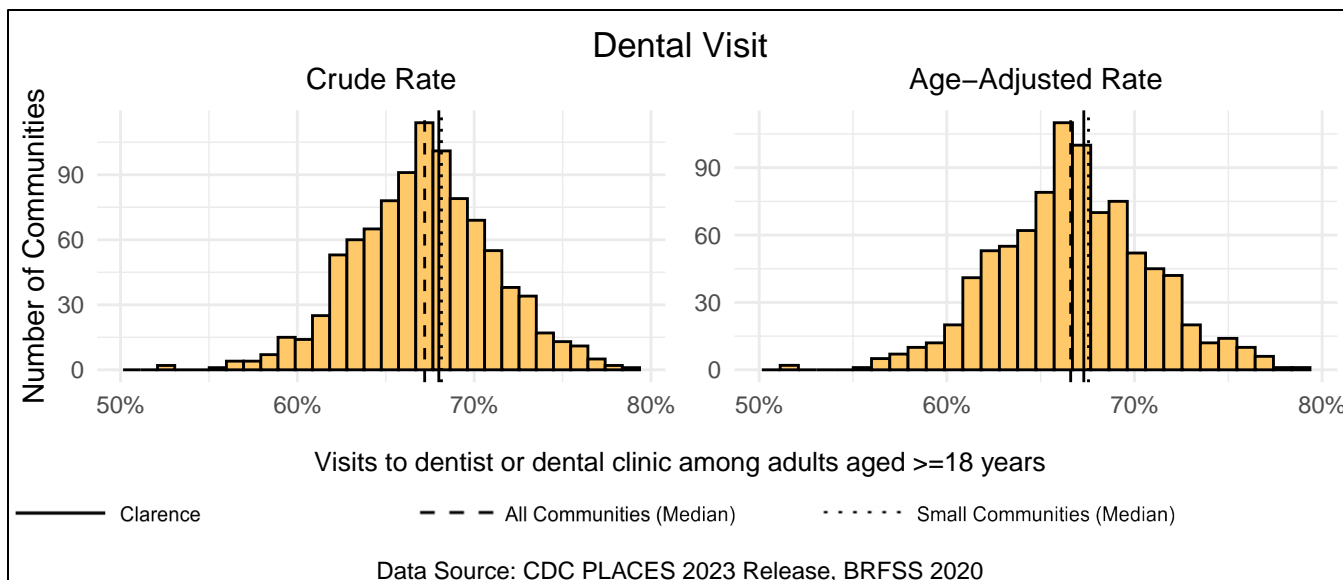

Clarence has a crude rate of 68.0% for visits to dentist or dental clinic among adults aged ≥ 18 years, which ranks 390th out of 958 Iowa communities (73rd out of 138 small communities). The age-adjusted rate for Clarence is 67.3%, which ranks 377th out of 905 Iowa communities (74th out of 138 small communities).

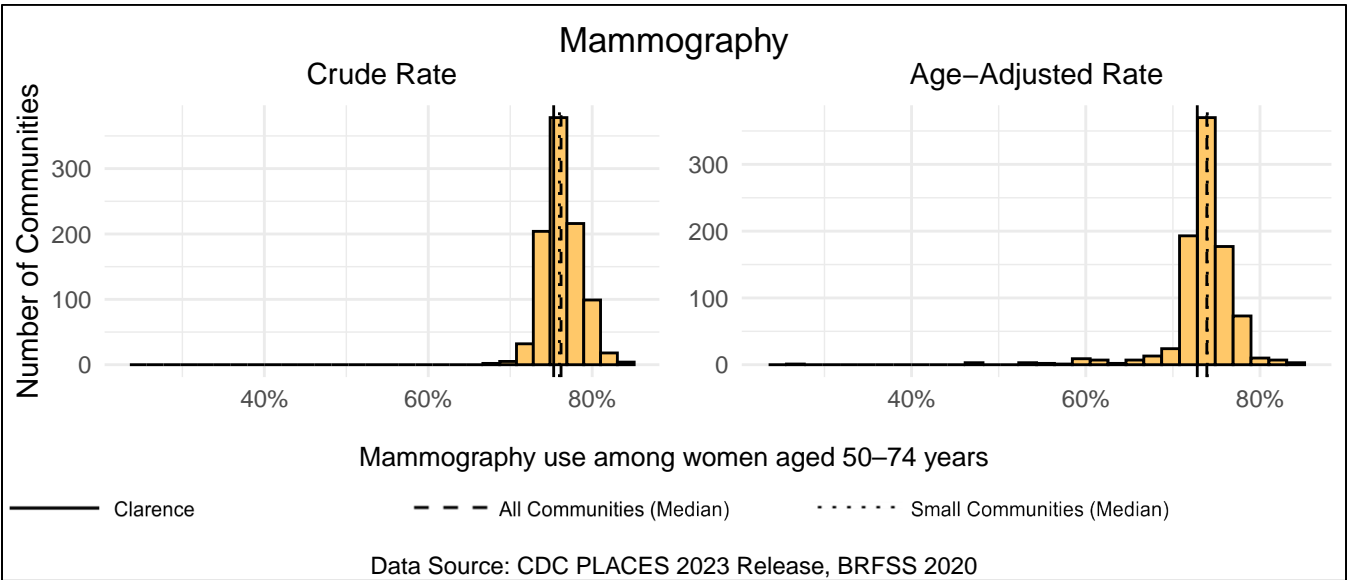

Clarence has a crude rate of 75.3% for mammography use among women aged 50–74 years, which ranks 642nd out of 958 Iowa communities (88th out of 138 small communities). The age-adjusted rate for Clarence is 72.8%, which ranks 641st out of 905 Iowa communities (97th out of 138 small communities).

Disability

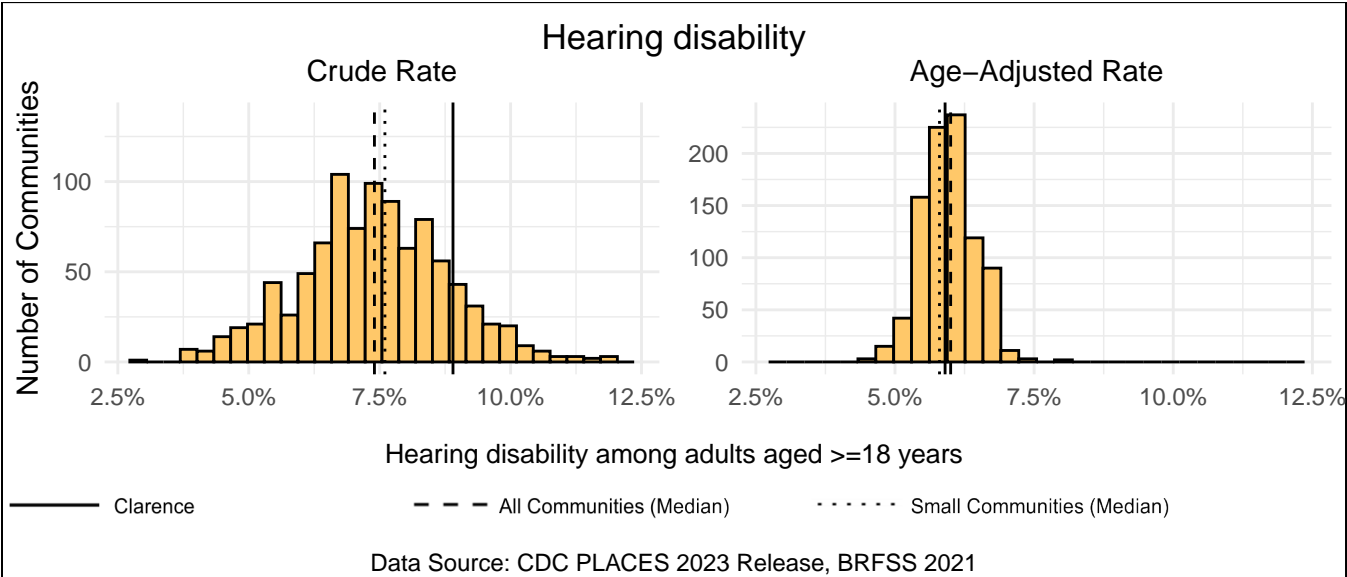

Clarence has a crude rate of 8.9% for hearing disability among adults aged ≥ 18 years, which ranks 818th out of 958 Iowa communities (109th out of 138 small communities). The age-adjusted rate for Clarence is 5.9%, which ranks 360th out of 905 Iowa communities (73rd out of 138 small communities).

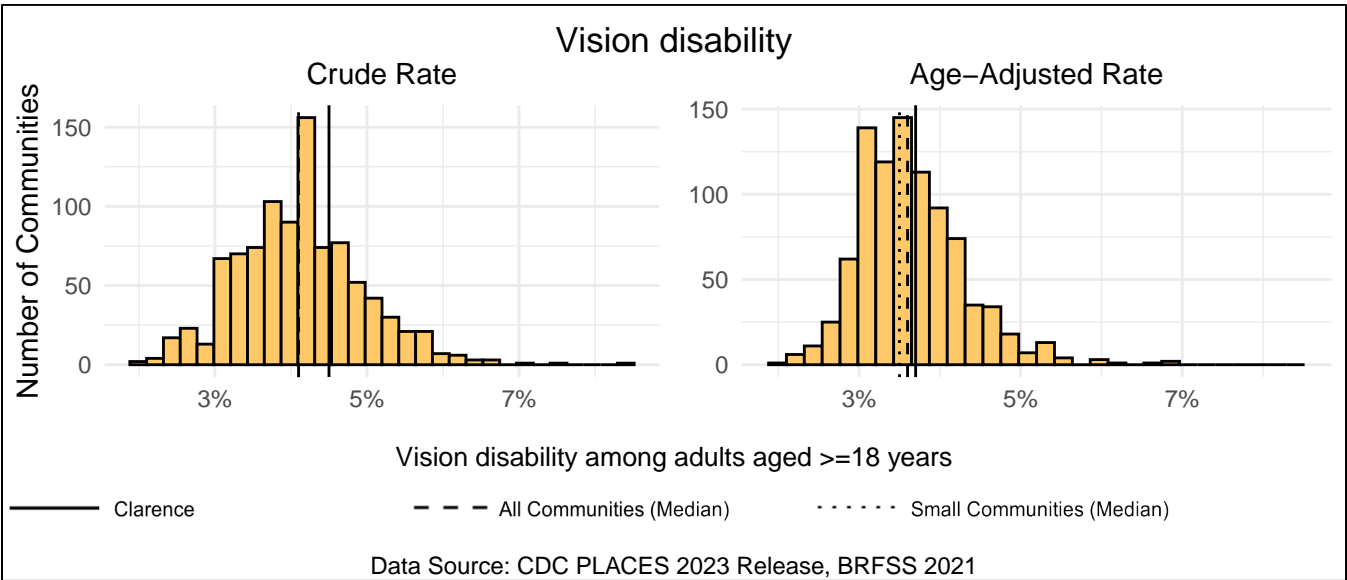

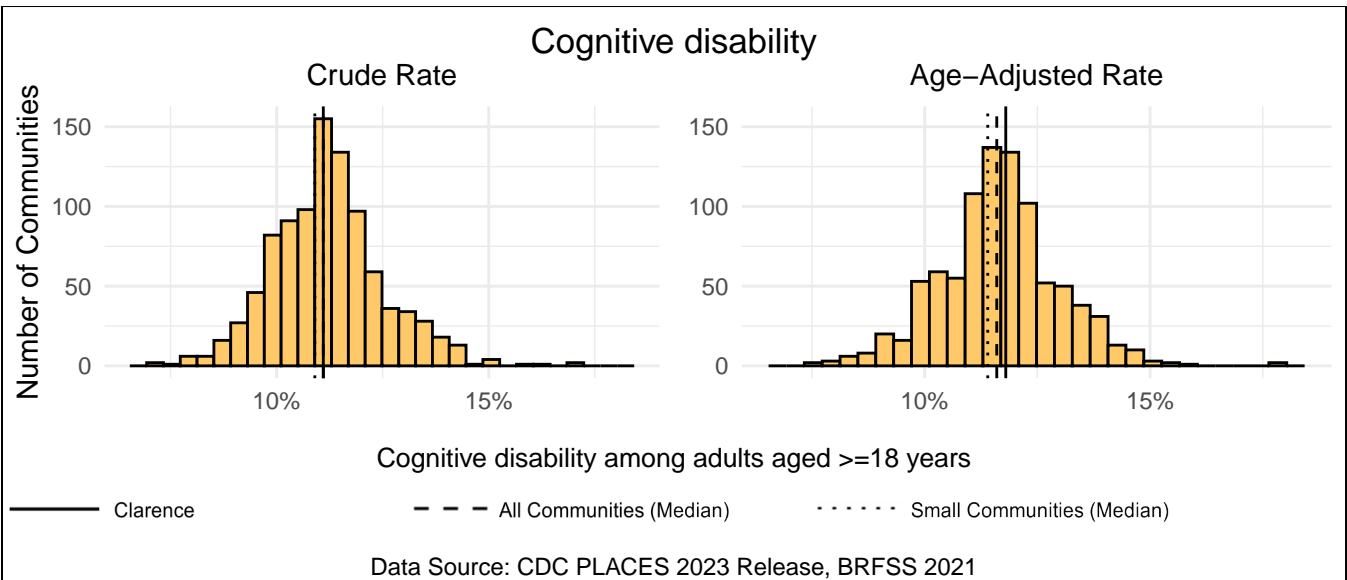

The age-adjusted rate for Clarence is 11.8%, which ranks 495th out of 905 Iowa communities (82nd out of 138 small communities).

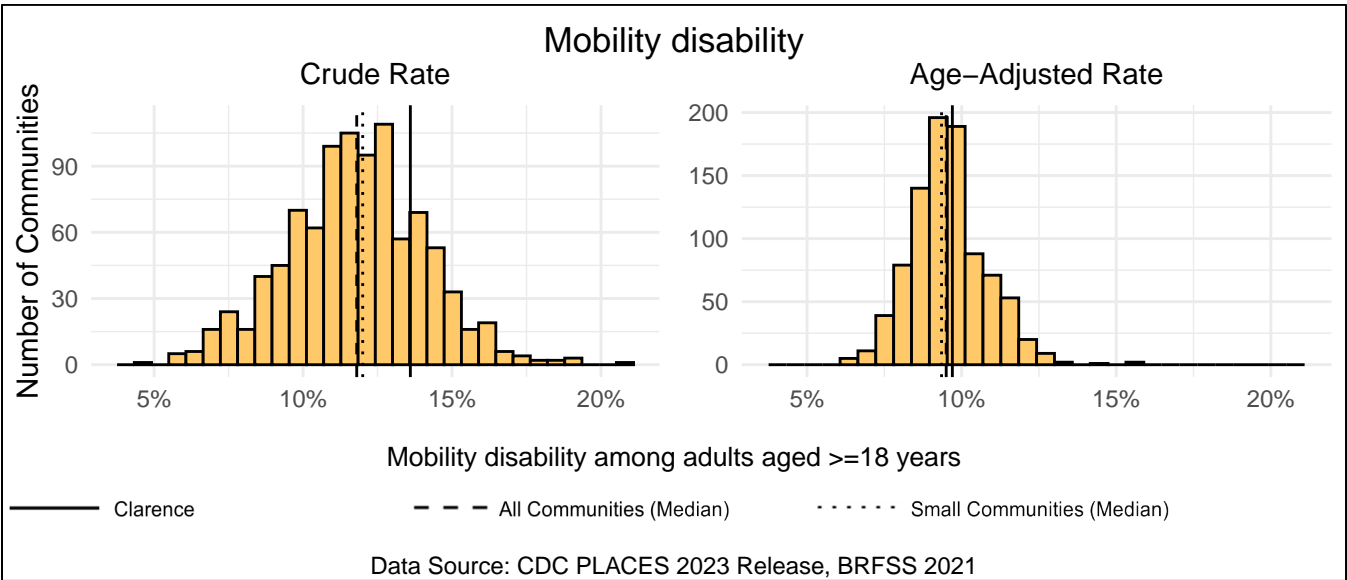

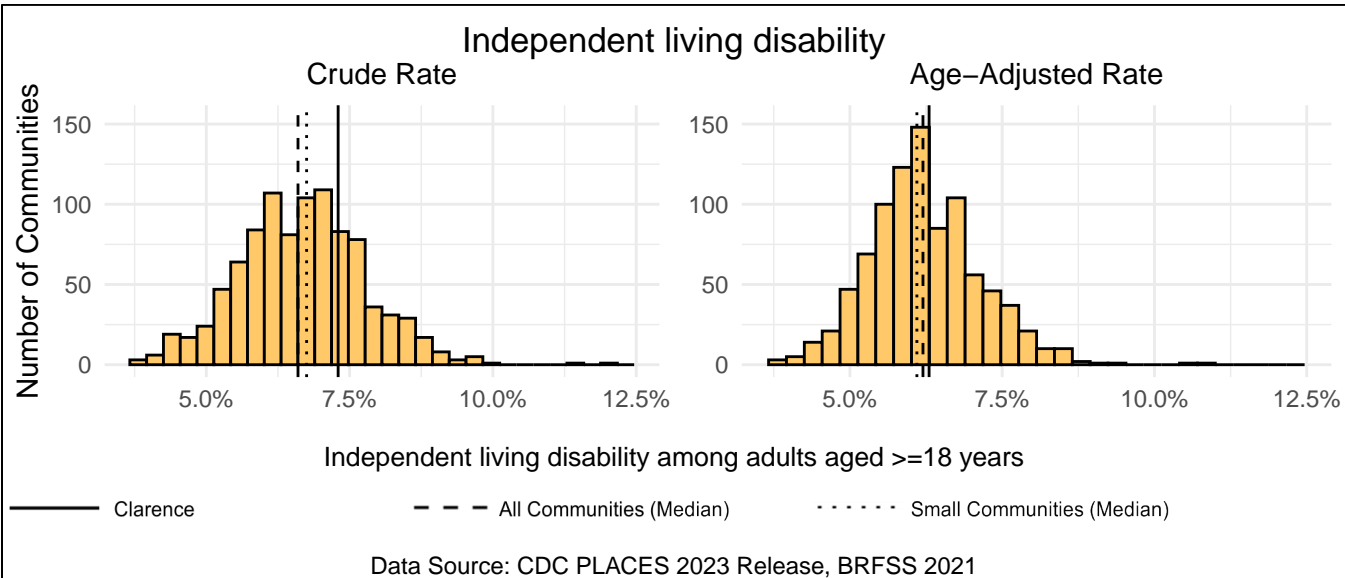

This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
