Health in Glenwood: Overview

Dear Community Members & Stakeholders of Glenwood,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partnership with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Glenwood ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Glenwood's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Glenwood. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community's strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

How to Use this Report

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Glenwood that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Glenwood, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Glenwood compares to the rest of the state and similarly-sized communities.

With a population of 5,128, Glenwood's similarly sized communities are defined as midsized communities. In lowa, midsized communities have an average population of 4,787, and there are 102 communities that are considered midsized communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, lowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

Health Status


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Glenwood has a crude rate of 14.1% for fair or poor selfrated health status among adults aged >= 18 years, which ranks 436th out of 958 lowa communities (46th out of 102 midsized communities). The age-adjusted rate for Glenwood is 13.2%, which ranks 552nd out of 905 lowa communities (53rd out of 102 midsized communities).



Poor Physical Health

Glenwood has a crude rate of 10.5% for physical health not good for >=14 days among adults aged >=18 years, which ranks 375th out of 958 lowa communities (45th out of 102 midsized communities). The age-adjusted rate for Glenwood is 10.0%, which ranks 559th out of 905 lowa communities (57th out of 102 midsized communities).



Poor Mental Health

Glenwood has a crude rate of 15.1% for mental health not good for >=14 days among adults aged >=18 years, which ranks 736th out of 958 lowa communities (70th out of 102 midsized communities). The age-adjusted rate for Glenwood is 15.6%, which ranks 457th out of 905 lowa communities (53rd out of 102 midsized communities).

Health Risk Behaviors


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Glenwood has a crude rate of 21.2% for binge drinking among adults aged >=18 years, which ranks 758th out of 958 lowa communities (81st out of 102 midsized communities). The age-adjusted rate for Glenwood is 22.4%, which ranks 585th out of 905 lowa communities (69th out of 102 midsized communities).



Current Smoking

Glenwood has a crude rate of 17.9% for current smoking among adults aged >=18 years, which ranks 679th out of 958 lowa communities (80th out of 102 midsized communities). The age-adjusted rate for Glenwood is 18.1%, which ranks 553rd out of 905 lowa communities (62nd out of 102 midsized communities).



Physical Inactivity

Glenwood has a crude rate of 25.8% for no leisure-time physical activity among adults aged >=18 years, which ranks 429th out of 958 lowa communities (43rd out of 102 midsized communities). The age-adjusted rate for Glenwood is 24.9%, which ranks 541st out of 905 lowa communities (56th out of 102 midsized communities).



Sleep <7 hours

Glenwood has a crude rate of 32.9% for sleeping less than 7 hours among adults aged >=18 years, which ranks 915th out of 958 lowa communities (95th out of 102 mid-sized communities). The age-adjusted rate for Glenwood is 33.1%, which ranks 840th out of 905 lowa communities (90th out of 102 midsized communities).

Health Outcomes



Arthritis

Glenwood has a crude rate of 25.1% for arthritis among adults aged >=18 years, which ranks 209th out of 958 lowa communities (31st out of 102 midsized communities). The age-adjusted rate for Glenwood is 22.8%, which ranks 347th out of 905 lowa communities (43rd out of 102 midsized communities).



High Blood Pressure

Glenwood has a crude rate of 29.2% for high blood pressure among adults aged >=18 years, which ranks 197th out of 958 lowa communities (30th out of 102 midsized communities). The age-adjusted rate for Glenwood is 26.8%, which ranks 319th out of 905 lowa communities (37th out of 102 midsized communities).



Cancer (except skin)

Glenwood has a crude rate of 7.2% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 223rd out of 958 lowa communities (30th out of 102 mid-sized communities). The age-adjusted rate for Glenwood is 6.4%, which ranks 74th out of 905 lowa communities (11th out of 102 midsized communities).



Current Asthma

Glenwood has a crude rate of 9.6% for current asthma among adults aged >=18 years, which ranks 716th out of 958 lowa communities (69th out of 102 midsized communities). The age-adjusted rate for Glenwood is 9.6%, which ranks 513th out of 905 lowa communities (48th out of 102 midsized communities).



Glenwood has a crude rate of 5.8% for coronary heart disease among adults aged >=18 years, which ranks 268th out of 958 lowa communities (30th out of 102 midsized communities). The age-adjusted rate for Glenwood is 5.1%, which ranks 511th out of 905 lowa communities (59th out of 102 midsized communities).



The age-adjusted rate for Glenwood is 6.5%, which ranks 571st out of 905 lowa communities (62nd out of 102 midsized communities).





Glenwood has a crude rate of 9.4% for diagnosed diabetes among adults aged >=18 years, which ranks 303rd out of 958 lowa communities (41st out of 102 midsized communities). The age-adjusted rate for Glenwood is 8.5%, which ranks 617th out of 905 lowa communities (60th out of 102 midsized communities).



Glenwood has a crude rate of 34.9% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 281st out of 958 lowa communities (38th out of 102 midsized communities). The age-adjusted rate for Glenwood is 30.3%, which ranks 634th out of 905 lowa communities (69th out of 102 midsized communities).



The age-adjusted rate for Glenwood is 2.6%, which ranks 349th out of 905 lowa communities (41st out of 102 midsized communities).





Glenwood has a crude rate of 7.8% for current lack of health insurance among adults aged 18–64 years, which ranks 633rd out of 958 lowa communities (56th out of 102 midsized communities). The age-adjusted rate for Glenwood is 8.1%, which ranks 573rd out of 905 lowa communities (53rd out of 102 midsized communities).



Glenwood has a crude rate of 77.8% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 710th out of 958 lowa communities (66th out of 102 midsized communities). The age-adjusted rate for Glenwood is 59.0%, which ranks 415th out of 905 lowa communities (50th out of 102 midsized communities).



The age-adjusted rate for Glenwood is 83.7%, which ranks 294th out of 905 lowa communities (41st out of 102 midsized communities).



Glenwood has a crude rate of 73.2% for visits to doctor for routine checkup within the past year among adults aged >=18 years, which ranks 812th out of 958 lowa communities (84th out of 102 midsized communities). The age-adjusted rate for Glenwood is 71.8%, which ranks 686th out of 905 lowa communities (82nd out of 102 midsized communities).



Glenwood has a crude rate of 80.7% for cholesterol screening among adults aged >=18 years, which ranks 760th out of 958 lowa communities (69th out of 102 mid-sized communities). The age-adjusted rate for Glenwood is 78.9%, which ranks 501st out of 905 lowa communities (56th out of 102 midsized communities).



The age-adjusted rate for Glenwood is 71.1%, which ranks 417th out of 905 lowa communities (50th out of 102 midsized communities).



Glenwood has a crude rate of 41.3% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 714th out of 958 lowa communities (67th out of 102 midsized communities). The age-adjusted rate for Glenwood is 41.8%, which ranks 615th out of 905 lowa communities (64th out of 102 midsized communities).



Core preventive services for older women

Glenwood has a crude rate of 38.8% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 492nd out of 958 lowa communities (40th out of 102 midsized communities). The age-adjusted rate for Glenwood is 41.0%, which ranks 359th out of 905 lowa communities (42nd out of 102 midsized communities).



Glenwood has a crude rate of 66.6% for visits to dentist or dental clinic among adults aged >=18 years, which ranks 540th out of 958 lowa communities (56th out of 102 mid-sized communities). The age-adjusted rate for Glenwood is 66.5%, which ranks 468th out of 905 lowa communities (51st out of 102 midsized communities).



Glenwood has a crude rate of 77.3% for mammography use among women aged 50–74 years, which ranks 282nd out of 958 lowa communities (34th out of 102 midsized communities). The age-adjusted rate for Glenwood is 74.7%, which ranks 285th out of 905 lowa communities (42nd out of 102 midsized communities).

Disability



Hearing disability

Glenwood has a crude rate of 6.7% for hearing disability among adults aged >=18 years, which ranks 282nd out of 958 lowa communities (29th out of 102 midsized communities). The age-adjusted rate for Glenwood is 6.0%, which ranks 444th out of 905 lowa communities (54th out of 102 midsized communities).



This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
