Health in Mount Pleasant: Overview

Dear Community Members & Stakeholders of Mount Pleasant,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partnership with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Mount Pleasant ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Mount Pleasant's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all Iowa communities and communities of similar size to Mount Pleasant. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community's strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

How to Use this Report

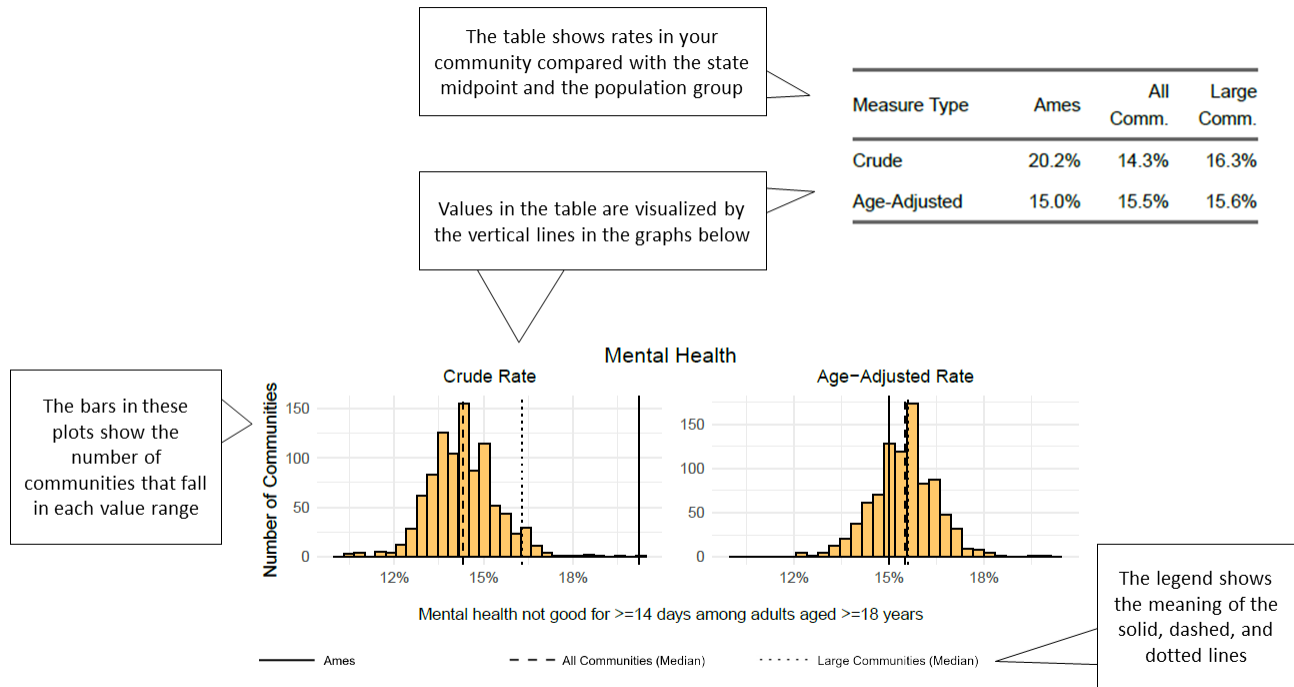
The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Mount Pleasant that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Mount Pleasant, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Mount Pleasant compares to the rest of the state and similarly-sized communities.

With a population of 9,214, Mount Pleasant’s similarly sized communities are defined as midsized communities. In Iowa, midsized communities have an average population of 4,787, and there are 102 communities that are considered midsized communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community’s crude and age-adjusted rate estimates alongside their averages across all Iowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all Iowa communities and the dotted lines showing the average rate for similarly-sized communities.



Health Status

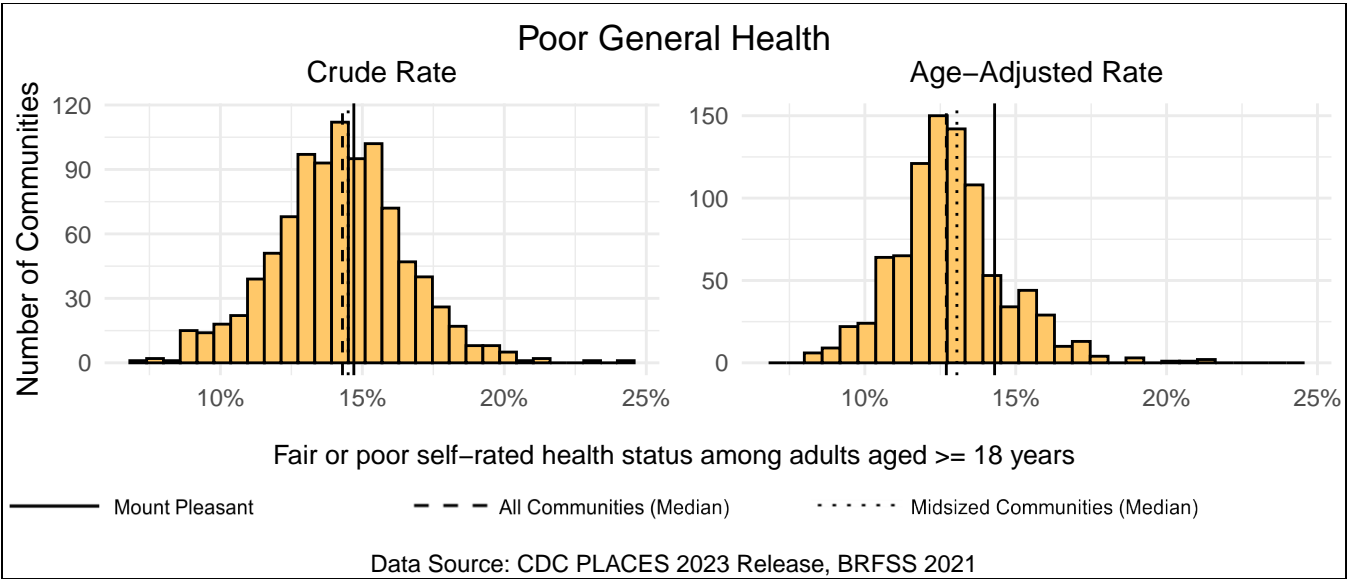
This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country’s population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of “excellent,” “very good,” “good,” “fair,” or “poor,” from which the respondents who answer “fair” or “poor” are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Mount Pleasant has a crude rate of 14.7% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 552nd out of 958 Iowa communities (55th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 14.3%, which ranks 744th out of 905 Iowa communities (71st out of 102 midsize communities).

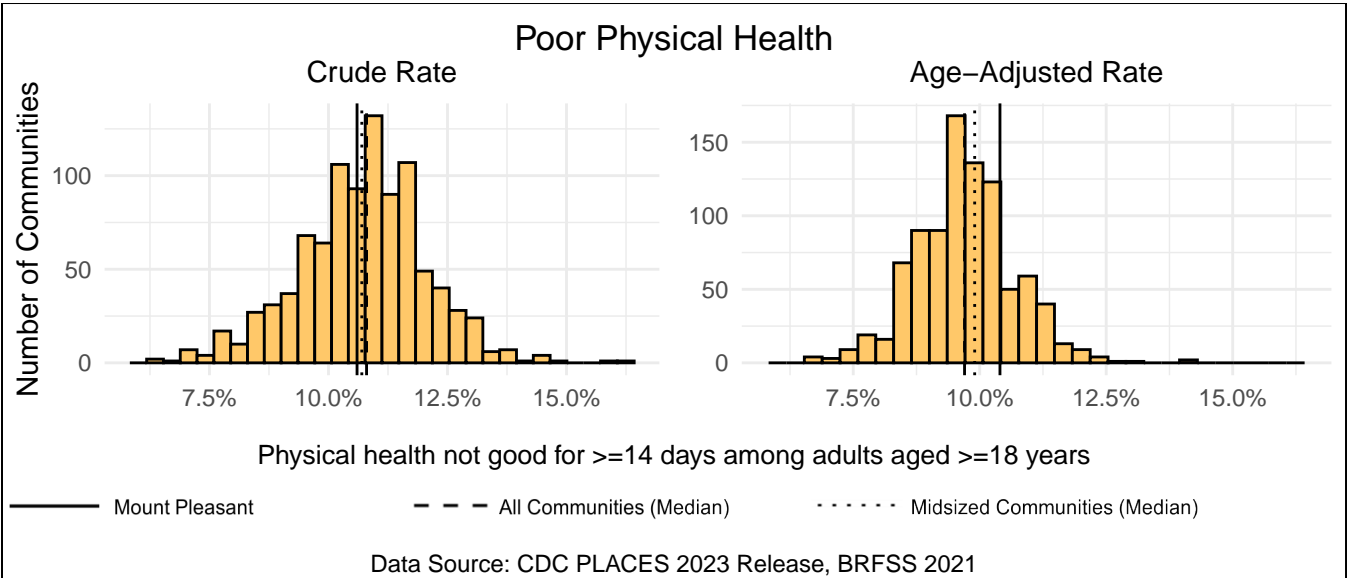

Poor Physical Health

Mount Pleasant has a crude rate of 10.6% for physical health not good for ≥ 14 days among adults aged ≥ 18 years, which ranks 404th out of 958 Iowa communities (46th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 10.4%, which ranks 707th out of 905 Iowa communities (69th out of 102 midsize communities).

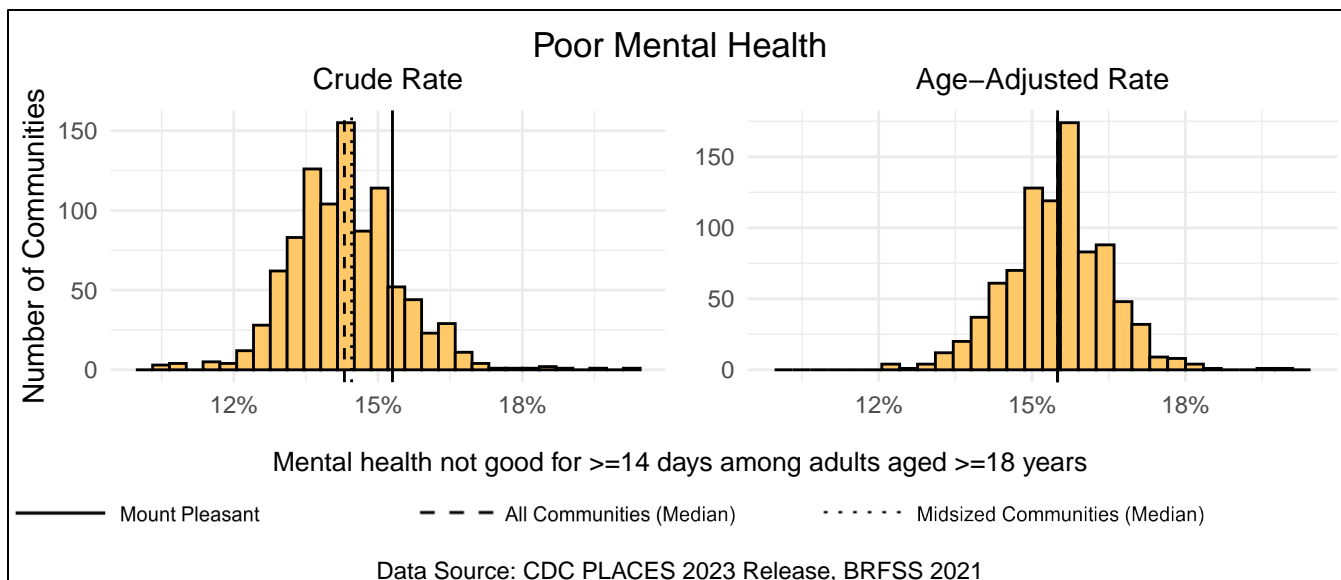

Poor Mental Health

Mount Pleasant has a crude rate of 15.3% for mental health not good for ≥ 14 days among adults aged ≥ 18 years, which ranks 788th out of 958 Iowa communities (76th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 15.5%, which ranks 405th out of 905 Iowa communities (49th out of 102 midsize communities).

Health Risk Behaviors

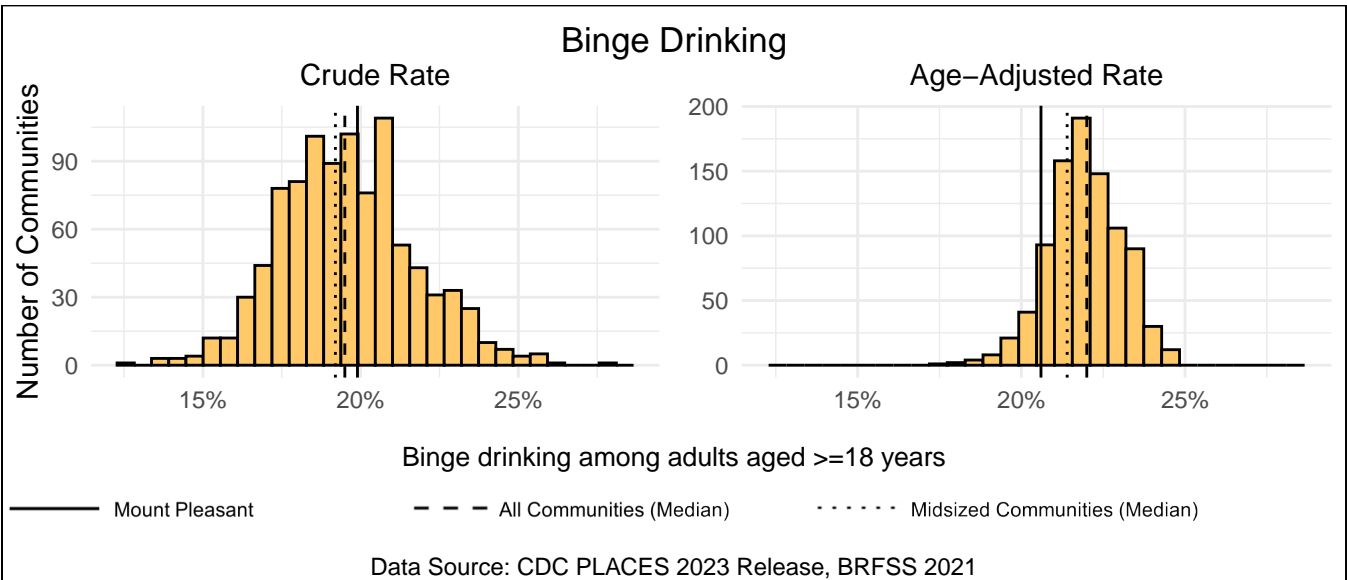
Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Mount Pleasant has a crude rate of 19.9% for binge drinking among adults aged ≥ 18 years, which ranks 549th out of 958 Iowa communities (63rd out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 20.6%, which ranks 95th out of 905 Iowa communities (24th out of 102 midsized communities).

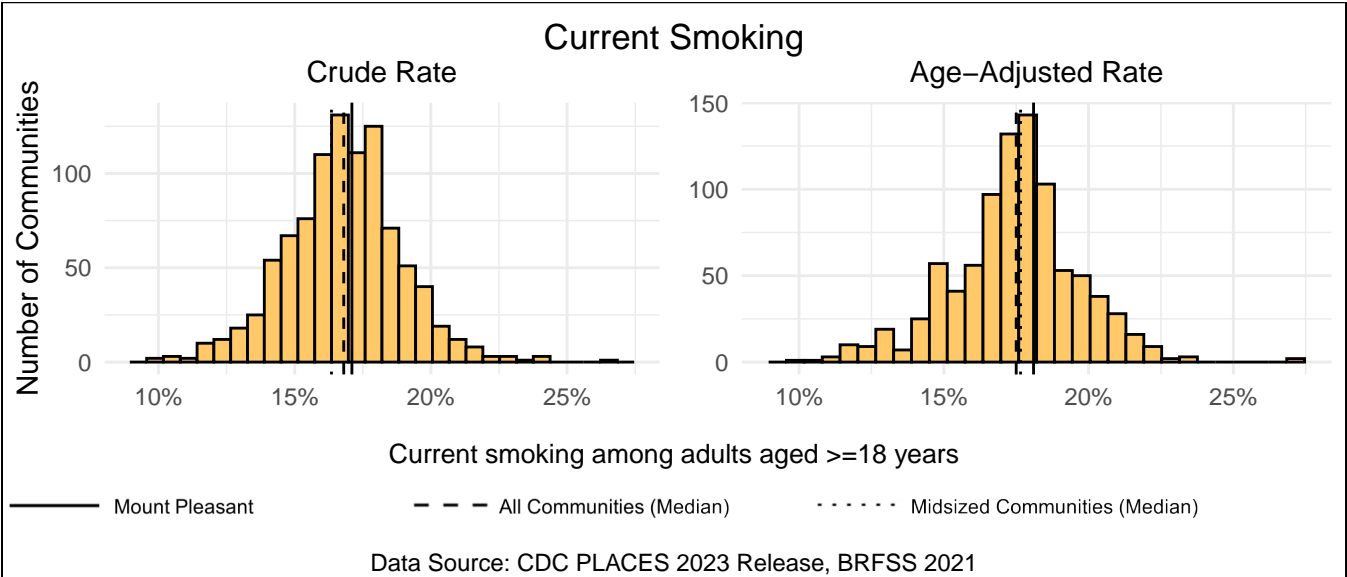

Current Smoking

Mount Pleasant has a crude rate of 17.1% for current smoking among adults aged ≥ 18 years, which ranks 539th out of 958 Iowa communities (66th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 18.1%, which ranks 553rd out of 905 Iowa communities (62nd out of 102 mid-sized communities).

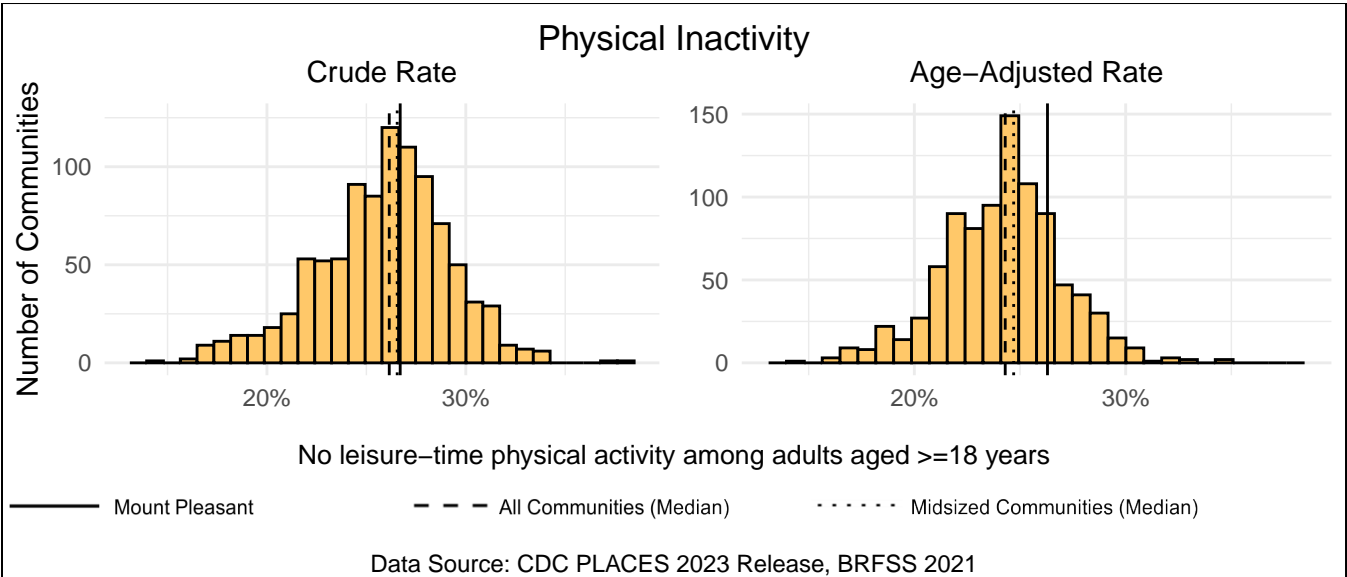

Physical Inactivity

Mount Pleasant has a crude rate of 26.7% for no leisure-time physical activity among adults aged ≥ 18 years, which ranks 549th out of 958 Iowa communities (54th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 26.3%, which ranks 726th out of 905 Iowa communities (70th out of 102 mid-sized communities).

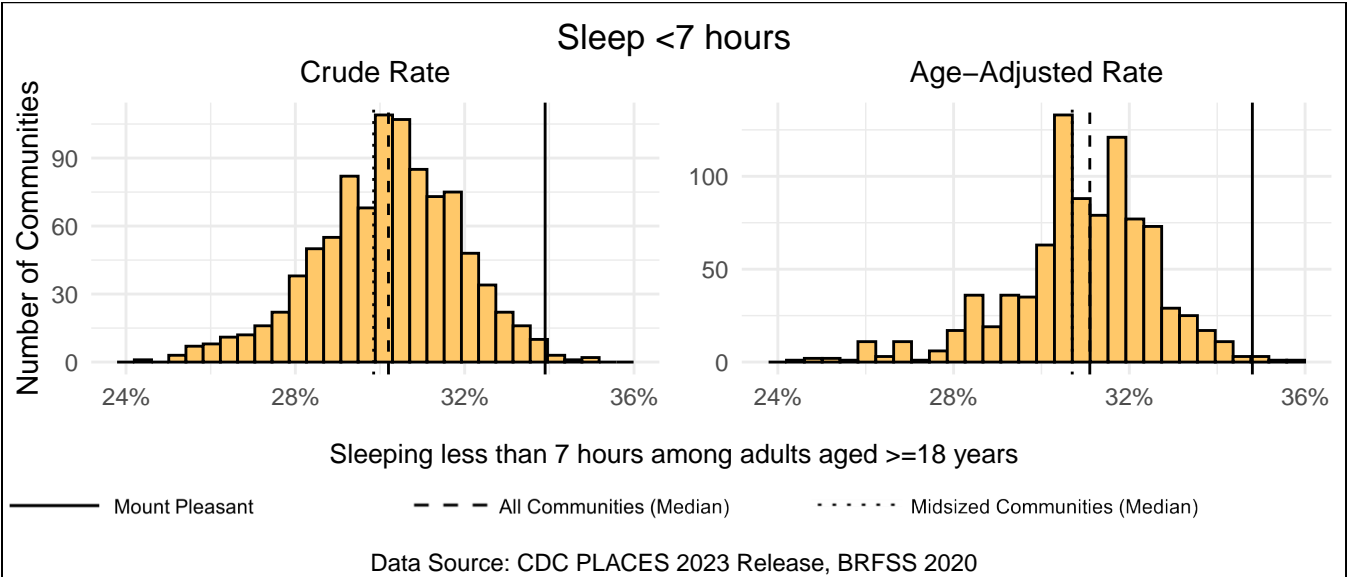

Sleep <7 hours

Mount Pleasant has a crude rate of 33.9% for sleeping less than 7 hours among adults aged ≥ 18 years, which ranks 951st out of 958 Iowa communities (101st out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 34.8%, which ranks 901st out of 905 Iowa communities (101st out of 102 midsized communities).

Health Outcomes

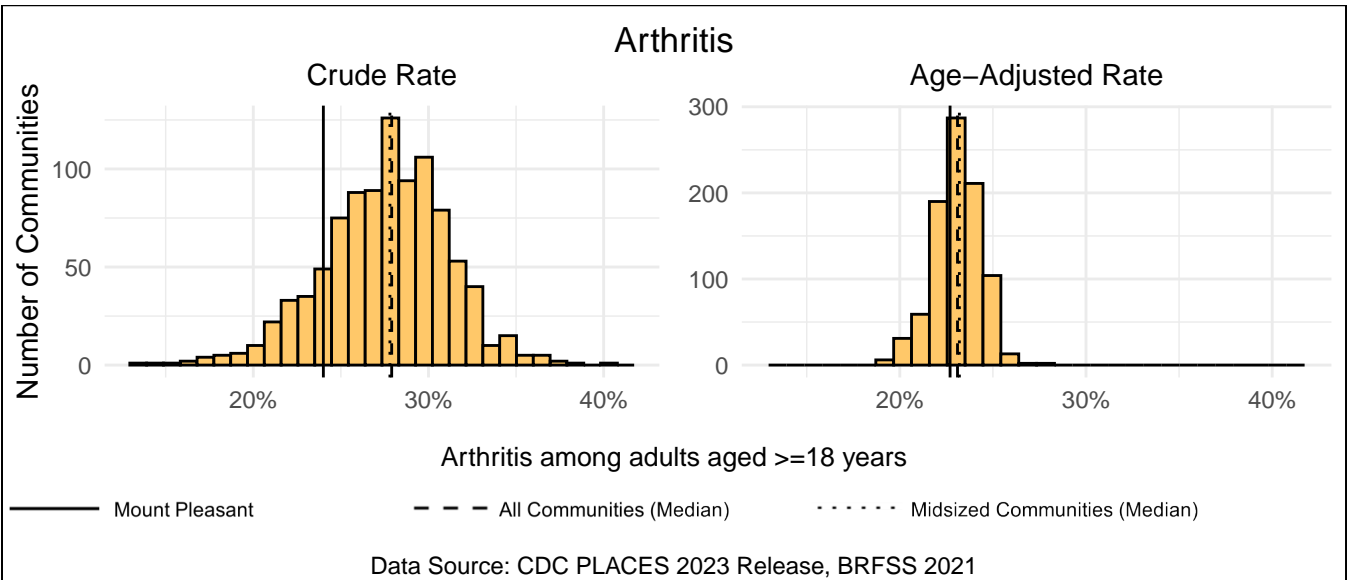
This section includes measures about specific health outcomes such as chronic illness, mental health conditions, and risk factors for future disease. Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. Arthritis

Mount Pleasant has a crude rate of 24.0% for arthritis among adults aged ≥ 18 years, which ranks 145th out of 958 Iowa communities (23rd out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 22.7%, which ranks 321st out of 905 Iowa communities (38th out of 102 midsized communities).

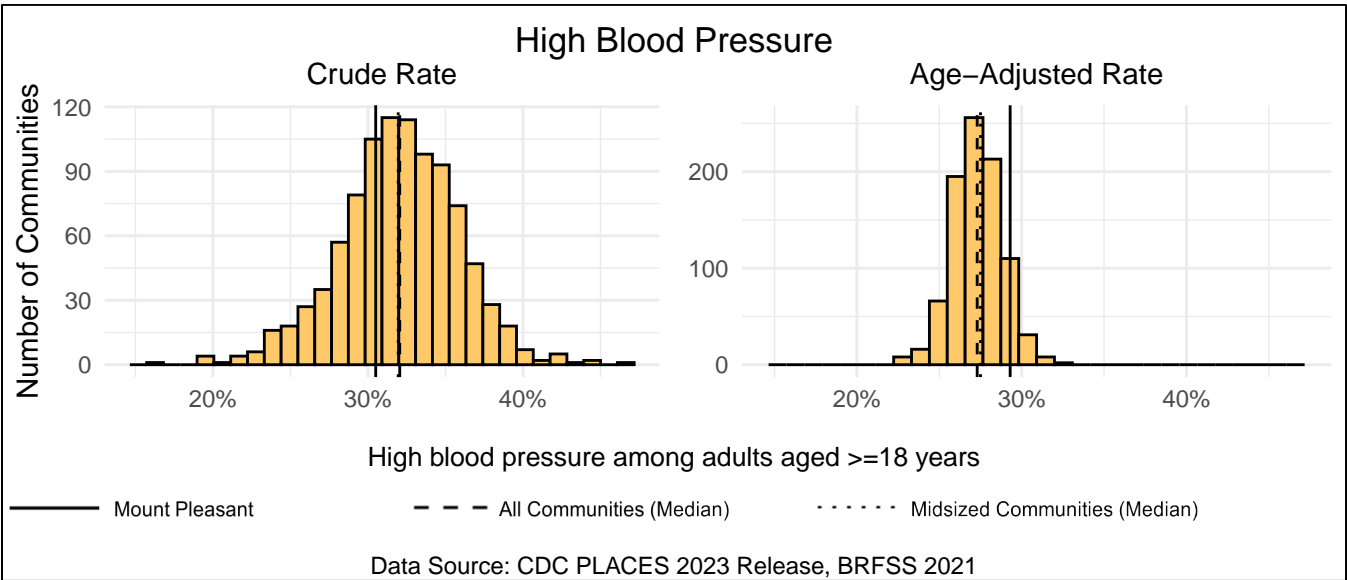

High Blood Pressure

Mount Pleasant has a crude rate of 30.5% for high blood pressure among adults aged ≥ 18 years, which ranks 308th out of 958 Iowa communities (37th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 29.3%, which ranks 808th out of 905 Iowa communities (83rd out of 102 mid-sized communities).

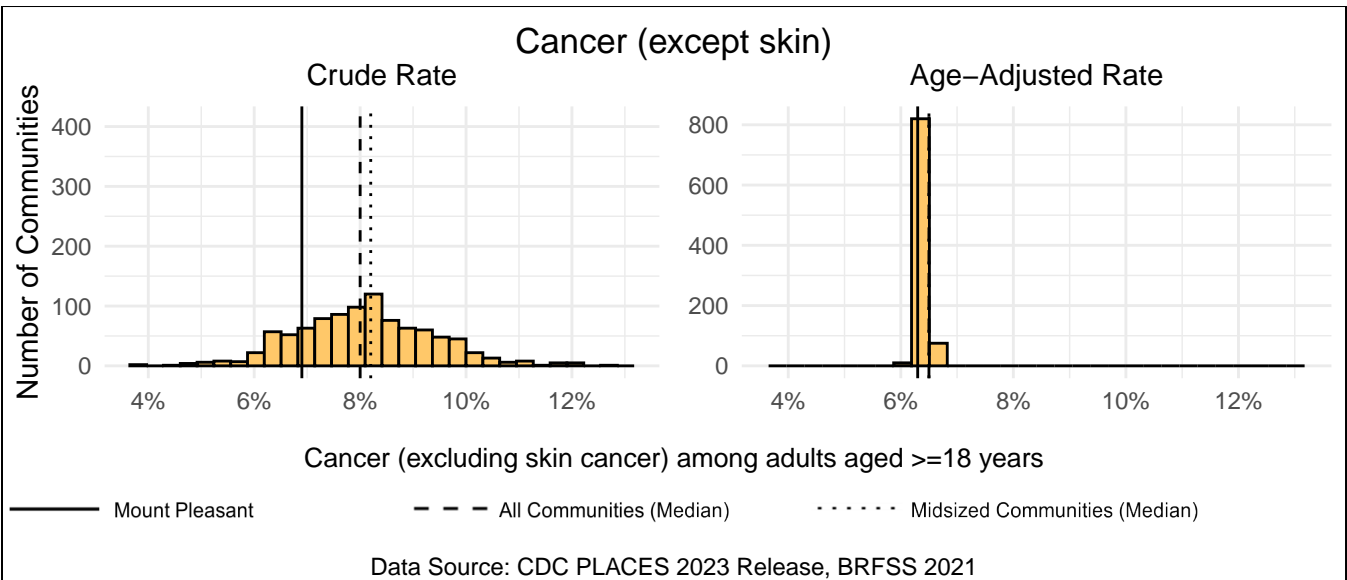

Cancer (except skin)

Mount Pleasant has a crude rate of 6.9% for cancer (excluding skin cancer) among adults aged ≥ 18 years, which ranks 160th out of 958 Iowa communities (22nd out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 6.3%, which ranks 16th out of 905 Iowa communities (6th out of 102 mid-sized communities).

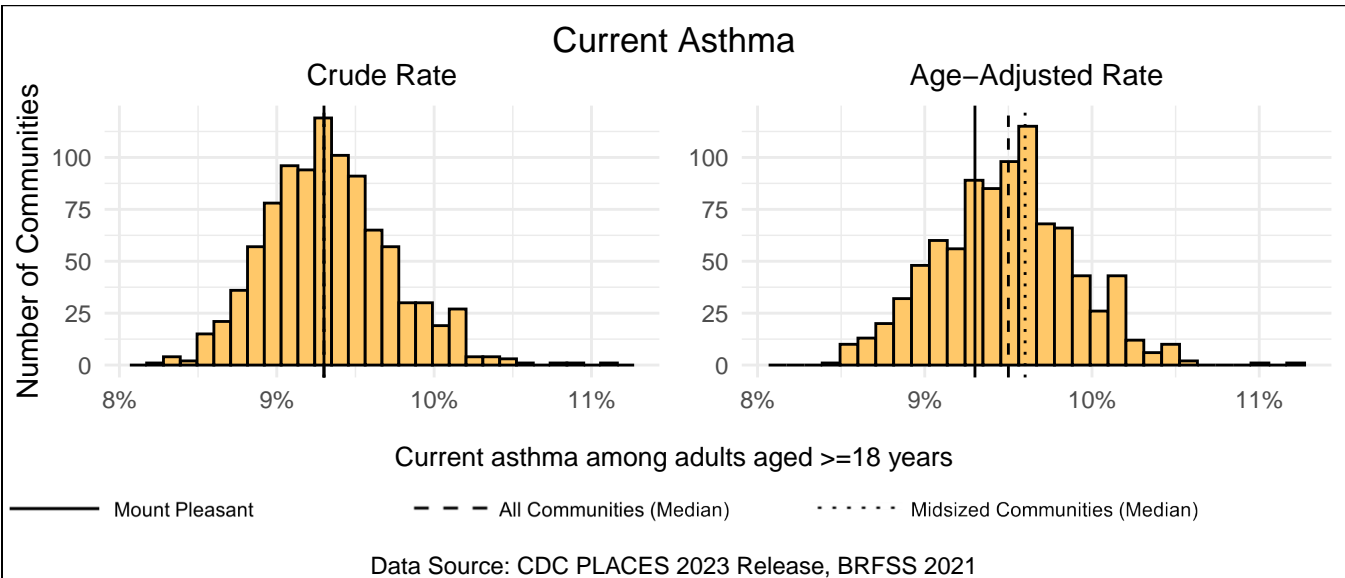

Current Asthma

Mount Pleasant has a crude rate of 9.3% for current asthma among adults aged ≥ 18 years, which ranks 405th out of 958 Iowa communities (36th out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 9.3%, which ranks 241st out of 905 Iowa communities (26th out of 102 midsized communities).

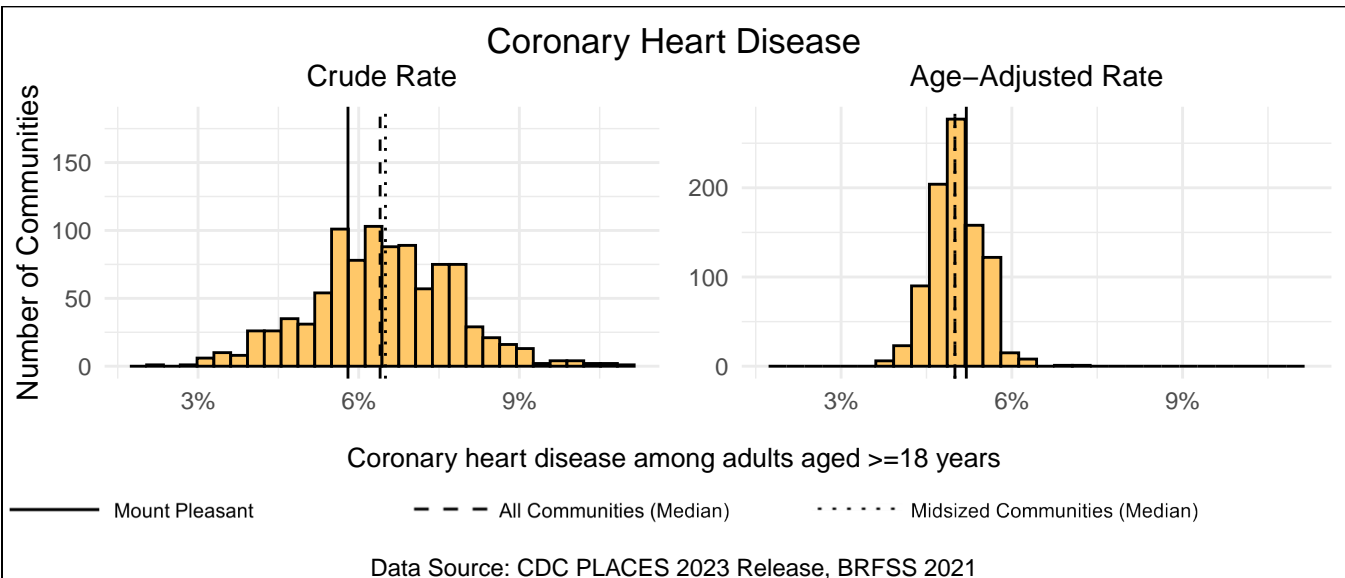

Coronary Heart Disease

Mount Pleasant has a crude rate of 5.8% for coronary heart disease among adults aged ≥ 18 years, which ranks 268th out of 958 Iowa communities (30th out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 5.2%, which ranks 601st out of 905 Iowa communities (63rd out of 102 midsized communities).

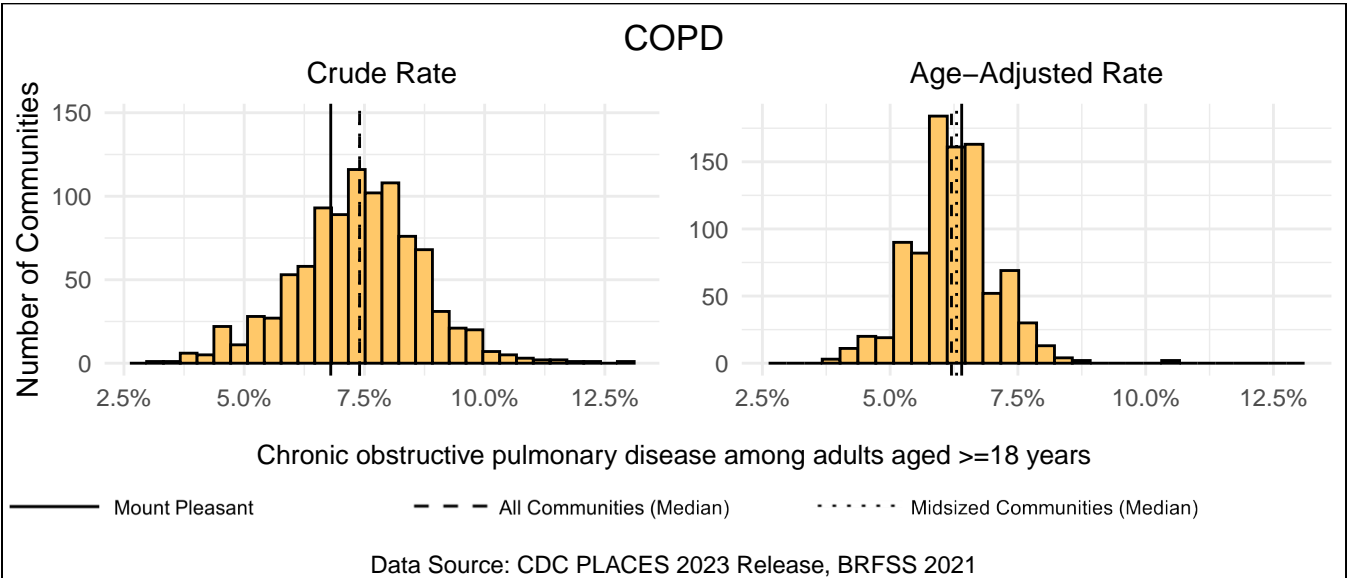

Mount Pleasant has a crude rate of 6.8% for chronic obstructive pulmonary disease among adults aged ≥ 18 years, which ranks 274th out of 958 Iowa communities (37th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 6.4%, which ranks 513th out of 905 Iowa communities (53rd out of 102 midsize communities).

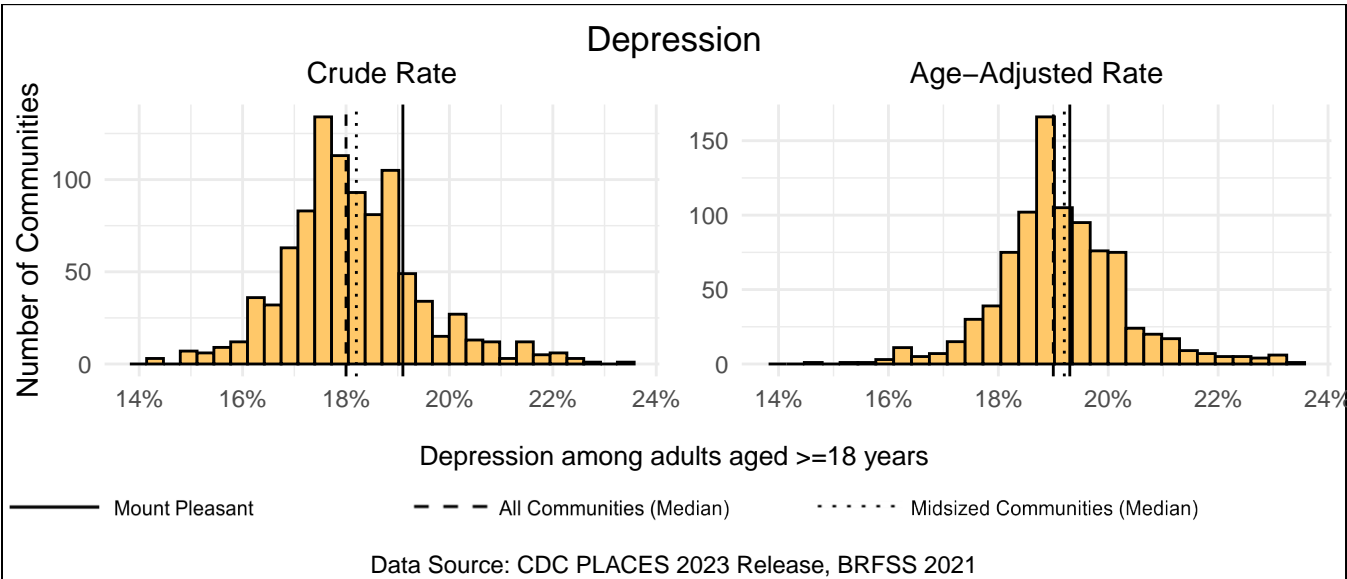

Mount Pleasant has a crude rate of 19.1% for depression among adults aged ≥ 18 years, which ranks 778th out of 958 Iowa communities (78th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 19.3%, which ranks 527th out of 905 Iowa communities (54th out of 102 midsize communities).

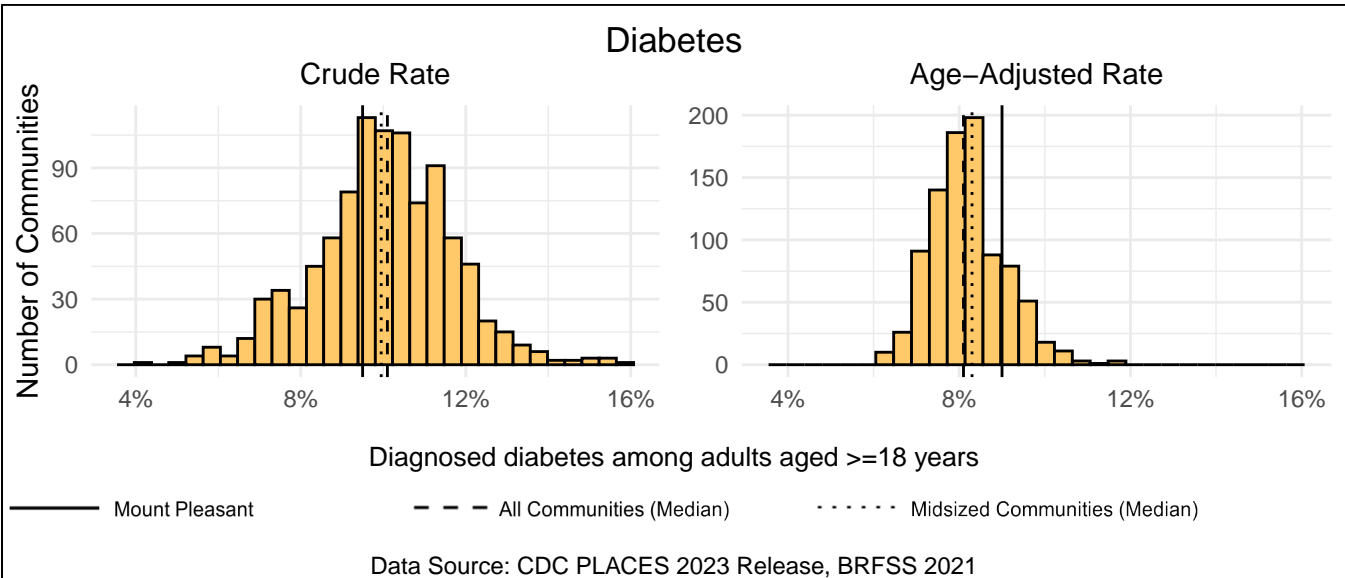

Diabetes

Mount Pleasant has a crude rate of 9.5% for diagnosed diabetes among adults aged ≥ 18 years, which ranks 327th out of 958 Iowa communities (42nd out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 9.0%, which ranks 740th out of 905 Iowa communities (73rd out of 102 midsized communities).

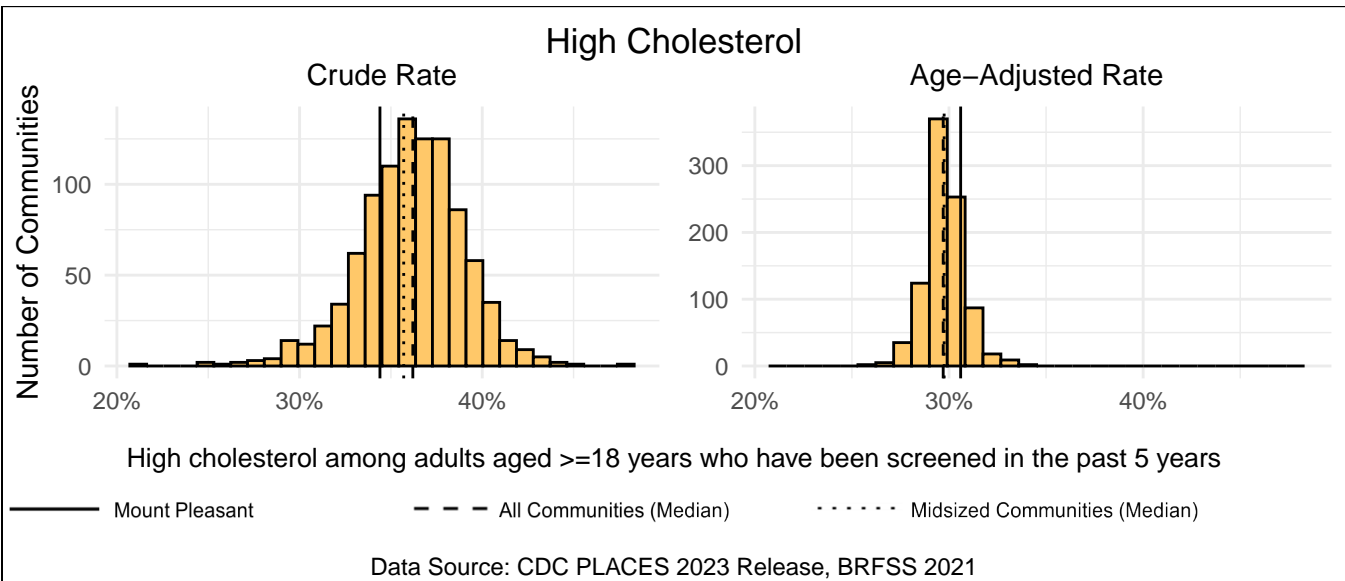

High Cholesterol

Mount Pleasant has a crude rate of 34.4% for high cholesterol among adults aged ≥ 18 years who have been screened in the past 5 years, which ranks 231st out of 958 Iowa communities (32nd out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 30.6%, which ranks 731st out of 905 Iowa communities (77th out of 102 midsized communities).

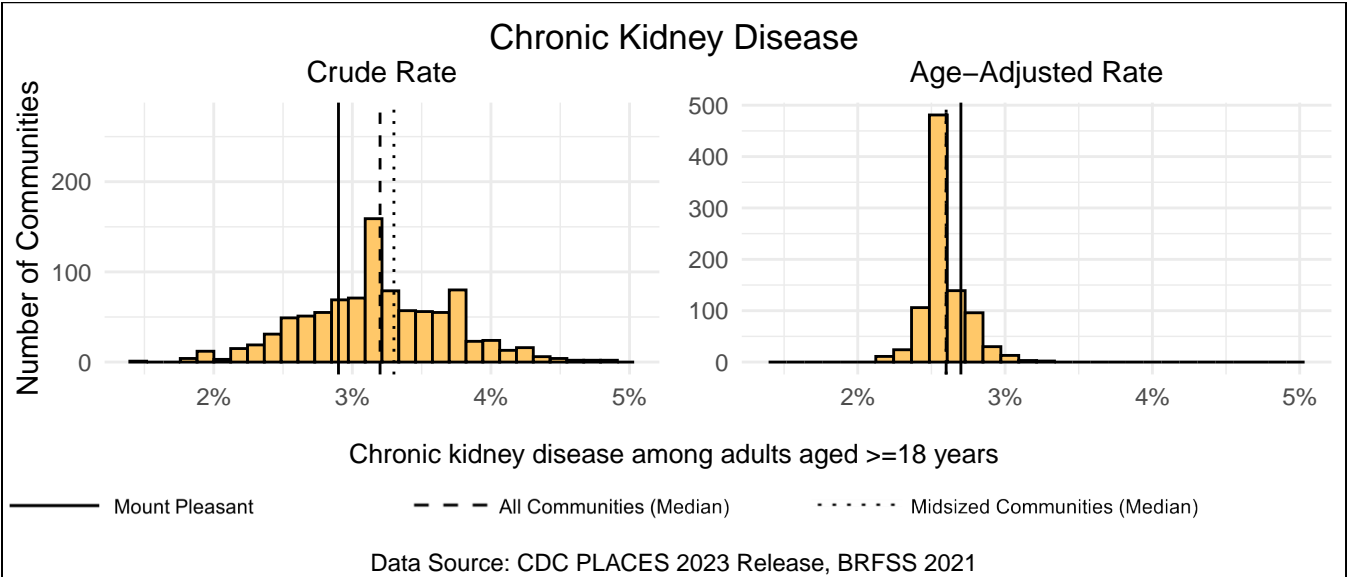

Chronic Kidney Disease

Mount Pleasant has a crude rate of 2.9% for chronic kidney disease among adults aged ≥ 18 years, which ranks 241st out of 958 Iowa communities (29th out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 2.7%, which ranks 623rd out of 905 Iowa communities (60th out of 102 midsized communities).

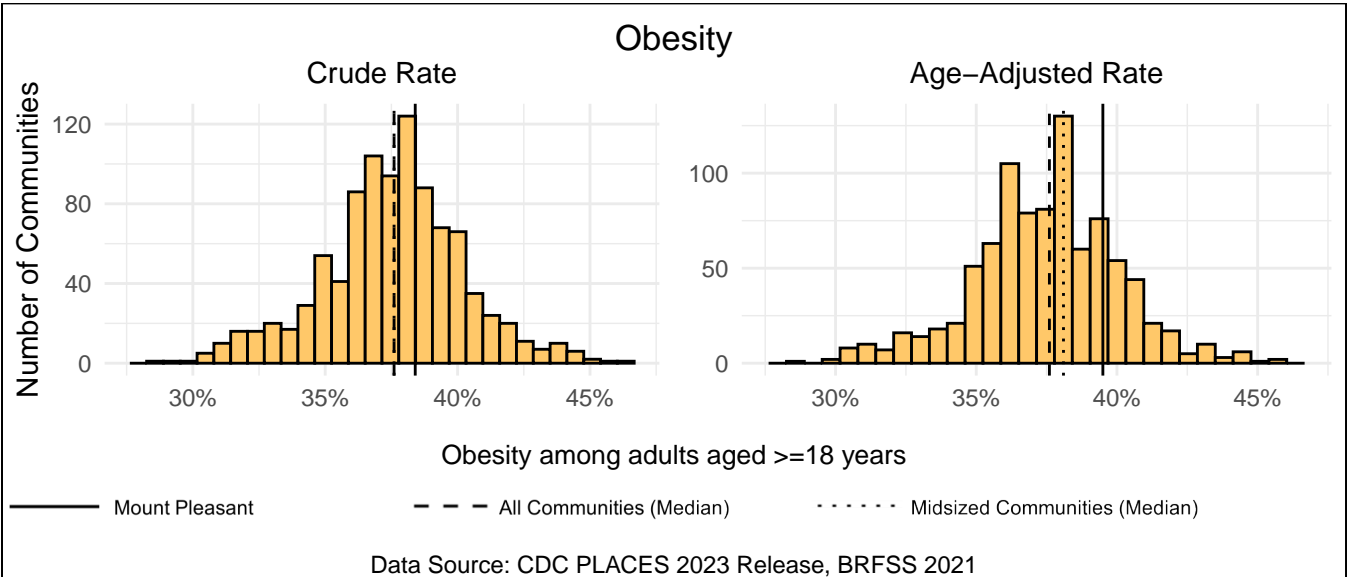

Mount Pleasant has a crude rate of 38.4% for obesity among adults aged ≥ 18 years, which ranks 601st out of 958 Iowa communities (69th out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 39.5%, which ranks 715th out of 905 Iowa communities (73rd out of 102 midsized communities).

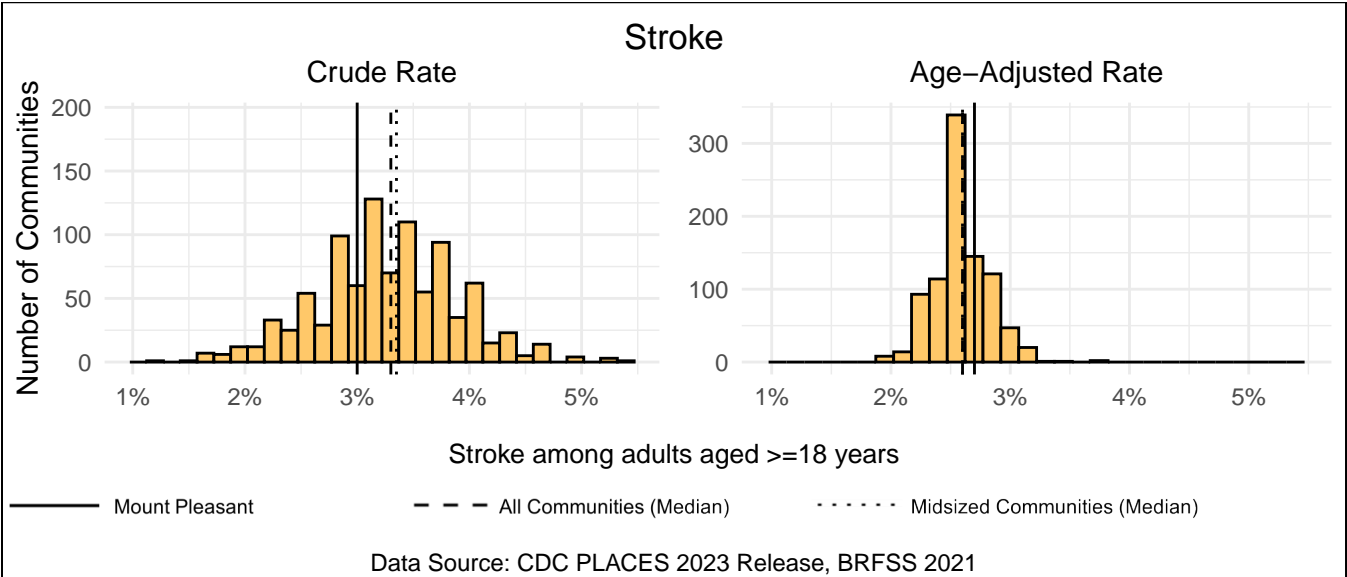

Mount Pleasant has a crude rate of 3.0% for stroke among adults aged ≥ 18 years, which ranks 280th out of 958 Iowa communities (30th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 2.7%, which ranks 569th out of 905 Iowa communities (57th out of 102 mid-sized communities).

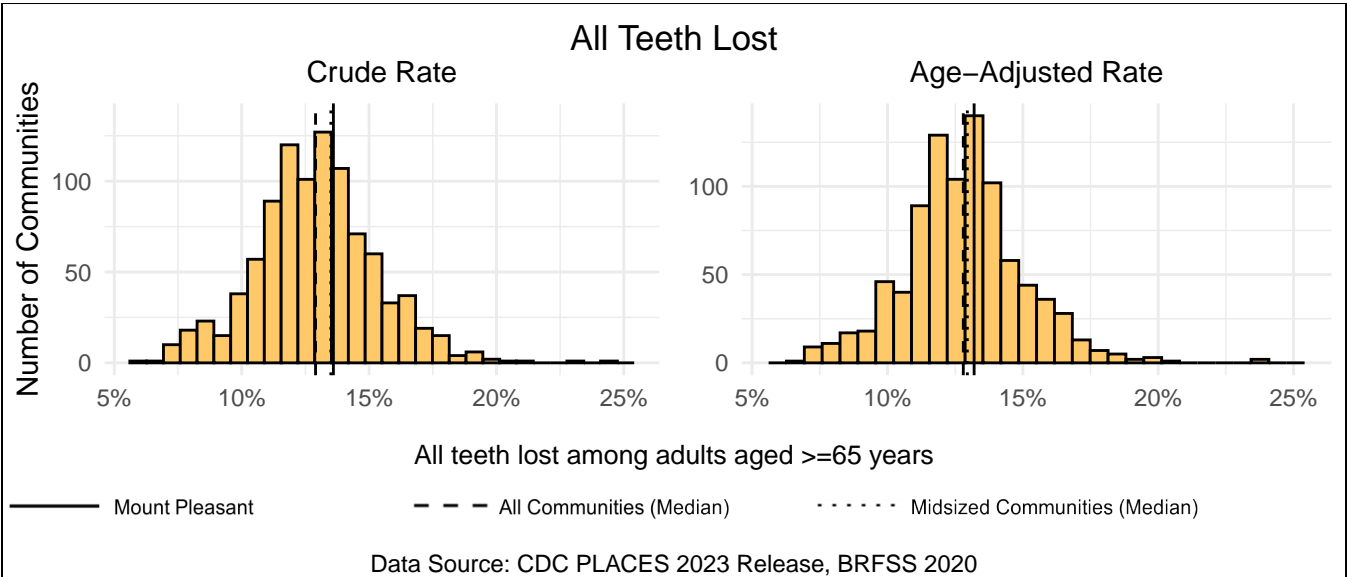

Mount Pleasant has a crude rate of 13.6% for all teeth lost among adults aged ≥ 65 years, which ranks 601st out of 958 Iowa communities (53rd out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 13.2%, which ranks 528th out of 905 Iowa communities (56th out of 102 mid-sized communities).

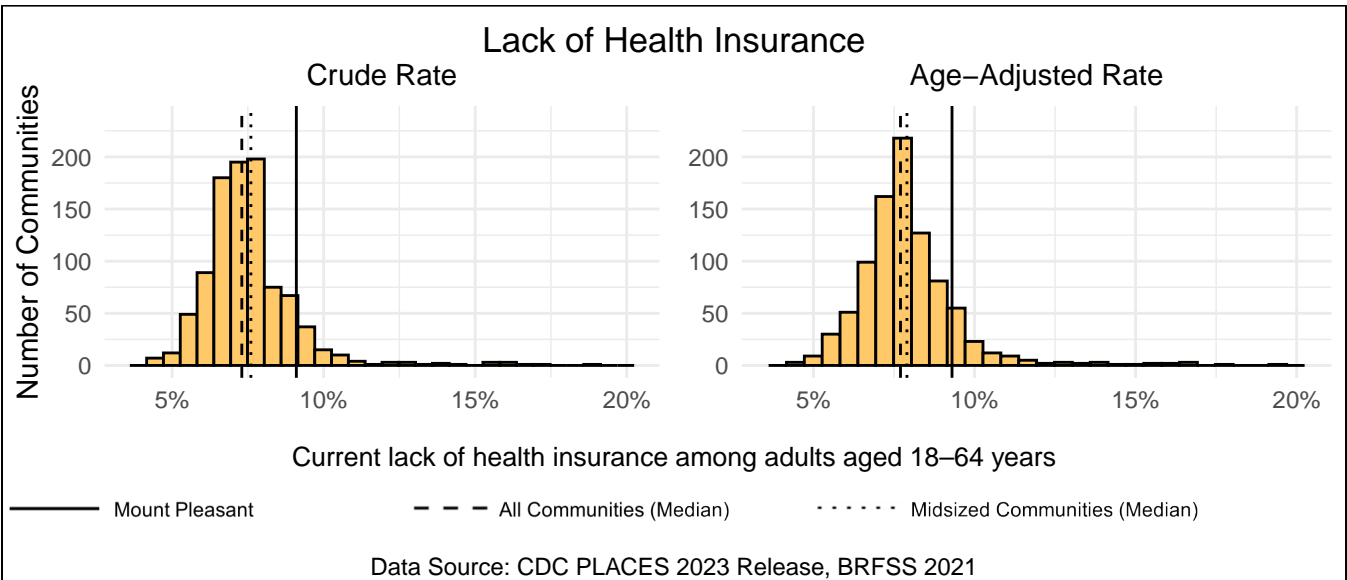

Mount Pleasant has a crude rate of 9.1% for current lack of health insurance among adults aged 18–64 years, which ranks 861st out of 958 Iowa communities (77th out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 9.3%, which ranks 788th out of 905 Iowa communities (72nd out of 102 midsized communities).

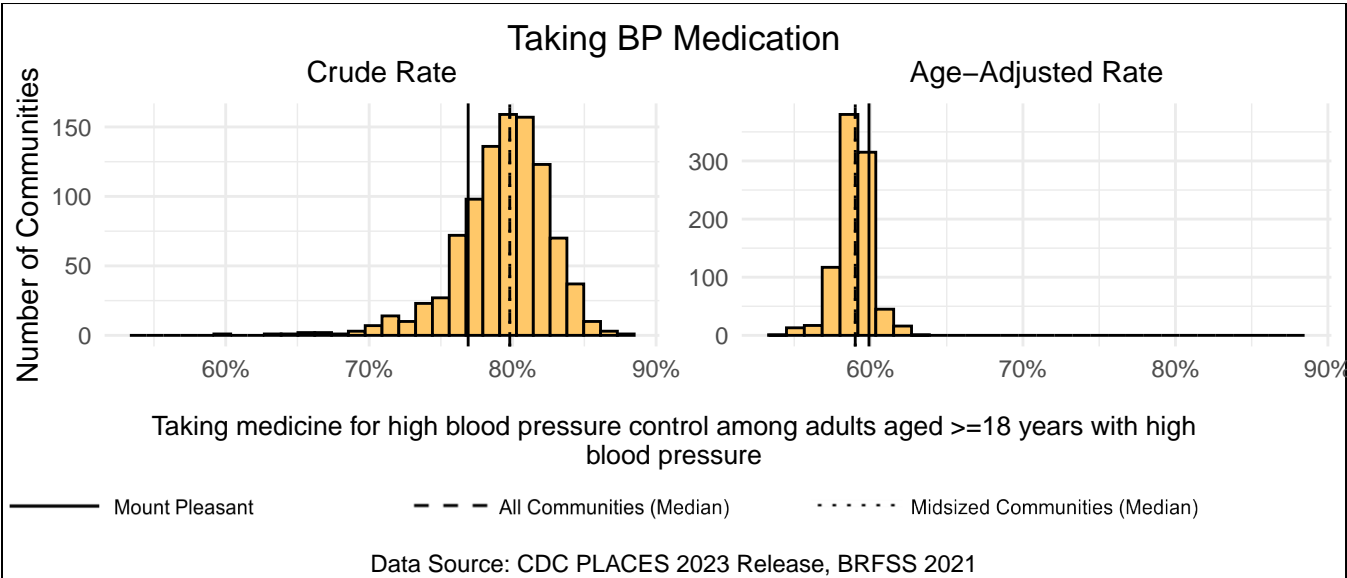

Taking BP Medication

Mount Pleasant has a crude rate of 76.9% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 780th out of 958 Iowa communities (74th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 59.9%, which ranks 107th out of 905 Iowa communities (22nd out of 102 mid-sized communities).

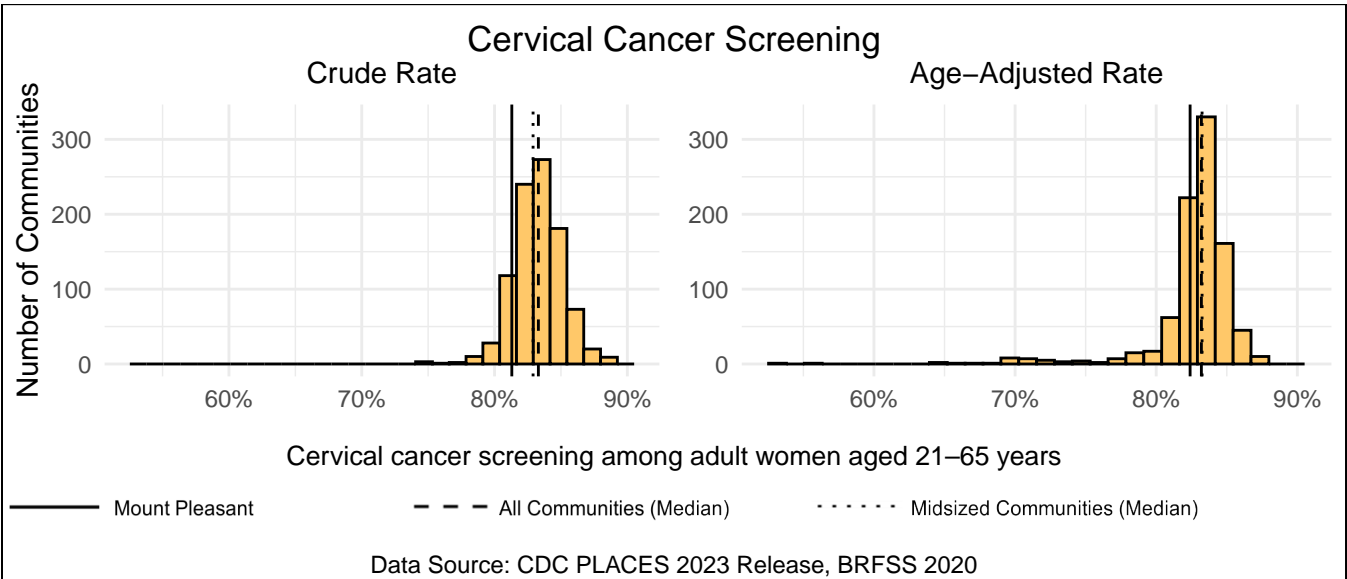

Cervical Cancer Screening

Mount Pleasant has a crude rate of 81.3% for cervical cancer screening among adult women aged 21–65 years, which ranks 832nd out of 958 Iowa communities (76th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 82.4%, which ranks 657th out of 905 Iowa communities (71st out of 102 mid-sized communities).

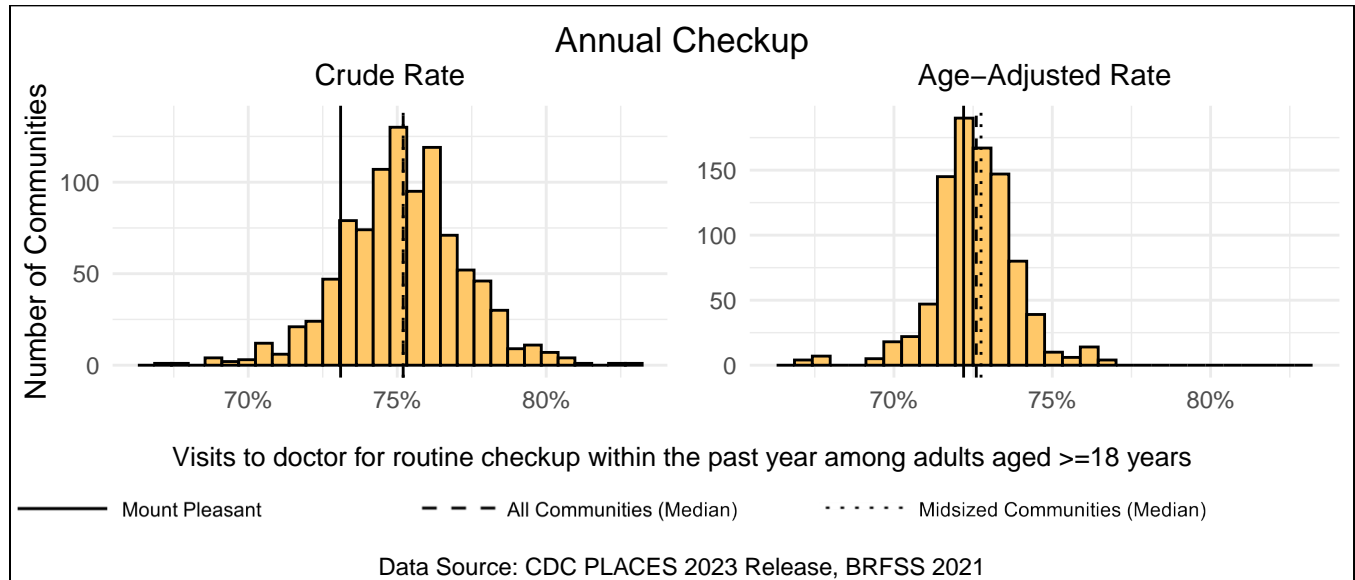

Annual Checkup

Mount Pleasant has a crude rate of 73.1% for visits to doctor for routine checkup within the past year among adults aged ≥ 18 years, which ranks 824th out of 958 Iowa communities (86th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 72.2%, which ranks 559th out of 905 Iowa communities (68th out of 102 midsize communities).

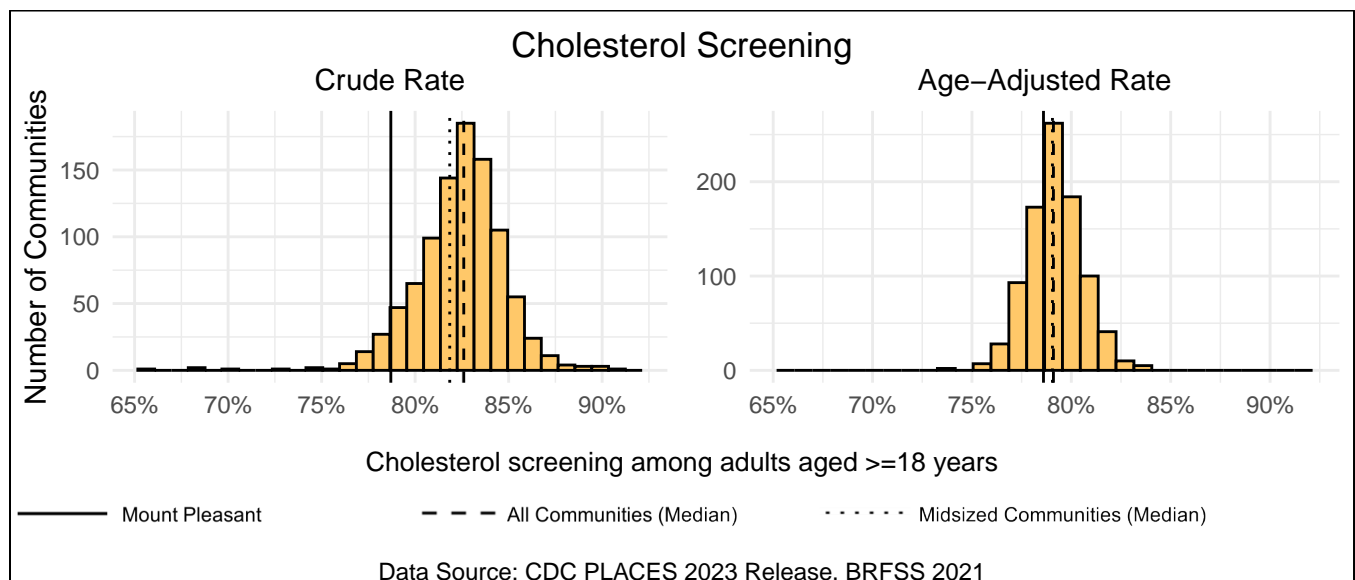

Cholesterol Screening

Mount Pleasant has a crude rate of 78.7% for cholesterol screening among adults aged ≥ 18 years, which ranks 902nd out of 958 Iowa communities (89th out of 102 midsize communities). The age-adjusted rate for Mount Pleasant is 78.6%, which ranks 603rd out of 905 Iowa communities (68th out of 102 midsize communities).

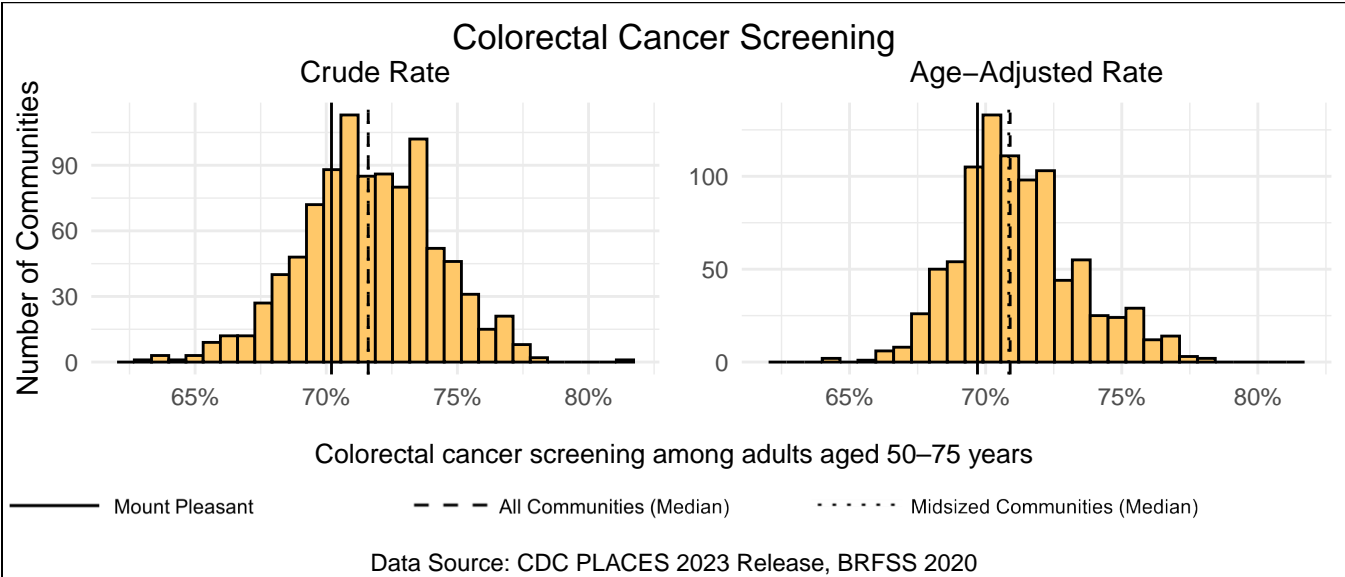

Colorectal Cancer Screening

Mount Pleasant has a crude rate of 70.2% for colorectal cancer screening among adults aged 50–75 years, which ranks 690th out of 958 Iowa communities (72nd out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 69.7%, which ranks 687th out of 905 Iowa communities (72nd out of 102 mid-sized communities).

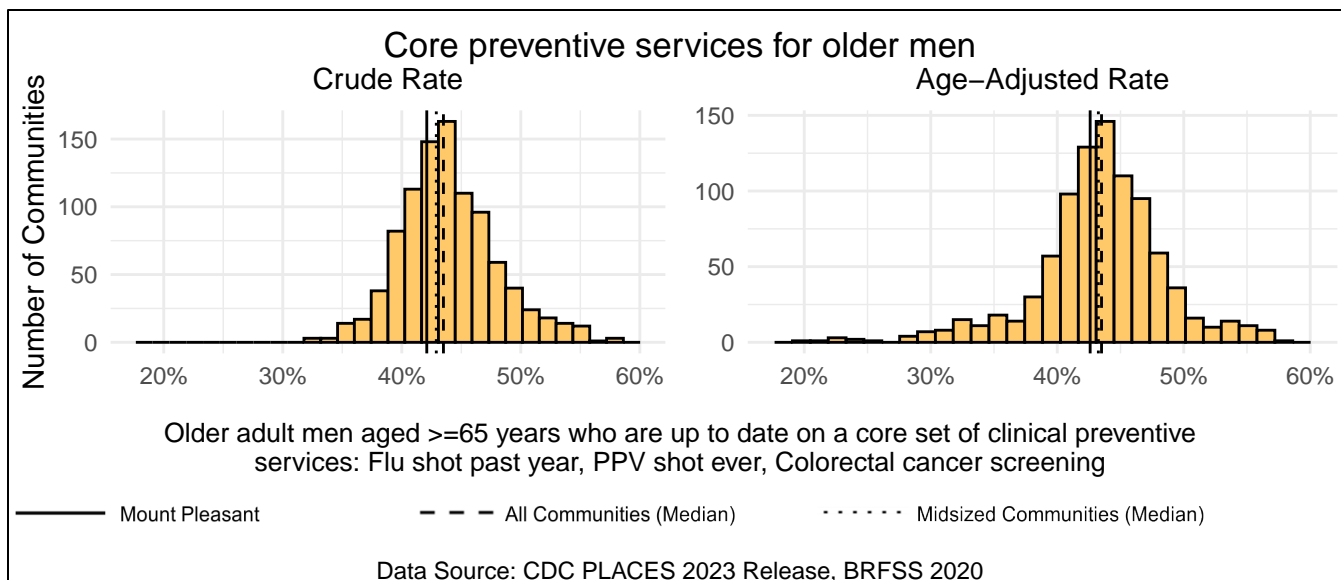

Core preventive services for older men

Mount Pleasant has a crude rate of 42.1% for older adult men aged ≥ 65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 642nd out of 958 Iowa communities (59th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 42.6%, which ranks 542nd out of 905 Iowa communities (58th out of 102 mid-sized communities).

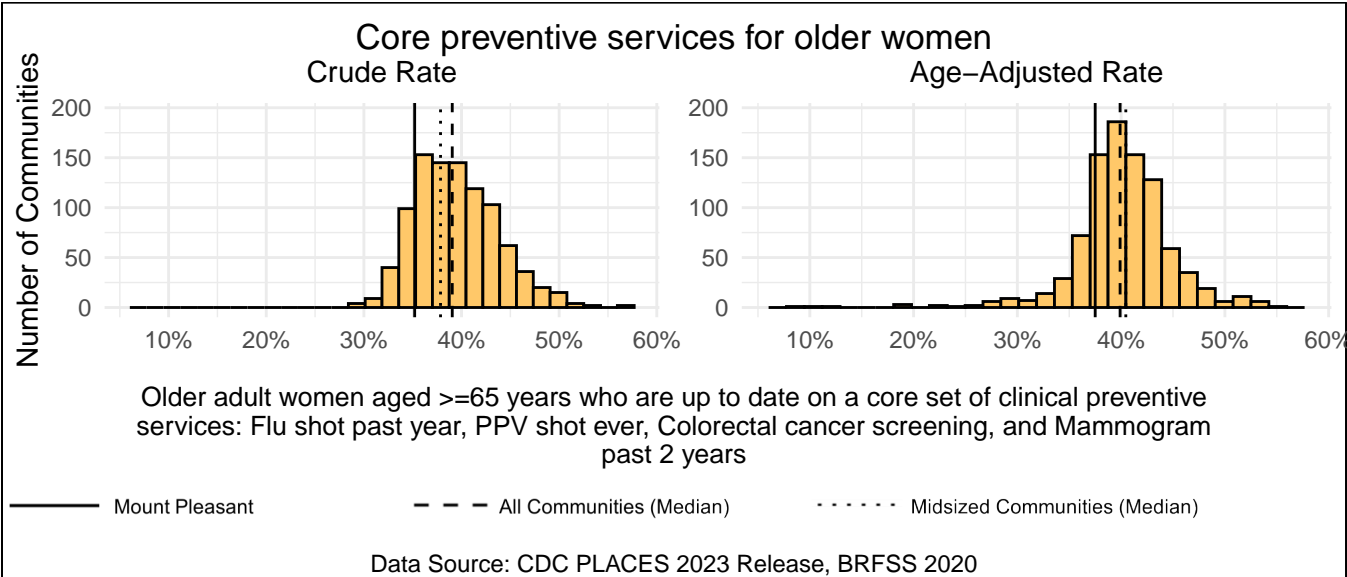

Core preventive services for older women

Mount Pleasant has a crude rate of 35.2% for older adult women aged ≥ 65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 807th out of 958 Iowa communities (82nd out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 37.5%, which ranks 717th out of 905 Iowa communities (83rd out of 102 mid-sized communities).

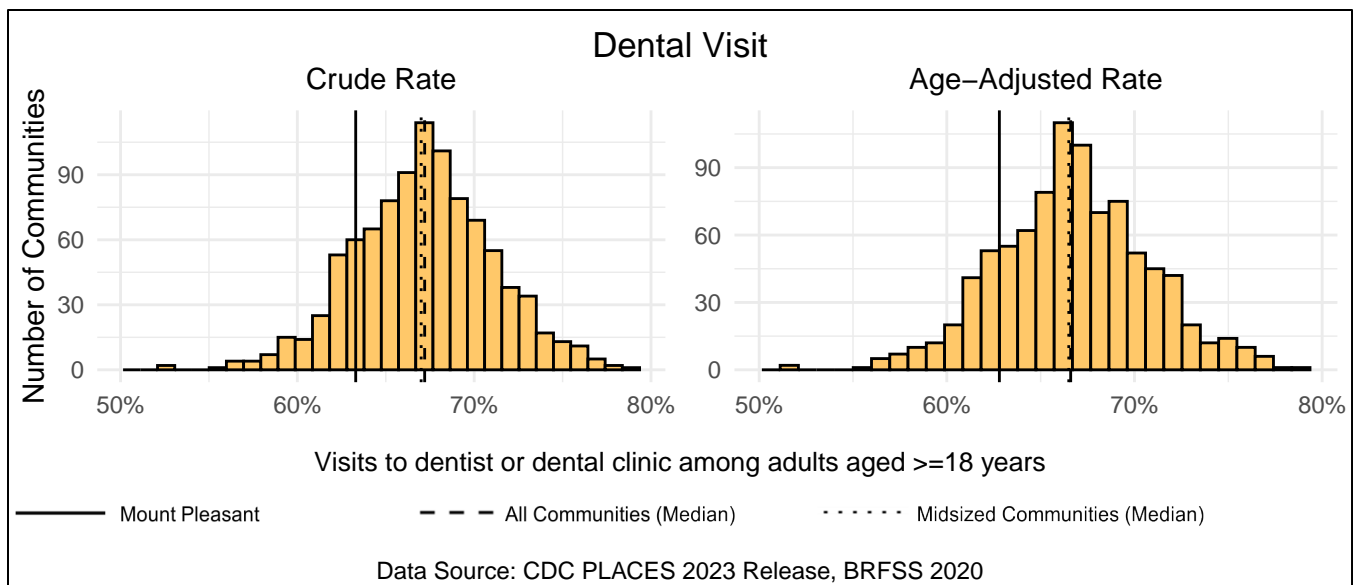

Dental Visit

Mount Pleasant has a crude rate of 63.3% for visits to dentist or dental clinic among adults aged ≥ 18 years, which ranks 804th out of 958 Iowa communities (73rd out of 102 midsized communities). The age-adjusted rate for Mount Pleasant is 62.8%, which ranks 755th out of 905 Iowa communities (73rd out of 102 midsized communities).

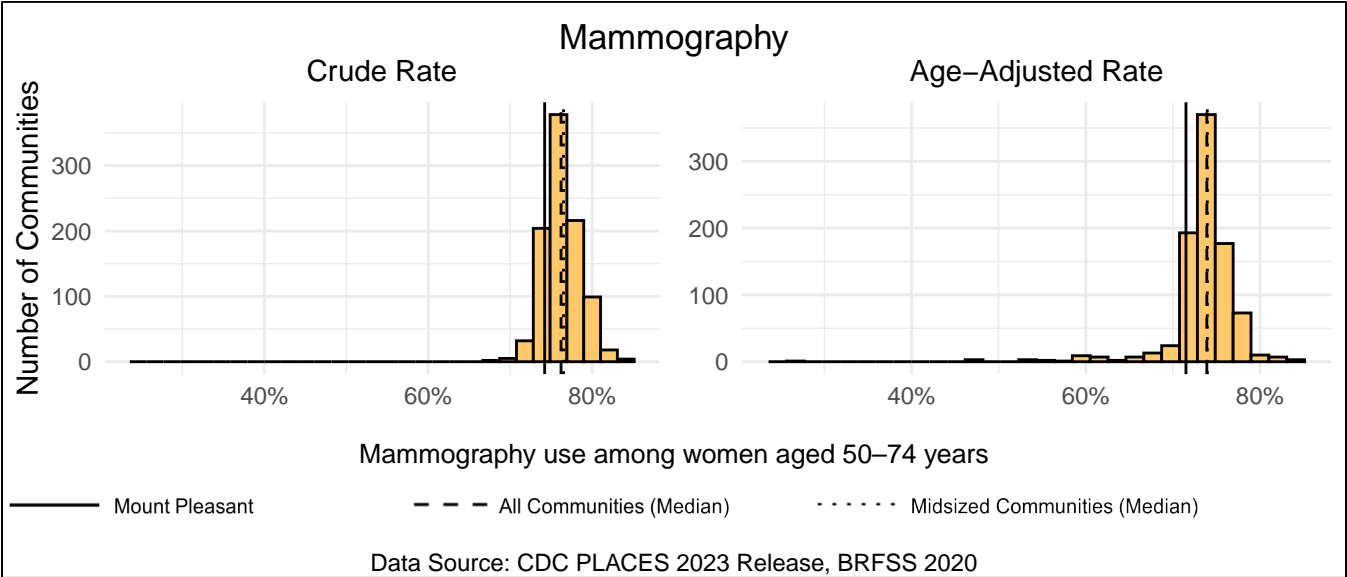

Mammography

Mount Pleasant has a crude rate of 74.2% for mammography use among women aged 50–74 years, which ranks 807th out of 958 Iowa communities (95th out of 102 mid-sized communities). The age-adjusted rate for Mount Pleasant is 71.5%, which ranks 793rd out of 905 Iowa communities (91st out of 102 mid-sized communities).

Disability

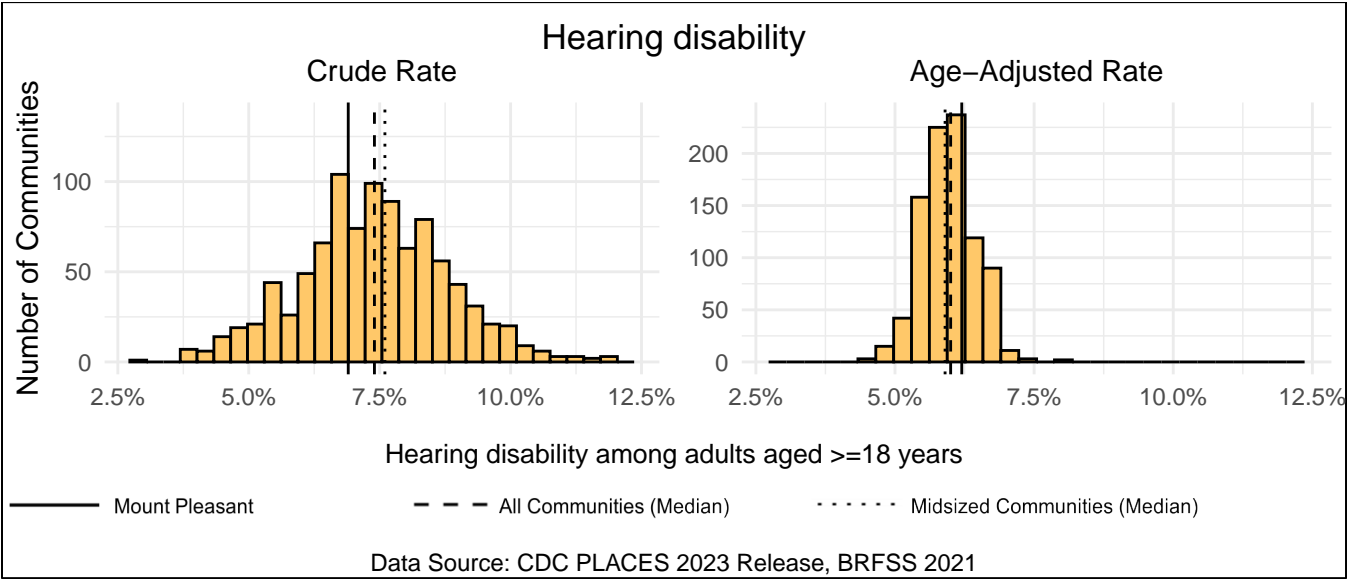
This section includes measures of physical and cognitive disabilities. Respondents were asked to report on six disabilities: hearing, vision, cognition, mobility, self-care, and independent living. Hearing disability

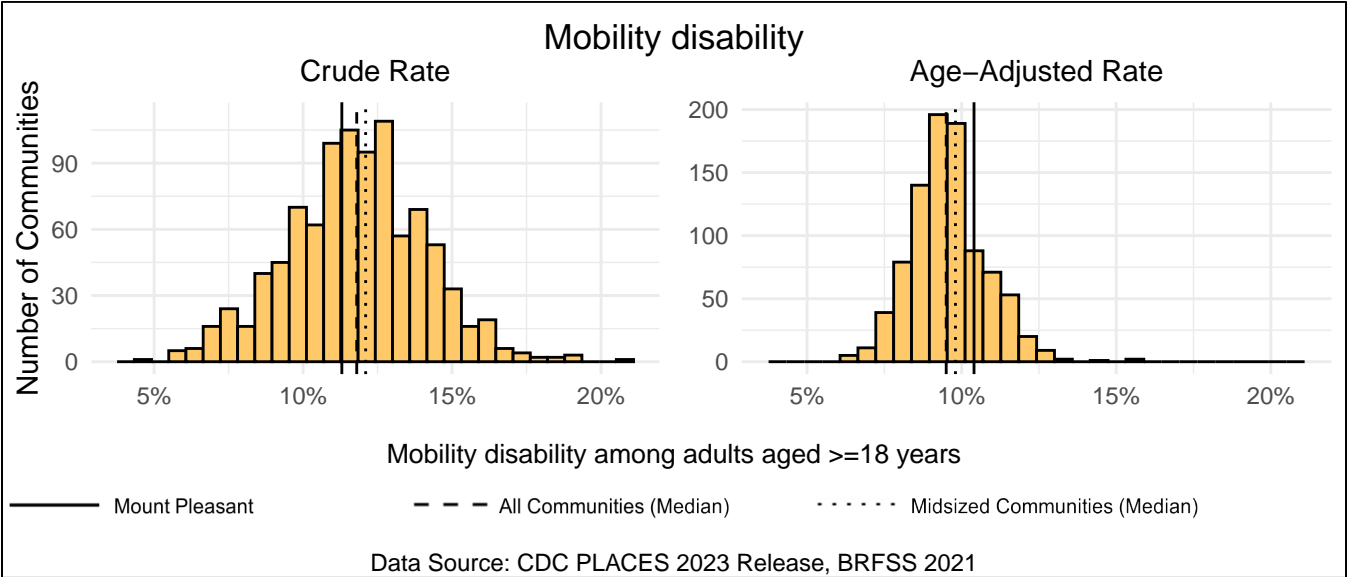

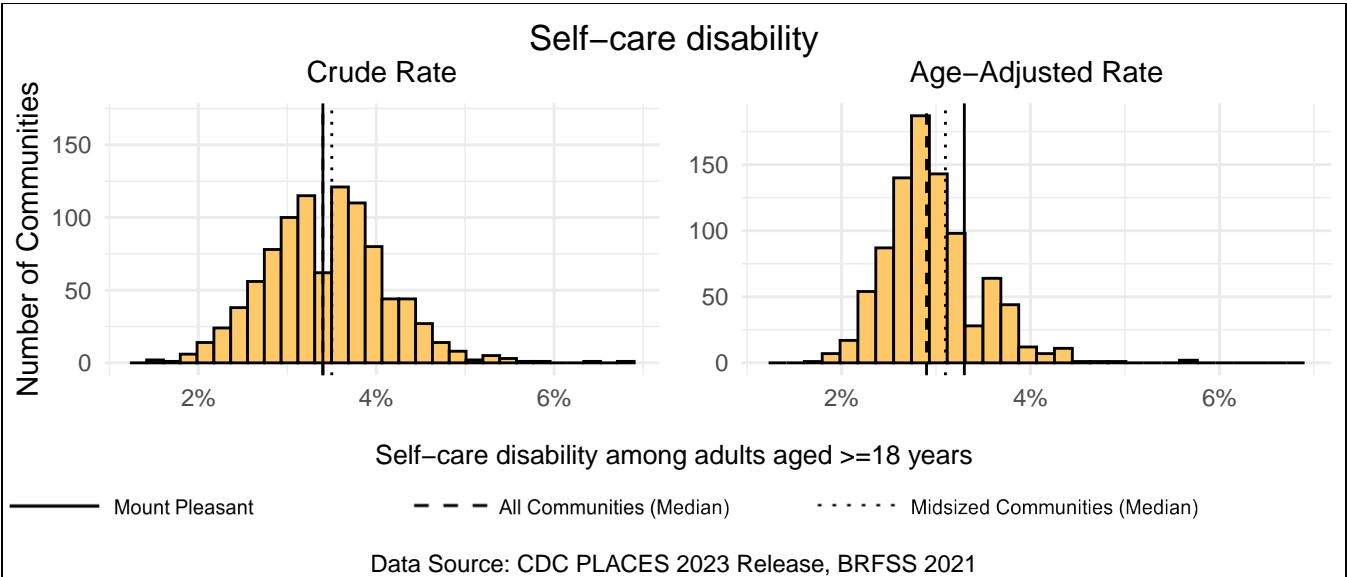

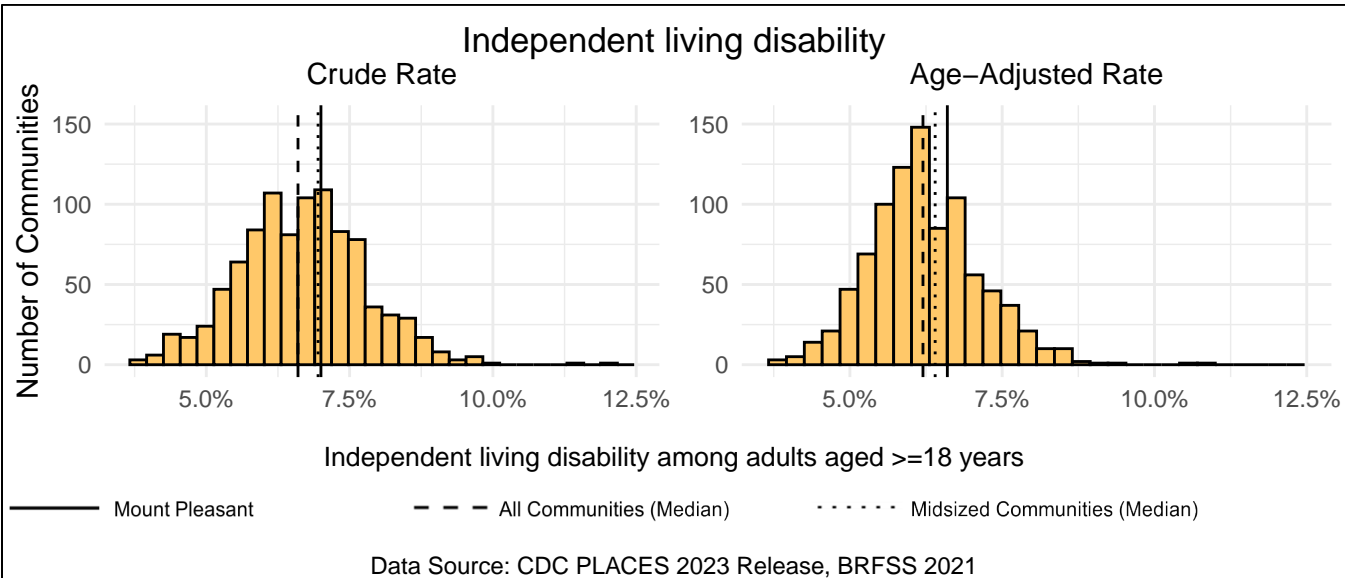

This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
