# Health in Nashua: Overview

Dear Community Members & Stakeholders of Nashua,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partner-ship with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Nashua ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Nashua's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Nashua. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

# **How to Use this Report**

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Nashua that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Nashua, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Nashua compares to the rest of the state and similarly-sized communities.

With a population of 1,472, Nashua's similarly sized communities are defined as small communities. In lowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

#### Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, lowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

## **Health Status**


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. #### **Poor General Health**

Nashua has a crude rate of 13.1% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 272nd out of 958 lowa communities (42nd out of 138 small communities). The age-adjusted rate for Nashua is 11.8%, which ranks 238th out of 905 lowa communities (45th out of 138 small communities).



#### **Poor Physical Health**

Nashua has a crude rate of 10.1% for physical health not good for >=14 days among adults aged >=18 years, which ranks 269th out of 958 lowa communities (44th out of 138 small communities). The age-adjusted rate for Nashua is 9.3%, which ranks 265th out of 905 lowa communities (49th out of 138 small communities).



#### **Poor Mental Health**

Nashua has a crude rate of 14.4% for mental health not good for >=14 days among adults aged >=18 years, which ranks 514th out of 958 lowa communities (87th out of 138 small communities). The age-adjusted rate for Nashua is 15.5%, which ranks 405th out of 905 lowa communities (65th out of 138 small communities).

# **Health Risk Behaviors**


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. ## **Binge Drinking**

Nashua has a crude rate of 19.9% for binge drinking among adults aged >=18 years, which ranks 549th out of 958 lowa communities (83rd out of 138 small communities). The age-adjusted rate for Nashua is 22.5%, which ranks 609th out of 905 lowa communities (91st out of 138 small communities).



#### **Current Smoking**

Nashua has a crude rate of 15.5% for current smoking among adults aged >=18 years, which ranks 233rd out of 958 lowa communities (47th out of 138 small communities). The age-adjusted rate for Nashua is 16.7%, which ranks 273rd out of 905 lowa communities (54th out of 138 small communities).



#### **Physical Inactivity**

Nashua has a crude rate of 24.3% for no leisure-time physical activity among adults aged >=18 years, which ranks 270th out of 958 lowa communities (43rd out of 138 small communities). The age-adjusted rate for Nashua is 22.6%, which ranks 241st out of 905 lowa communities (50th out of 138 small communities).



## Sleep <7 hours

Nashua has a crude rate of 29.9% for sleeping less than 7 hours among adults aged >=18 years, which ranks 374th out of 958 lowa communities (66th out of 138 small communities). The age-adjusted rate for Nashua is 31.1%, which ranks 446th out of 905 lowa communities (77th out of 138 small communities).

# **Health Outcomes**



Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. #### **Arthritis**

Nashua has a crude rate of 27.9% for arthritis among adults aged >=18 years, which ranks 479th out of 958 lowa communities (61st out of 138 small communities). The age-adjusted rate for Nashua is 23.5%, which ranks 550th out of 905 lowa communities (84th out of 138 small communities).



#### **High Blood Pressure**

Nashua has a crude rate of 31.7% for high blood pressure among adults aged >=18 years, which ranks 424th out of 958 lowa communities (59th out of 138 small communities). The age-adjusted rate for Nashua is 27.0%, which ranks 368th out of 905 lowa communities (66th out of 138 small communities).



#### Cancer (except skin)

Nashua has a crude rate of 8.5% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 606th out of 958 lowa communities (74th out of 138 small communities). The age-adjusted rate for Nashua is 6.6%, which ranks 831st out of 905 lowa communities (126th out of 138 small communities).



#### **Current Asthma**

Nashua has a crude rate of 9.4% for current asthma among adults aged >=18 years, which ranks 524th out of 958 lowa communities (85th out of 138 small communities). The age-adjusted rate for Nashua is 9.6%, which ranks 513th out of 905 lowa communities (73rd out of 138 small communities).



#### **Coronary Heart Disease**

Nashua has a crude rate of 6.4% for coronary heart disease among adults aged >=18 years, which ranks 438th out of 958 lowa communities (60th out of 138 small communities). The age-adjusted rate for Nashua is 4.8%, which ranks 257th out of 905 lowa communities (53rd out of 138 small communities).



Nashua has a crude rate of 7.1% for chronic obstructive pulmonary disease among adults aged >=18 years, which ranks 363rd out of 958 lowa communities (56th out of 138 small communities). The age-adjusted rate for Nashua is 6.0%, which ranks 305th out of 905 lowa communities (56th out of 138 small communities).





#### **Diabetes**

Nashua has a crude rate of 9.2% for diagnosed diabetes among adults aged >=18 years, which ranks 258th out of 958 lowa communities (44th out of 138 small communities). The age-adjusted rate for Nashua is 7.5%, which ranks 147th out of 905 lowa communities (30th out of 138 small communities).



#### **High Cholesterol**

Nashua has a crude rate of 35.6% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 375th out of 958 lowa communities (50th out of 138 small communities). The age-adjusted rate for Nashua is 29.3%, which ranks 276th out of 905 lowa communities (45th out of 138 small communities).









# **Prevention**



#### **Lack of Health Insurance**

Nashua has a crude rate of 7.0% for current lack of health insurance among adults aged 18–64 years, which ranks 338th out of 958 lowa communities (61st out of 138 small communities). The age-adjusted rate for Nashua is 7.1%, which ranks 234th out of 905 lowa communities (49th out of 138 small communities).



## **Taking BP Medication**

Nashua has a crude rate of 79.6% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 493rd out of 958 lowa communities (80th out of 138 small communities). The age-adjusted rate for Nashua is 58.1%, which ranks 737th out of 905 lowa communities (108th out of 138 small communities).



Nashua has a crude rate of 82.9% for cervical cancer screening among adult women aged 21–65 years, which ranks 557th out of 958 lowa communities (91st out of 138 small communities). The age-adjusted rate for Nashua is 84.1%, which ranks 217th out of 905 lowa communities (45th out of 138 small communities).



The age-adjusted rate for Nashua is 72.4%, which ranks 498th out of 905 lowa communities (80th out of 138 small communities).





Nashua has a crude rate of 74.7% for colorectal cancer screening among adults aged 50–75 years, which ranks 100th out of 958 lowa communities (18th out of 138 small communities). The age-adjusted rate for Nashua is 73.2%, which ranks 159th out of 905 lowa communities (29th out of 138 small communities).



Nashua has a crude rate of 46.2% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 243rd out of 958 lowa communities (39th out of 138 small communities). The age-adjusted rate for Nashua is 46.2%, which ranks 233rd out of 905 lowa communities (43rd out of 138 small communities).



#### Core preventive services for older women

Nashua has a crude rate of 39.8% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 407th out of 958 lowa communities (57th out of 138 small communities). The age-adjusted rate for Nashua is 41.1%, which ranks 353rd out of 905 lowa communities (62nd out of 138 small communities).



Nashua has a crude rate of 68.9% for visits to dentist or dental clinic among adults aged >=18 years, which ranks 305th out of 958 lowa communities (55th out of 138 small communities). The age-adjusted rate for Nashua is 68.4%, which ranks 292nd out of 905 lowa communities (56th out of 138 small communities).



## **Mammography**

Nashua has a crude rate of 74.5% for mammography use among women aged 50–74 years, which ranks 764th out of 958 lowa communities (110th out of 138 small communities). The age-adjusted rate for Nashua is 73.6%, which ranks 499th out of 905 lowa communities (79th out of 138 small communities).

# **Disability**



Nashua has a crude rate of 7.4% for hearing disability among adults aged >=18 years, which ranks 470th out of 958 lowa communities (59th out of 138 small communities). The age-adjusted rate for Nashua is 5.7%, which ranks 219th out of 905 lowa communities (46th out of 138 small communities).











This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
