Health in Swisher: Overview

Dear Community Members & Stakeholders of Swisher,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partner-ship with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Swisher ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Swisher's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Swisher. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your community had a standard age distribution. Crude rates can provide a general comparison between communities and age-adjusted rates can give a fairer comparison between communities with different age structures.

Take a look at the top strengths of your community! Below are unadjusted and age-adjusted health measures that represent your community's strengths. We recommend using continued investment in these areas to maintain them as strengths, as well as building on them to improve in other health domains.

How to Use this Report

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Swisher that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Swisher, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Swisher compares to the rest of the state and similarly-sized communities.

With a population of 1,126, Swisher's similarly sized communities are defined as small communities. In lowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, lowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

Health Status


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Swisher has a crude rate of 8.9% for fair or poor self-rated health status among adults aged >= 18 years, which ranks 12th out of 958 lowa communities (3rd out of 138 small communities). The age-adjusted rate for Swisher is 8.6%, which ranks 7th out of 905 lowa communities (2nd out of 138 small communities).



Poor Physical Health

Swisher has a crude rate of 7.6% for physical health not good for >=14 days among adults aged >=18 years, which ranks 15th out of 958 lowa communities (4th out of 138 small communities). The age-adjusted rate for Swisher is 7.3%, which ranks 8th out of 905 lowa communities (2nd out of 138 small communities).



Poor Mental Health

Swisher has a crude rate of 13.2% for mental health not good for >=14 days among adults aged >=18 years, which ranks 119th out of 958 lowa communities (17th out of 138 small communities). The age-adjusted rate for Swisher is 13.6%, which ranks 28th out of 905 lowa communities (7th out of 138 small communities).

Health Risk Behaviors


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Swisher has a crude rate of 24.0% for binge drinking among adults aged >=18 years, which ranks 936th out of 958 lowa communities (131st out of 138 small communities). The age-adjusted rate for Swisher is 24.4%, which ranks 895th out of 905 lowa communities (136th out of 138 small communities).



Current Smoking

Swisher has a crude rate of 12.8% for current smoking among adults aged >=18 years, which ranks 34th out of 958 lowa communities (7th out of 138 small communities). The age-adjusted rate for Swisher is 11.9%, which ranks 13th out of 905 lowa communities (3rd out of 138 small communities).



Physical Inactivity

Swisher has a crude rate of 17.4% for no leisure-time physical activity among adults aged >=18 years, which ranks 13th out of 958 lowa communities (3rd out of 138 small communities). The age-adjusted rate for Swisher is 17.3%, which ranks 13th out of 905 lowa communities (3rd out of 138 small communities).



Sleep <7 hours

Swisher has a crude rate of 28.7% for sleeping less than 7 hours among adults aged >=18 years, which ranks 169th out of 958 lowa communities (31st out of 138 small communities). The age-adjusted rate for Swisher is 28.1%, which ranks 44th out of 905 lowa communities (7th out of 138 small communities).

Health Outcomes



Health outcome measures include but are not limited to arthritis, high blood pressure, cancer, depression, and obesity. Arthritis

Swisher has a crude rate of 21.6% for arthritis among adults aged >=18 years, which ranks 53rd out of 958 lowa communities (14th out of 138 small communities). The age-adjusted rate for Swisher is 20.5%, which ranks 26th out of 905 lowa communities (8th out of 138 small communities).



High Blood Pressure

Swisher has a crude rate of 23.6% for high blood pressure among adults aged >=18 years, which ranks 20th out of 958 lowa communities (7th out of 138 small communities). The age-adjusted rate for Swisher is 22.6%, which ranks 2nd out of 905 lowa communities (1st out of 138 small communities).



Cancer (except skin)

Swisher has a crude rate of 6.6% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 108th out of 958 lowa communities (17th out of 138 small communities). The age-adjusted rate for Swisher is 6.6%, which ranks 831st out of 905 lowa communities (126th out of 138 small communities).



Current Asthma

Swisher has a crude rate of 8.9% for current asthma among adults aged >=18 years, which ranks 80th out of 958 lowa communities (11th out of 138 small communities). The age-adjusted rate for Swisher is 8.9%, which ranks 45th out of 905 lowa communities (7th out of 138 small communities).



Swisher has a crude rate of 4.0% for coronary heart disease among adults aged >=18 years, which ranks 27th out of 958 lowa communities (8th out of 138 small communities). The age-adjusted rate for Swisher is 4.0%, which ranks 7th out of 905 lowa communities (1st out of 138 small communities).



Swisher has a crude rate of 4.5% for chronic obstructive pulmonary disease among adults aged >=18 years, which ranks 16th out of 958 lowa communities (6th out of 138 small communities). The age-adjusted rate for Swisher is 4.3%, which ranks 8th out of 905 lowa communities (2nd out of 138 small communities).



Swisher has a crude rate of 18.7% for depression among adults aged >=18 years, which ranks 673rd out of 958 lowa communities (104th out of 138 small communities). The age-adjusted rate for Swisher is 18.7%, which ranks 291st out of 905 lowa communities (45th out of 138 small communities).



Swisher has a crude rate of 6.6% for diagnosed diabetes among adults aged >=18 years, which ranks 24th out of 958 lowa communities (7th out of 138 small communities). The age-adjusted rate for Swisher is 6.2%, which ranks 4th out of 905 lowa communities (1st out of 138 small communities).



Swisher has a crude rate of 29.3% for high cholesterol among adults aged >=18 years who have been screened in the past 5 years, which ranks 16th out of 958 lowa communities (6th out of 138 small communities). The age-adjusted rate for Swisher is 26.2%, which ranks 1st out of 905 lowa communities (1st out of 138 small communities).









Swisher has a crude rate of 7.1% for all teeth lost among adults aged >=65 years, which ranks 4th out of 958 lowa communities (2nd out of 138 small communities). The age-adjusted rate for Swisher is 7.5%, which ranks 6th out of 905 lowa communities (2nd out of 138 small communities).



Lack of Health Insurance

Swisher has a crude rate of 4.9% for current lack of health insurance among adults aged 18–64 years, which ranks 10th out of 958 lowa communities (2nd out of 138 small communities). The age-adjusted rate for Swisher is 5.1%, which ranks 10th out of 905 lowa communities (2nd out of 138 small communities).



Taking BP Medication

Swisher has a crude rate of 72.9% for taking medicine for high blood pressure control among adults aged >=18 years with high blood pressure, which ranks 919th out of 958 lowa communities (128th out of 138 small communities). The age-adjusted rate for Swisher is 55.1%, which ranks 898th out of 905 lowa communities (138th out of 138 small communities).



Swisher has a crude rate of 87.4% for cervical cancer screening among adult women aged 21–65 years, which ranks 17th out of 958 lowa communities (5th out of 138 small communities). The age-adjusted rate for Swisher is 86.2%, which ranks 19th out of 905 lowa communities (6th out of 138 small communities).



Swisher has a crude rate of 71.9% for visits to doctor for routine checkup within the past year among adults aged >=18 years, which ranks 909th out of 958 lowa communities (130th out of 138 small communities). The age-adjusted rate for Swisher is 71.4%, which ranks 787th out of 905 lowa communities (128th out of 138 small communities).



Cholesterol Screening

Swisher has a crude rate of 83.8% for cholesterol screening among adults aged >=18 years, which ranks 240th out of 958 lowa communities (40th out of 138 small communities). The age-adjusted rate for Swisher is 82.0%, which ranks 27th out of 905 lowa communities (7th out of 138 small communities).



Colorectal Cancer Screening

Swisher has a crude rate of 76.1% for colorectal cancer screening among adults aged 50–75 years, which ranks 44th out of 958 lowa communities (10th out of 138 small communities). The age-adjusted rate for Swisher is 75.5%, which ranks 45th out of 905 lowa communities (13th out of 138 small communities).



Core preventive services for older men

Swisher has a crude rate of 46.4% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 233rd out of 958 lowa communities (35th out of 138 small communities). The age-adjusted rate for Swisher is 46.6%, which ranks 203rd out of 905 lowa communities (33rd out of 138 small communities).



Core preventive services for older women

Swisher has a crude rate of 50.4% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 10th out of 958 lowa communities (4th out of 138 small communities). The age-adjusted rate for Swisher is 49.2%, which ranks 22nd out of 905 lowa communities (4th out of 138 small communities).



Dental Visit

Swisher has a crude rate of 73.9% for visits to dentist or dental clinic among adults aged >=18 years, which ranks 41st out of 958 lowa communities (8th out of 138 small communities). The age-adjusted rate for Swisher is 73.9%, which ranks 38th out of 905 lowa communities (9th out of 138 small communities).



Swisher has a crude rate of 78.8% for mammography use among women aged 50–74 years, which ranks 128th out of 958 lowa communities (15th out of 138 small communities). The age-adjusted rate for Swisher is 78.4%, which ranks 30th out of 905 lowa communities (4th out of 138 small communities).

Disability



Swisher has a crude rate of 4.7% for hearing disability among adults aged >=18 years, which ranks 29th out of 958 lowa communities (7th out of 138 small communities). The age-adjusted rate for Swisher is 4.8%, which ranks 8th out of 905 lowa communities (1st out of 138 small communities).











The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
