Health in Winfield: Overview

Dear Community Members & Stakeholders of Winfield,

We are pleased to share the Iowa Community Health Snapshot series, a set of reports designed in partnership with Iowa State University's Community Economic Development to assess the overall landscape of health and well-being across Iowa. The following pages include the health snapshot for your community. The snapshot can be used to see how Winfield ranks across various health measures compared to the rest of the state and similarly-sized communities. This comparison allows us to identify Winfield's strengths and opportunities for growth by leveraging the Centers for Disease Control and Prevention PLACES dataset.

The report includes 37 health measures organized topically by general health status, risky behavior, health outcomes, prevention, and disability. We provide a general overview of each health topic, followed by a description of each health measure. Health measure descriptions include crude and age-adjusted rates and a ranking that tells you how your community ranks compared to all lowa communities and communities of similar size to Winfield. Crude rates tell you the raw, un-adjusted percent of the population experiencing the health measure. Age-adjusted rates account for the age distribution present in your community and presents what the rate would be if your communities and age-adjusted rates can give a fairer comparison between communities and age-adjusted rates can give a fairer comparison between communities.

How to Use this Report

The purpose of the Iowa Community Health Snapshot Series is to provide an overview of health in Winfield that can be used to help inform health-related interventions and programming. This report contains five sections, including the overall health status of Winfield, a review of risky behaviors in the community, and information on various health outcomes, prevention measures, and disability needs. Each section includes an overview of the health domain, a breakdown of its underlying health measures, and data to see how Winfield compares to the rest of the state and similarly-sized communities.

With a population of 1,063, Winfield's similarly sized communities are defined as small communities. In lowa, small communities have an average population of 1,553, and there are 138 communities that are considered small communities. To see all of the communities in this population group, please see Appendix 3 of this report.

Using Ames, IA as an Example

The graphic below is an example of the details included for each health measure. The table in the upper right shows your community's crude and age-adjusted rate estimates alongside their averages across all lowa communities and similarly-sized communities. The images below show the distribution of the health measure across communities. The vertical lines correspond with the values in the table to show the estimate for the specific community compared to communities across the state. The solid black line in each plot represents the community rate, with the dashed lines indicating the average rate for all lowa communities and the dotted lines showing the average rate for similarly-sized communities.



The example graphic above displays the poor mental health rate in Ames, Iowa. The left plot shows the crude rate of poor mental health in the community. Crude rates are the raw, un-adjusted percent of the population experiencing the health measure. Notice how the solid black line is closer to the right of the plot than the dashed and dotted lines; this indicates that Ames has a higher crude rate of poor mental health than most communities in the state. However, the age-adjusted rate plot on the right shows the solid line closer to the peak of the distribution and averages for the state and similarly-sized communities, indicating that when accounting for Ames's unique age distribution, Ames's poor mental health rate is not a significant outlier, and is estimated to be lower than the statewide average. Accounting for crude and age-adjusted rates is critical to help inform health interventions as age-adjusted rates can help contextualize the health measure within the population.

Health Status


This section reflects measures for overall health, including general, physical, and mental health. These measures are a valuable way to see a simple summary of the health of a country's population. The questions to calculate these measures ask respondents to evaluate their health status. General health is evaluated on a 5-point scale where respondents can report their health status as one of "excellent," "very good," "good," "fair," or "poor," from which the respondents who answer "fair" or "poor" are included in the measure. Physical and mental health are evaluated as the rate of respondents who say they have had 14 or more days in the last 30 days in which their physical or mental health was not good. Poor General Health

Winfield has a crude rate of 14.8% for fair or poor selfrated health status among adults aged >= 18 years, which ranks 576th out of 958 lowa communities (90th out of 138 small communities). The age-adjusted rate for Winfield is 13.6%, which ranks 642nd out of 905 lowa communities (108th out of 138 small communities).



Poor Physical Health

Winfield has a crude rate of 11.2% for physical health not good for >=14 days among adults aged >=18 years, which ranks 600th out of 958 lowa communities (94th out of 138 small communities). The age-adjusted rate for Winfield is 10.3%, which ranks 673rd out of 905 lowa communities (110th out of 138 small communities).



Poor Mental Health

Winfield has a crude rate of 15.0% for mental health not good for >=14 days among adults aged >=18 years, which ranks 705th out of 958 lowa communities (117th out of 138 small communities). The age-adjusted rate for Winfield is 16.2%, which ranks 686th out of 905 lowa communities (114th out of 138 small communities).

Health Risk Behaviors


Health risk measures are measures of individual behaviors that can lead to poor health outcomes. These include binge drinking, current smoking, physical inactivity, and getting less than seven hours of nightly sleep. Risk behaviors are the most critical intervention points as they can help save lives and drastically improve health outcomes later in life. Each measure is calculated as the rate of respondents participating in a high level of risk behavior. The exact cutoff points for the behavior depend on the health area. Binge Drinking

Winfield has a crude rate of 18.4% for binge drinking among adults aged >=18 years, which ranks 283rd out of 958 lowa communities (50th out of 138 small communities). The age-adjusted rate for Winfield is 20.6%, which ranks 95th out of 905 lowa communities (13th out of 138 small communities).



Current Smoking

Winfield has a crude rate of 16.9% for current smoking among adults aged >=18 years, which ranks 490th out of 958 lowa communities (97th out of 138 small communities). The age-adjusted rate for Winfield is 18.0%, which ranks 536th out of 905 lowa communities (88th out of 138 small communities).



Physical Inactivity

Winfield has a crude rate of 27.0% for no leisure-time physical activity among adults aged >=18 years, which ranks 594th out of 958 lowa communities (88th out of 138 small communities). The age-adjusted rate for Winfield is 25.2%, which ranks 593rd out of 905 lowa communities (96th out of 138 small communities).



Sleep <7 hours

Winfield has a crude rate of 32.8% for sleeping less than 7 hours among adults aged >=18 years, which ranks 905th out of 958 lowa communities (133rd out of 138 small communities). The age-adjusted rate for Winfield is 33.8%, which ranks 880th out of 905 lowa communities (136th out of 138 small communities).

Health Outcomes



Arthritis

Winfield has a crude rate of 27.4% for arthritis among adults aged >=18 years, which ranks 422nd out of 958 lowa communities (55th out of 138 small communities). The age-adjusted rate for Winfield is 23.3%, which ranks 494th out of 905 lowa communities (72nd out of 138 small communities).



High Blood Pressure

Winfield has a crude rate of 33.0% for high blood pressure among adults aged >=18 years, which ranks 576th out of 958 lowa communities (77th out of 138 small communities). The age-adjusted rate for Winfield is 28.5%, which ranks 710th out of 905 lowa communities (113th out of 138 small communities).



Winfield has a crude rate of 8.2% for cancer (excluding skin cancer) among adults aged >=18 years, which ranks 505th out of 958 lowa communities (58th out of 138 small communities). The age-adjusted rate for Winfield is 6.5%, which ranks 418th out of 905 lowa communities (41st out of 138 small communities).



Winfield has a crude rate of 9.5% for current asthma among adults aged >=18 years, which ranks 625th out of 958 lowa communities (100th out of 138 small communities). The age-adjusted rate for Winfield is 9.8%, which ranks 696th out of 905 lowa communities (107th out of 138 small communities).









Winfield has a crude rate of 9.9% for diagnosed diabetes among adults aged >=18 years, which ranks 416th out of 958 lowa communities (63rd out of 138 small communities). The age-adjusted rate for Winfield is 8.4%, which ranks 567th out of 905 lowa communities (98th out of 138 small communities).









Winfield has a crude rate of 7.6% for current lack of health insurance among adults aged 18–64 years, which ranks 570th out of 958 lowa communities (92nd out of 138 small communities). The age-adjusted rate for Winfield is 7.9%, which ranks 498th out of 905 lowa communities (89th out of 138 small communities).











The age-adjusted rate for Winfield is 70.4%, which ranks 538th out of 905 Iowa communities (92nd out of 138 small communities).



Winfield has a crude rate of 42.9% for older adult men aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, which ranks 553rd out of 958 lowa communities (90th out of 138 small communities). The age-adjusted rate for Winfield is 43.1%, which ranks 496th out of 905 lowa communities (90th out of 138 small communities).



Core preventive services for older women

Winfield has a crude rate of 33.9% for older adult women aged >=65 years who are up to date on a core set of clinical preventive services: flu shot past year, ppv shot ever, colorectal cancer screening, and mammogram past 2 years, which ranks 890th out of 958 lowa communities (131st out of 138 small communities). The age-adjusted rate for Winfield is 37.8%, which ranks 693rd out of 905 lowa communities (121st out of 138 small communities).



The age-adjusted rate for Winfield is 64.7\%, which ranks 638th out of 905 lowa communities (105th out of 138 small communities).



Winfield has a crude rate of 75.0% for mammography use among women aged 50–74 years, which ranks 684th out of 958 lowa communities (96th out of 138 small communities). The age-adjusted rate for Winfield is 71.6%, which ranks 782nd out of 905 lowa communities (124th out of 138 small communities).



Winfield has a crude rate of 7.9% for hearing disability among adults aged >=18 years, which ranks 620th out of 958 lowa communities (73rd out of 138 small communities). The age-adjusted rate for Winfield is 6.1%, which ranks 544th out of 905 lowa communities (97th out of 138 small communities).











This report uses a novel dataset from the Centers for Disease Control and Prevention (CDC) called PLACES: Local Data for Better Health. The PLACES dataset uses small area estimation methods to provide estimates of health measures for counties, places, census tracts, and zip code tabulation areas. The estimates are created with a multilevel statistical modeling framework that utilizes CDC's Behavioral Risk Factor Surveillance System (BRFSS), Census population counts, and American Community Survey demographic and socioeconomic data.
